
WHEREFORE, Defendants request that the said Complaint be stricken for failure to conform as set forth above.



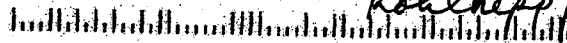

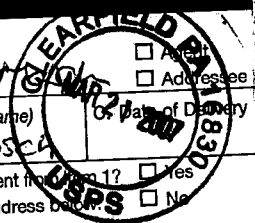
