2. The Petitioner is the natural mother of Bobbi Sue Corcelle, a minor child, who was born on November 5, 1996 and is ten (10) years of age. The minor child resides with Petitioner at 152 Hemlock Road, DuBois, Pennsylvania.

3. The natural father of said minor child is John M. Corcelle Jr., who currently resides at Old Pike Road, Philipsburg, Pennsylvania.

4. The natural father, John M. Corcelle Jr., has not seen said minor child since 1998. The Petitioner would request that Bobbi Sue Corcelle's surname to be the same as her natural mother.


5. Since mother's last surname is "Gray," Petitioner desires that the legal surname of the
