PETITION FOR FORFEITURE AND CONDEMNATION

COMES NOW, the Attorney General of the Commonwealth of Pennsylvania, Thomas W. Corbett, Jr., by and through Stevan Kip Portman Deputy Attorney General, pursuant to and under authority of the provisions of the Judicial Code, Chapter 68, Controlled Substances Forfeitures Act, 42 Pa. C.S.A. 6801 et seq. (hereinafter referred to as "Act") and petitions this Honorable Court setting forth a right of possession in and requesting an Order of Forfeiture for a 1999 Freightliner Class, VIN: 1FUYSDB3XLF38321, and in support thereof avers as follows:

1. Your Affiant is Trooper Dennis M. Regal of the Pennsylvania State Police.

2. The Commonwealth seized the defendant/property, 1999 Freightliner Class, VIN: 1FUYSDB3XLF38321 (Property or tractor), pursuant to the Act.

3. The Commonwealth seized the Property at or about 5:15 p.m., on or about Wednesday, October 18, 2006.

4. The Commonwealth seized the Property at Interstate 80 eastbound at milepost #122, Bradford Township, Clearfield County, Pennsylvania.

5a. The titled owner of the Property, based upon all information currently available, is Leticia Leal, 5958 Ruby Red Lane, Brownsville, Texas.

5b. The titled owner of the Property, based upon all information currently available, is C & L Trucking, 5958 Ruby Red Lane, Brownsville, Texas.

6a. At the time of seizure, on the date and at the place of seizure, hereinbefore mentioned, the Property was in the possession of Arnulfo Perez Uresti (Uresti), 2548 Autumn Sage Drive, Brownsville, Texas.

6b. At the time of seizure, on the date and at the place of seizure, hereinbefore mentioned, the Property was in the possession of Hugo Francisco Leal-Flores (Leal-Flores), Aquiles Serdan 80-2, H. Matamoros, Mexico.

7. The Property is subject to forfeiture and condemnation and no legal right, title or interest exists in it by any owners or possessors of it pursuant to Section 6801(a) of the Act, 42 Pa. C.S.A. Section 6801, (Relating to loss of property rights to the Commonwealth), based upon the following averment of material facts.

a. On or about Wednesday, October 18, 2006, Pennsylvania State Police Trooper Brett R. Hanlon (Trooper Hanlon) initiated a traffic stop on the tractor.

b. At all times material hereto, Uresti was the operator of the tractor.

c. At all times material hereto, Leal-Flores was the sole passenger in the tractor.

d. At all times material hereto, Uresti consented to a search of the tractor.

e. At all times material hereto, a hidden compartment was located within the passenger compartment of the tractor.

f. At all times material hereto, cocaine was located within the hidden compartment.

g. At all times material hereto, because of a further search of the tractor by members of the Pennsylvania State Police (PSP), the PSP seized twenty-eight (28) kilos of cocaine: twenty-six (26) kilos were located under the lower bunk in a well-constructed black metal box and two (2) kilos were located inside a speaker.

h. The packages of cocaine weighed from 2.4 to 2.6 pounds each.

i. At all times material hereto, Leal-Flores was the brother of an owner of C & L Trucking.

j Uresti told a member of the Pennsylvania State Police, among other information, substantially the following:

- (i) He has made approximately 100 trips for C & L Trucking.
- (ii) Leal-Flores has accompanied him on approximately four of the 100 trips.
- (iii) Leal-Flores is a brother of one of the owners.
- (iv) Leal-Flores does not have a commercial driver's license.
- (v) He and Leal-Flores departed Brownsville, Texas on Sunday, October 15, 2006 at 6:00 a.m.
- (vi) He and Leal-Flores drove from Brownsville, Texas to Houston, Texas, where they remained for 10 hours.



- (vii) He and Leal-Flores drove from Houston, Texas to Matthews, Missouri, where they spent the night.
- (viii) He and Leal-Flores traveled from Matthews, Missouri to Chicago, Illinois, where he delivered a load of steel and they spent the rest of the day.
- (ix) On Wednesday morning, October 18, 2006, he and Leal-Flores left from Chicago, Illinois to drive to Newark, New Jersey, where they were to deliver the load on the trailer, two steel coils.
- (x) He and Leal-Flores where to pick up two steel coils in New Jersey and return with them to Texas.

k Leal-Flores told a member of the Pennsylvania State Police, among other information, substantially the following:

- (i) His brother owns C & L Trucking.
- (ii) A person known to him as Chino contacted him to transport cocaine to New Jersey.
- (iii) He knows Chino to be a credible, violent drug dealer.
- (iv) He gave Chino a key to the tractor.
- (v) Chino told him he loaded cocaine into a speaker area of the sleeper compartment of the tractor and some on the floor.
- (vi) His brother (an owner of the tractor) gave him a cellular telephone with a "walkie talkie" function, which he was to use to communicate with Chino.
- (vii) He and Uresti were to arrive in New Jersey on October 18, 2006, between 6 p.m. and 8 p.m. and look for an "Indian owned" motel.
- (viii) Chino would contact him on the aforementioned cellular telephone on October 19, 2006.

- (ix) Prior to leaving Texas, Chino told him that while he and Uresti were at the motel in New Jersey, a man would take them to eat and he was to give a key to the tractor to another man.
- (x) Chino told him the second man would unload the cocaine while Uresti, he and the first man were eating.

8. The Property is a conveyance, which was used, or intended for use, to transport, or in any manner to facilitate the transportation, sale, receipt, possession or concealment of drug paraphernalia, controlled substances, or other drugs which have been manufactured, distributed, dispensed or acquired in violation of the Controlled Substance, Drug, Device and Cosmetic Act.

WHEREFORE, the Commonwealth through the Attorney General prays this Honorable Court to issue an Order that the Property be condemned and adjudged forfeited to the Commonwealth and that all right, title or interest in the Property, except that vested in the Office of Attorney General, Commonwealth of Pennsylvania, be declared null and void and that the property be used or disposed of in accordance with law.
