WHEREFORE, Defendant respectfully requests that Plaintiff's Complaint against him be dismissed, with prejudice and costs of suit.

NEW MATTER

10. The averments at paragraphs 1 through 9 of this Answer with New Matter are incorporated herein by reference as though set forth in full.

11. Defendant hereby raises and asserts all those defenses and/or limitations on damages available by reason of the terms and provisions of the Pennsylvania Motor Vehicle Financial Responsibility Law, as amended.

12. To the extent Plaintiff's medical expenses, if any, have been paid or are payable under a policy of insurance, the same may not be plead, proven or recovered in the instant action.


13. To the extent Plaintiff was insured under a policy of insurance carrying the limited tort option, Plaintiff's claims may be barred or reduced accordingly.

**DEFENDANT JEFFREY HAHN'S MOTION TO COMPEL PLAINTIFFS' RESPONSES
TO DEFENDANT'S REQUEST FOR PRODUCTION OF DOCUMENTS (SET THREE)**

AND NOW, comes Defendant, Jeffrey Hahn, by and through his attorneys, McQuaide, Blasko, Fleming & Faulkner, Inc., to respectfully move this Honorable Court pursuant to Pa.R.C.P. 4019 to issue an appropriate Order compelling Plaintiffs to fully and completely answer Defendant's Request for Production of Documents (Set Three). In support thereof, Defendant avers the following:

Pleadings

1. Plaintiffs commenced this personal injury action by Complaint filed on February 15, 2007 and reinstated on June 7, 2007.
2. Defendant Jeffery K. Hahn filed an Answer with New Matter to Plaintiff's Complaint on June 28, 2007.

Nature of Claims

3. Plaintiffs seek damages for alleged injuries to minor Plaintiff Cheyanne Hahn from a motor vehicle accident that occurred on December 26, 2005 on S.R. 322 in Rush Township, Centre County, Pennsylvania. Cheyanne Hahn was a passenger in a vehicle driven by her father, Defendant Jeffrey Hahn, at the time of the accident.

4. During the course of discovery, it has become apparent that the main thrust of Plaintiffs' injury claim is a claim that minor Plaintiff Cheyanne Hahn ("Minor Plaintiff") suffered a traumatic brain injury in the accident that has resulted in significant cognitive and emotional impairments and associated self-destructive behaviors, including self-mutilation.

5. Plaintiffs have, at this point, produced two reports from Wayne R. D'Agaro, Psy.D., in support of their claims and purportedly substantiating the cognitive, emotional, and serious behavioral problems that Plaintiffs claim are related to the accident.¹

6. Information available to date also reflects that any cognitive, emotional, and behavioral problems Minor Plaintiff is experiencing might well be the result of various documented factors and circumstances completely unrelated to the vehicle accident giving rise to this lawsuit.

7. In that regard, records of psychiatric/psychological counseling sessions from Cen Clear Child Services document numerous social issues, unrelated to the vehicle accident, which may be critically important in ascertaining the cause of the Minor Plaintiff's alleged cognitive, emotional, and behavioral problems. These records also reflect that the Minor Plaintiff has

maintained a computer journal, and possibly other journals, pertaining to her emotional and behavioral problems.

Discovery Dispute

8. On or about March 7, 2008, Defendant served a request for production of documents on Plaintiffs requesting production of all documents created within the past 10 years pertaining to the Minor Plaintiff's mental or emotional state. The request specifically included copies of journals, diaries, and electronic postings. (A true and correct copy of Defendant's Request for Production of Documents (Set Three) is attached hereto as Exhibit "A").

9. By letter dated March 18, 2008, Plaintiffs' attorney stated that Plaintiffs objected to Defendant's request for production of documents pertaining to the Minor Plaintiff's mental/emotional state, and further indicated that the Minor Plaintiff did not have any such information. (See Exhibit "B" hereto). Plaintiffs did not provide a signed, verified response to Defendant's request for production as required by Pa.R.C.P. 4009.12(c).

10. In light of the aforementioned correspondence, defense counsel wrote to Plaintiffs' attorney on April 29, 2008, seeking a stipulation that Plaintiffs were not making a claim for emotional/psychological damage based on the vehicle accident, or, alternatively, requesting a verified response to Defendant's Third Request for Production of Documents. (See Exhibit "C" hereto).

11. A stipulation in this regard was never reached, and Plaintiffs' attorney has remained insistent that Plaintiffs would "stand by" their objections as stated in the March 18, 2008 letter.

12. The documents requested by Defendant are highly relevant in light of the Minor Plaintiff's claim that she suffered a brain injury with resulting serious cognitive, emotional, and

behavioral problems, and this discovery is essential for proper investigation of Plaintiffs' claims, including an investigation into the cause of any emotional and behavioral problems, as well as for ultimate trial preparation.

13. Defendant is clearly entitled to the information sought, and the information is critical to permit Defendant a meaningful opportunity to investigate and prepare a defense in this case.

14. Plaintiffs' refusal to completely and fully respond to Defendant's Third Request for Production of Documents has been to the extreme prejudice of Defendant, and has virtually forestalled Defendant's discovery efforts in that Defendant has been unable to secure pertinent documents needed in advance of depositions of Plaintiffs and for defense expert review, including an independent neuropsychological examination.

WHEREFORE, Defendant, Jeffrey K. Hahn, respectfully requests that an Order be issued compelling Plaintiffs to fully and completely answer Defendant's Request for Production of Documents (Set Three), and to produce all documents responsive thereto, within 20 days or suffer appropriate sanctions.







**DEFENDANT JEFFREY HAHN'S MOTION TO COMPEL MEDICAL AND
PSYCHOLOGICAL EXAMINATIONS**

AND NOW, comes Defendant, Jeffrey Hahn, by and through his attorneys, McQuaide, Blasko, Fleming & Faulkner, Inc., to respectfully move this Honorable Court pursuant to Pa.R.C.P. 4010 to issue an Order compelling Plaintiffs to produce minor Plaintiff Cheyanne Hahn for medical and psychological examinations. In support thereof, Defendant avers the following:

1. This action sounds in motor vehicle negligence, and arises from a single vehicle accident that occurred on December 26, 2005 on S.R. 322 in Rush Township, Centre County, Pennsylvania. Minor Plaintiff Cheyanne Hahn (currently 16 years old) was a passenger in a vehicle driven by her father, Defendant Jeffrey Hahn, at the time of the accident.

2. Plaintiff Lorraine Hahn brings this action as mother and natural guardian of the minor Plaintiff, Cheyanne Hahn. Plaintiff Lorraine L. Hahn and Defendant Jeffrey K. Hahn are divorced, and Cheyanne Hahn resides with her mother.

3. In this action, Plaintiffs seek damages for injuries allegedly sustained by Cheyanne Hahn as a result of the December 26, 2005 accident. *Inter alia*, Plaintiffs claim that Cheyanne suffered a traumatic brain injury allegedly resulting in on-going cognitive and emotional-behavioral problems, including learning deficits, depression, and self-mutilation behavior.

4. The parties have exchanged written discovery, and Defendant has subpoenaed medical and psychological records for Cheyanne Hahn.

5. Defendant Jeffrey Hahn's deposition was taken on October 6, 2008. Depositions of Cheyanne and Lorraine Hahn are scheduled for December 10, 2008, and the depositions of the investigating officer and of an eye witness to the accident will occur on December 12, 2008.

6. Medical records exchanged in discovery reflect that that the Minor Plaintiff, Cheyanne Hahn, was admitted for emergency care at Altoona Hospital after the accident, and that she was released on December 29, 2005 in stable condition after being evaluated and monitored over the course of a four-day admission. A CT scan taken at Altoona Hospital showed a small right temporal contusion.

7. At a follow-up visit with a neurosurgeon, Dr. James Burke, approximately three weeks after the accident, the right temporal contusion was noted to be resolved, and there were no documented complaints. Other records from this same timeframe likewise indicate that Cheyanne was doing well.

8. Approximately one year later, on January 5, 2007, records show another visit to Dr. Burke, and that Cheyanne was complaining at that point of severe headaches and dizziness, and that her mother (Plaintiff Lorraine Hahn) reported that Cheyanne was having short term memory problems. These complaints lead to a referral to Dr. Clark, a neurologist at Blair

Medical Associates, and ultimately to neuropsychological evaluations performed by Wayne D'Agaro, Psy.D.

9. Records produced during written discovery included two reports from Wayne D'Agaro, Psy.D, setting forth his opinion that the Minor Plaintiff suffers from cognitive and emotional-behavioral deficits as a result of the accident, and setting forth various diagnoses. True and correct copies of Dr. D'Agaro's reports are attached hereto as Exhibit "A."

10. Dr. D'Agaro reached these conclusions after conducting interviews of Cheyanne Hahn and her mother, Lorraine Hahn, on March 16, 2007 and April 10, 2008, and performing and interpreting a series of neuropsychological tests.

11. On or about July 10, 2008, Plaintiff also produced a report from Dr. Joseph Clark at Blair Medical Associates stating an opinion that Cheyanne Hahn has post concussive syndrome as a result of the accident, and that all of her symptoms, including the "depressive-type" symptoms as noted by Dr. D'Agaro, relate back to the accident. A true and correct copy of Dr. Clark's June 28, 2008 letter to Ferraraccio & Noble, Attorneys at Law, is attached hereto as Exhibit "B."

12. Defendant has also obtained limited counseling records pertaining to Cheyanne Hahn from Cen-Clear Child Services during the discovery process. These records document various social issues and circumstances completely unrelated to the vehicle accident giving rise to this lawsuit that might play a causal role in the cognitive, emotional, and behavioral problems that Plaintiffs contend are a result of injuries from the accident. None of these issues were addressed by either Dr. D'Agaro or Dr. Clarke in their records or reports.

13. One of the most significant damages issues in this case involves whether the cognitive and emotional problems Cheyanne Hahn allegedly experiences, and the resulting

behaviors such as self-mutilation, are the result of an injury Cheyanne sustained in the December 26, 2005 vehicle accident.

14. To further investigate this issue and to proceed with defense trial preparation, Defendant requested that Plaintiffs produce Cheyanne Hahn for a medical examination with a neurologist, Dr. Richard Kasdan, and for a psychological examination with Dr. James Petrick, a licensed psychologist. Attached hereto as Exhibits "C" and "C-1" are curriculum vitae for Drs. Kasdan and Petrick.

15. Drs. Kasdan and Petrick both have offices in the Pittsburgh area.¹

16. Defendant has agreed to cooperate with Plaintiffs in the scheduling of these examinations so as to cause as minimal disruption as possible to Cheyanne Hahn's school and activity schedule. Defendant is also willing to reimburse Plaintiffs for mileage for the examinations based on the current federal rate for travel for medical purposes.²

17. Plaintiffs have refused to produce Cheyanne Hahn for medical or psychological evaluations. Plaintiffs initially based opposition to an independent medical examination on their attorney's opinion that an IME is unnecessary (see correspondence of Attorney Noble dated August 11, 2008, attached hereto as Exhibit "D"). More recently, Plaintiffs objected to an IME because of the "extensive treatment and documents previously provided," and the length of travel involved in attending the examinations requested. (See Attorney Noble correspondence dated November 20, 2008, attached hereto as Exhibit "E").

¹ Dr. Kasdan has office locations in the Pittsburgh area at Shadyside, South Hills, and Monroeville. Dr. Petrick's office is located in Mount Lebanon, Pennsylvania.

² Because Plaintiffs have stated an outright refusal to produce Cheyanne Hahn for independent medical examinations as noted in paragraph 17 of the within Motion, there has been no opportunity to discuss any details pertaining to the same for purposes of reaching an agreement.

18. If Plaintiff Cheyanne Hahn is not required to attend and cooperate in medical and psychological examinations as requested, Defendant will effectively be forced to accept the findings and conclusions of the doctors that Plaintiffs intend to call in support of the claims in this lawsuit, and Defendant will be virtually foreclosed from independently conducting a meaningful and competent investigation of the claims that Cheyanne Hahn suffered a substantial traumatic brain injury in the accident resulting in on-going physical and psychological problems.

19. Pursuant to Pennsylvania Rule of Civil Procedure 4010, physical and psychological examinations of a party may be ordered upon a showing of good cause. See Pa.R.C.P. 4010.


20. Courts interpreting Rule 4010 have recognized that examinations under Rule 4010 should “practically always be an available remedy where appropriate, and orders thereunder should normally be entered without crippling or restrictive conditions.” See e.g., Klusko v. Gaines-Murfit Chevrolet, Inc., 16 Pa D&C2d 86, 87-88 (Bucks Co. 1958).

21. The medical and psychological examinations sought by Defendant are critical to Defendant’s ability to complete discovery pertaining to the primary damages issues in this case, and to move forward with identification of experts and trial preparation. Unless and until Cheyanne Hahn is produced for these examinations, Defendant will be extremely prejudiced, and will be virtually forestalled in further discovery efforts and trial preparation.

WHEREFORE, Defendant, Jeffrey K. Hahn, respectfully requests that an Order be issued compelling Plaintiffs to produce minor Plaintiff Cheyanne Hahn for medical and psychological examinations by Drs. Kasdan and Petrick within 90 days, and to cooperate with the scheduling of such examinations.



Per your request for neuropsychological consultation, I completed a clinical interview with Cheyanne Hahn and her mother, Ms. Lorraine Hahn, on March 16, 2007 and followed up with the following procedures that same date: Luria-Nebraska Neuropsychological Battery, Children's Version (LNNB-C), Visual and Motor Scale items; Speech Sounds Perception Test (SSPT); Seashore Rhythm Test (SRT); Trail Making Test (TMT); Neurobehavioral Cognitive Status Examination, Auditory Comprehension and Oral Repetition subtests; Boston Naming Test (BNT); Controlled Oral Word Association Test (COWAT); Rey Auditory-Verbal Learning Test (RAVLT); Children's Memory Scale (CMS), Stories and Family Picture subtests; Rey-Osterrieth Complex Figure Test (ROCFT); Wechsler Intelligence Scale For Children - IV (WISC-IV), Coding, Symbol Search, Digit Span, Letter-Number Sequencing, Vocabulary, Similarities, Comprehension, Picture Concepts, Matrix Reasoning, and Block Design subtests; Wide Range Achievement Test - 3 (WRAT-3); Children's Category Test (CCT); Beck Youth Inventories (BYI).

The purpose of this evaluation was to delineate Cheyanne's cognitive and behavioral strengths and weaknesses, functional implications of the same, and recommendations for treatment (including academic interventions) secondary to a closed head injury.

BACKGROUND INFORMATION:

Cheyanne is a 14-year-old, right-hand dominant female who sustained a traumatic brain injury on December 26, 2005 when the automobile that she was a passenger in was involved in a partial rollover accident. She was not wearing a seatbelt at the time. Cheyanne was evaluated at the Altoona campus of Altoona Regional Health System where a CT-scan revealed evidence of a "small right temporal contusion". She remained hospitalized for three to four days before being discharged with no

recommendation for follow-up rehabilitation.

Cheyanne's medical history was otherwise unremarkable and free of any other neurological disorders or symptoms, including prior blows to the head. There no psychiatric or substance abuse histories.

Cheyanne was an 8th grade student in the West Branch Area School District at the time of her accident. She had no grade repetitions or special education involvement. She is currently a 9th grade student in the same school district. Cheyanne continues to report headaches that were not present prior to her December of 2005 accident, as well as periodic dizziness. Cognitively, she has experienced "confusion" as she has gone from her home to a friend's home, and vice versa, but has never gotten so disoriented or lost to the degree that she was unable to reach her destination. Cheyanne will also forget conversations that she has had with others, will experience easy distractibility while in classroom settings, has had difficulty completing class examinations, and doesn't always write coherent or complete class notes. Her academic averages the first and second nine-week marking period were 88.2% both times. Emotionally, Cheyanne also noted increased "moodiness" and "depression", and was recently prescribed an unknown antidepressant. Within this same context, Cheyanne stated that she has engaged in subtle self-mutilation (cutting) and has had suicidal thoughts without any intentions or plans of acting on these ideations.

Cheyanne and her parents are divorced. She reported having a "good, normal" relationship with her mother, with whom she resides, but acknowledged having difficulty "getting along" with her father, who is undependable and prone to break promises and "change his mind". In discussing her future, Cheyanne stated that she plans on attending college following high school. She is currently interested in possibly studying Criminal Justice.

BEHAVIORAL OBSERVATIONS:

Cheyanne was on time for her evaluation session, accompanied by her mother who was responsible for his transportation. She was appropriately dressed for the weather and neatly groomed, alert and oriented in all spheres, and fully cooperative with the evaluation process. Although initially only responsive to my questions, as the evaluation progressed and she became more relaxed, Cheyanne became more spontaneous. Her affect was generally stable, except for a brief period when she began to tear up while discussing her depression and mood swings. Her affect also reflected at least a mild decrease in range and intensity that would be consistent with a depressive process. There was no evidence of gross distraction during the evaluation. Cheyanne also demonstrated no lower or upper extremities and was capable of

completing manual-dependent tasks. Her vision and hearing were within functional limits. Her speech was articulate and characterized by a normal amplitude and a constant rate of speed.

TEST RESULTS:

Age, gender, and/or education corrected normative values were used to compare Cheyanne's test performance against estimated premorbid abilities. Her test scores are summarized in the attached addendum.

Sensory-Perceptual, Spatial-Constructional and Motor Functions. Cheyanne demonstrated no apparent visual or auditory limitations when presented with stimuli requiring primary sensory-perceptual processing and secondary sensory-perceptual integration.

Simple and more complex visuoperceptual and visuospatial organization, conceptualization, and reasoning were appropriate. Cheyanne's constructional abilities were borderline compromised for an object assembly tasks but within expected limits for a graphomotor task.

Cheyanne's manual strength was within expected limits as were her results on screening measures designed to assess unimanual sequencing and bimanual coordination, motor planning and execution (praxis), and the ability to regulate simple motor actions in response to equally simple oral commands.

Attention, Concentration and Mental Tracking. Cheyanne experienced mild difficulty when required to attend to, register and immediately recall auditory stimuli. She had an equal degree of difficulty with both the passive storing and the active processing of this information. Cheyanne also demonstrated borderline difficulty on a more sustained measure of auditory attention that involved verbal stimuli. On a similar measure of auditory attention that required more rapid processing of nonverbal stimuli, Cheyanne had a mild to moderate degree of difficulty.

Cheyanne's psychomotor processing speed was within expected limits. So too was her basic visuomotor attention, scanning and sequencing. On a similar visuomotor measure that required her to mentally shift and alternate attention between equally demanding cognitive tasks, Cheyanne had borderline difficulty; she needed to work at a slower rate to avoid making an error (as she did when presented with a sample trial immediately prior to the actual administration of this task).

New Learning and Memory. Cheyanne's ability to encode, retain and retrieve

auditory-verbal information was below expectations. On an unstructured, 15-item word list presented five consecutive times, Cheyanne demonstrated a positive but slow-to-develop learning curve that reflected an overall learning efficiency that was borderline compromised. Her recalls for this same word list immediately following both the presentation of an interference task (another but similar 15-item word list), and a delay of approximately 25 to 35 minutes, were mildly impaired. On a more structured, prose task involving the presentation of paragraph-length material, Cheyanne's initial learning was mildly impaired but her 25 to 35 minute delayed recall was within expected limits.

Cheyanne's ability to encode, retain and retrieve visual-nonverbal information was also below expectations. On a "concrete" task involving the presentation of four separate pictures of individuals engaged in various activities, each picture exposed for only 10 seconds, Cheyanne's initial learning was borderline compromised. Her delayed free recall for these same pictures 25 to 35 minutes following their initial presentation was equally compromised. Cheyanne had more difficulty on a more "abstract" task that first required the pencil-and-paper reproduction of a complex, two-dimensional pattern with the stimulus figure present and then immediately following the removal of her drawing and this stimulus figure. Moderate to severe difficulty was evident during both the immediate recall phase and following a delay of 25 to 35 minutes.

Language and Communication. Cheyanne's auditory comprehension of simple and complex language, oral repetition, and expressive vocabulary level were within expected limits. Despite this, her confrontation naming for pictorial representations of objects was borderline impaired, with more mild impairment noted on a measure of phonemic (e.g., word) verbal fluency.

Conceptual Reasoning and Executive Abilities. Cheyanne's verbal abstract reasoning was within expected limits as was her nonverbal abstract reasoning, conceptual formation and cognitive flexibility. Cheyanne also demonstrated good social judgment and reasoning.

General Intelligence and Academic Skills. Cheyanne's estimated auditory-verbal and visual-nonverbal intellectual abilities clearly fell within the Average classification range, with a slightly significant (.15), 8-point difference, in favor of the former. Measures of academic achievement that assessed Cheyanne's word recognition and word attack skills, spelling, and written arithmetic (without the use of a calculator) were below expectations and approximated a functional level equivalent to that of the average 5th to 6th grade student. These findings were also inconsistent with her grades during her current academic year. When permitted the use of a calculator to complete the same mathematical operations, Cheyanne's score significantly improved,

minimally consistent with her current academic standing.

Emotional and Behavioral Status. Cheyanne's result on a screening measure of depression and anxiety, minimally revealed a mild degree of both depression and anxiety.

CLINICAL IMPRESSIONS:

The results of this evaluation revealed a number of problem areas, both cognitive and emotional-behavioral. These would primarily include borderline to mild difficulty with visual confrontation naming and phonemic verbal fluency, attention and information processing, and new learning and memory. Her reading, spelling and arithmetic results on a screening measure of academic achievement were also lower than expected but inconsistent with her grades the first and second nine weeks of her freshman year. Emotionally, Cheyanne is also experiencing a moderate degree of depression and anxiety, as well as cutting behavior. These collective problems, in my professional opinion, were not present prior to Cheyanne's closed head injury.

DIAGNOSIS:

Per the Fourth Edition of the Diagnostic and Statistical Manual of Mental Disorders and the Ninth Edition of the International Classification of Diseases (ICD-9), the following diagnoses are appropriate at this time:

- Axis I = Cognitive Disorder Not Otherwise Specified (294.9), secondary to Axis III; Major Depressive Disorder, Single Episode, Moderate (296.22); Anxiety Disorder Not Otherwise Specified (300.00).
- Axis II = No Diagnosis (V71.09) at this time.
- Axis III = Mild Traumatic Brain Injury (850.9), sustained 12/26/05.

RECOMMENDATIONS:

1. Cheyanne needs to continue with all medical interventions prescribed by those physicians who remain involved in her care. This would specifically include the continued use of her recently prescribed antidepressant medication or other psychotropic medication regime to ensure emotional and behavioral stability. I also question if a psychostimulant medication may be appropriate on a trial basis to assess its effectiveness, if any, on Cheyanne's attentional matrix.
2. I would strongly recommend, especially given her cutting behavior and suicidal ideation, that Cheyanne also involve herself in individual counseling.

3. Within school, Cheyanne should have the opportunity to take class examinations in quieter settings, should be permitted extra time to complete such examinations, should be provided with lecture notes or study outlines to ensure that the material that she is studying is appropriate and complete. Cheyanne should also be permitted the use of a calculator to complete mathematical calculations.
4. A copy of this report is being provided to Cheyanne's mother so that she may share it with school personnel, who ultimately have the responsibility for improving the academic accommodations recommended above. They may also wish to complete more comprehensive academic testing to determine if the results that I obtained are truly an accurate representation of her current standing.
5. Given that she is still within the 24-month recovery period expected for traumatic brain injury, Cheyanne should be re-evaluated in 6 months to compare results against the baseline neuropsychological data that is now available for this purpose.
6. Some during her junior year of high school, Cheyanne should be referred for an evaluation by the Office of Vocational Rehabilitation, who may be able to assist Cheyanne in obtaining funding for a higher education and, if still necessary, academic accommodations.

I completed a clinical interview with Cheyanne Hahn and her mother, Ms. Lorraine Hahn, on April 10, 2008, and followed up with the administration of the following tests that same day: Luria-Nebraska Neuropsychological Battery, Children's Version (LNNB-C), Visual and Motor Scale items; Speech Sounds Perception Test (SSPT); Seashore Rhythm Test (SRT); Trail Making Test (TMT); Neurobehavioral Cognitive Status Examination, Auditory Comprehension and Oral Repetition subtests; Boston Naming Test (BNT); Controlled Oral Word Association Test (COWAT); Rey Auditory-Verbal Learning Test (RAVLT); Wechsler Memory Scale - III (WMS-III), Logical Memory and Family Picture subtests; Rey-Osterrieth Complex Figure Test (ROCFT); Wechsler Intelligence Scale For Children - IV (WISC-IV), Coding, Symbol Search, Digit Span, Letter-Number Sequencing, Vocabulary, Similarities, Comprehension, Picture Concepts, Matrix Reasoning, and Block Design subtests; Wide Range Achievement Test - 3 (WRAT-3), Reading, Spelling and Arithmetic subtests; Children's Category Test (CCT); Brown Attention Deficits Disorder Scale (BADDs).

The purpose of this evaluation was to compare Cheyanne's current cognitive and behavioral status against baseline data that was obtained when I first assessed her on March 16, 2007.

BACKGROUND INFORMATION: Cheyanne is a now 15-year-old, right-hand dominant female who sustained a traumatic brain injury on December 26, 2005 when the automobile that she was a passenger in was involved in a partial rollover accident. Additional information regarding that accident and the treatment that she received can be found in the initial neuropsychological evaluation, dated March 30, 2007.

At the time of her injury, Cheyanne was an 8th grade student in the West Branch Area School District. She is now a 10th grade student in that same school district.

Since my last contact with her, Cheyanne reported a full resolution of the headaches and periodic dizziness that were not present prior to her December of 2005 accident. Cognitively, however, she continues to experience "confusion" that prevents her from following class/subject directions in general and mathematics specifically. She equally remains easily distracted in class, especially large classes (currently biology and algebra) where others are talking, tapping or dropping pencils, and so on. She also experiences anxiety during class examinations, "pressured" to not be the last one to complete testing. Her academic averages the first and second nine-week marking period were 87% and 85.6%, respectively. Cheyanne also remains "moody" but denied depression and more specific self-mutilation (cutting) and suicidal thoughts.

Cheyanne is currently taking Citalopram (40mg per day) for depression and initiated individual counseling approximately one month ago at Cen-Clear Child Services, Inc. Such counseling takes place every two weeks. From a more cognitive perspective, Cheyanne was recently prescribed the Exelon Patch (4.6mg per 24 hours). She was previously prescribed Aricept (5mg per day) but this was discontinued secondary to sleep disturbance. Since my last contact with Cheyanne, she was involved in a dirt bike accident the Fall of 2007 but denied hitting her head; she also denied any additional blows to the head since December of 2005, seizure activity or other neurological issues. She denied any substance abuse.

Cheyanne continues to reside with her mother, with whom she reported a "normal" teenager-mother relationship. As before, she acknowledged ongoing difficulty "getting along" with her father, who is undependable, prone to break promises, and "uncaring" secondary to believing that "nothing is wrong" with her. In discussing her future, Cheyanne stated that she would like to become a paramedic following high school so that she can "help people".

BEHAVIORAL OBSERVATIONS: Cheyanne was on time for her evaluation session, accompanied by her mother who was responsible for her transportation. She was appropriately dressed for the weather and neatly groomed, alert and oriented in all spheres, and fully cooperative with the evaluation process. Cheyanne fully cooperated with the evaluation process by responding to questions and engaging in spontaneous conversation, and putting forth her best effort on the testing that was presented. Her affect was stable. Compared to my last contact with her when she began to tear up while discussing her mood swings, Cheyanne demonstrated no lability. Cheyanne remained capable of completing manual-dependent tasks. Her vision, hearing and speech were functionally intact.

TEST RESULTS: Age, gender, and/or education corrected normative values were used to compare Cheyanne's test performance against estimated premorbid abilities. Her test scores are summarized in the attached addendum.

Sensory-Perceptual, Spatial-Constructional and Motor Functions

Cheyanne demonstrated no apparent visual or auditory limitations when presented with stimuli requiring primary sensory-perceptual processing and secondary sensory-perceptual integration.

Simple and more complex visuoperceptual and visuospatial organization, conceptualization, and reasoning were appropriate. Cheyanne's constructional ability for an object assembly task remained borderline compromised but was within expected limits for a graphomotor task.

Cheyanne's manual strength was within expected limits as were her results on screening measures designed to assess unimanual sequencing and bimanual coordination, motor planning and execution (praxis), and the ability to regulate simple motor actions in response to equally simple oral commands.

Attention, Concentration and Mental Tracking

Cheyanne experienced borderline to mild difficulty when required to attend to, register and immediately recall auditory stimuli, demonstrating an equal degree of difficulty with both the passive storing and the active processing of this information. Cheyanne did well on a sustained measure of auditory attention that involved verbal stimuli but, consistent with her initial evaluation, still had mild to moderate difficulty on a similar measure of auditory attention that required more rapid processing of nonverbal stimuli.

Cheyanne's psychomotor processing speed was within expected limits. So too was her basic visuomotor attention, scanning and sequencing. On a similar visuomotor measure that required her to mentally shift and alternate attention between equally demanding cognitive tasks, Cheyanne had borderline difficulty; she produced no errors but her response speed was below normative expectations.

New Learning and Memory

Cheyanne's ability to encode, retain and retrieve auditory-verbal information was within expected limits except for mild difficulty on the initial trial of an unstructured, 15-item word list presented five consecutive times. Her overall learning efficiency and recalls this same word list immediately following both an interference task (another but

similar 15-item word list), and a delay of approximately 25 to 35 minutes, were within expected limits. Cheyanne did equally well on a structured, prose task involving the presentation of paragraph-length material.

Cheyanne's ability to encode, retain and retrieve visual-nonverbal information was also better and grossly within expected limits.

Language and Communication

Cheyanne's auditory comprehension, oral repetition, and expressive vocabulary level were within expected limits. Her confrontation naming for pictorial representations of objects, however, remained borderline impaired, with mild impairment noted on a measure of phonemic (e.g., word) verbal fluency.

Conceptual Reasoning and Executive Abilities

Cheyanne's verbal abstract reasoning was within expected limits as was her nonverbal abstract reasoning, conceptual formation and cognitive flexibility. Cheyanne also demonstrated good social judgment and reasoning.

General Intelligence and Academic Skills

Cheyanne's estimated auditory-verbal and visual-nonverbal intellectual abilities fell within the central limits of the Average to the lowest limit of the High Average classification ranges, with a 16-point difference, in favor of the former.

Measures of academic achievement that assessed Cheyanne's word recognition and word attack skills, spelling, and written arithmetic (without the use of a calculator) were below expectations and approximated a functional level equivalent to that of the average 7th to 8th grade student. When permitted the use of a calculator to complete the same mathematical operations, Cheyanne's score significantly improved, consistent with her current academic standing.

Emotional and Behavioral Status

Cheyanne's results on a screening measure of attention deficit disorder symptomology inferred the presence of attention and memory problems.

CLINICAL IMPRESSIONS: The results of this evaluation revealed improvement in Cheyanne's ability to learn and retain new information, although her auditory attention and information processing, and visual confrontation naming and phonemic verbal

fluency, remain impaired. Intellectually, Cheyanne's auditory-verbal and visual-nonverbal intellectual abilities are consistent with her estimated premorbid ability level. Her reading, spelling and arithmetic results on a screening measure of academic achievement were also lower than expected but inconsistent with her grades the first and second nine weeks of her sophomore year. From an emotional-behavioral perspective, Cheyanne is experiencing no depression, anxiety or cutting behavior.

These collective problems, from the information that I had available, were not evident prior to Cheyanne's traumatic brain injury.

DIAGNOSIS: Per the Fourth Edition of the Diagnostic and Statistical Manual of Mental Disorders and the Ninth Edition of the International Classification of Diseases, the following diagnoses are justified at this time:

- Axis I = Cognitive Disorder Not Otherwise Specified (294.9), secondary to Axis III; Major Depressive Disorder, Single Episode, Moderate (296.22) + Anxiety Disorder Not Otherwise Specified (300.00), currently in partial to full remission.
- Axis II = No Diagnosis (V71.09) at this time.
- Axis III = Mild Traumatic Brain Injury (850.9), sustained 12/26/05.

RECOMMENDATIONS:

1. Cheyanne needs to continue with all medical interventions prescribed by those physicians who remain involved in her care. This would specifically include the ongoing use of her antidepressant medication to ensure continued emotional and behavioral stability, as well as Exelon to stabilize and improve her cognitive status. I also question if a psychostimulant medication may be appropriate on a trial basis to assess its effectiveness, if any, on Cheyanne's attentional matrix.
2. Cheyanne should remain involved in individual counseling through Cen-Clear Child Services, Inc.
3. Within school, Cheyanne should have the opportunity to take class examinations in a quieter setting to improve her mental focus, should be permitted extra time to complete such examinations, and should be provided with lecture notes or study outlines to ensure that the material that she is studying is appropriate and complete. Cheyanne should also be permitted the use of a calculator to complete mathematical calculations.
4. A copy of this report is being provided to Cheyanne's mother so that she may share



My narrative concerns Ms. Cheyanne Hahn. I saw Ms. Hahn in my Neurology Clinic for the first time January 23, 2007. The patient, at that point, was a 14-year-old right-handed female who was having blackout spells, headaches, memory loss, and dizziness. She was having these spells so they were actually lost time episodes and no loss of consciousness. The patient states she had headaches over her whole head again several times a week. Motrin was helping but she could not take it every day. She also had dizziness with a spinning sensation in her head feeling like she could fall over and this happened several times a week. She also describes short-term memory loss, forgetting things that she was told, forgetting who she had seen in the past. She relates all this back to a motor vehicle accident in 2005 when she struck her head, all of these have been since then. The patient did have a right temporal contusion at the time and was cared for by Dr. Burke; no surgery was required. Therefore, the patient was evaluated in my Clinic for the other symptoms she was having.

I follow her at this time because of her symptomatology that she had, post-concussive syndrome. At that point, I took the liberty of ordering a CT of her head. I did not do an MRI as the patient had braces, and this would cause too much artifact, an EEG and neuropsychological testing, and I treated the patient with Pamelor 10mg at bedtime for the headaches and for the dizziness. The patient had a CT scan of her head completed, which showed an essentially normal study with resolution of the area of hematoma. The patient also had an electroencephalogram done, which was normal.

The patient was seen by Dr. Wayne D'Agaro, a neuropsychologist, for neuropsychological testing. His results showed a diagnosis of cognitive disorder

not otherwise specified secondary to major depressive disorder, anxiety disorder, and traumatic brain injury.

The patient was next seen by me on May 10, 2007. At that point, the findings of the neuropsychological testing were explained to the patient showing there was a great deal of depression causing most of her current symptomatology, although again this all stemmed back to the motor vehicle accident. She was having side effects of the Pamelor that was stopped and Lexapro was added, 10mg by mouth q day.

The patient was seen back next on September 27, 2007. We could not get insurance to pay for the Lexapro so I gave her a trial of Celexa which is a generic family member of Lexapro. The patient was started on 20mg and was feeling sleepy, therefore, she decreased to 10mg.

She was next seen on January 10, 2008. She was tolerating the Celexa at 10mg a day, and her headaches seemed to be better at that point. The patient, at that point, was started on Aricept due to the memory loss.

She was next seen on April 10, 2008. The Aricept was stopped due to the drowsiness. She was having more trouble with school since stopping it, and her Celexa was increased back to 20mg and then 40mg a day. Because the patient has stopped the Aricept, she was started on an Exelon patch.

The patient had a follow up with Dr. D'Agaro on April 10, 2008, and basically, he reiterated the diagnoses as before. Further elaboration should be gleaned from Dr. D'Agaro.

So my final diagnosis of this patient is post-concussive syndrome sustained due to a motor vehicle accident on December 26, 2005. I believe at this point all her symptomatology is related back to that accident to include the depressive-type symptoms.


Please be advised that I do not share your view that an IME is needed. As such, I hereby object to the same.



REPLY TO MOTION TO COMPEL

AND NOW, Lorraine L. Hahn, Mother and Natural Guardian for Cheyanne M. Hahn, Plaintiff, by and through her counsel of record, Theron G. Noble, Esquire, of Ferraraccio & Noble, avers as follows in response to Defendant's MOTION TO COMPEL:

1 - 5. Admitted.

6. Admitted in part, denied in part. As to Defendant's evaluation of the CT Scan, the same is DENIED as being over-simplified, all else is admitted.

7. Denied. Again, Defense has simplified the situation, but at said time, said Doctor had still ordered Cheyanne from not participating in gym class and not riding her bicycle, all indicating factors other than Cheyanne's injuries were "resolved" or no documented complaints. By way of further response, in dealing with traumatic brain injury, as was herein diagnosed, the symptoms often times do not reveal themselves for a period of months, which explains the conservative approach and orders by Dr. Burke.

8. Admitted in part, Denied in part. As to the records the same is admitted, however, as explained at the various depositions, the problems actually started to appear in the

summer of 2006, with the lapse in time explained by the time they were observed and understood to be other than "adolscent behavior" and then appointments made.

9. Denied. Dr. D'Agaro has also issued a narrative report, attached hereto as Plaintiff's Exhibit "A".

10. Denied. Again, defendants have either misstated or over simplified this particular matter. First, Cheyanne fully participated in two sessions with Dr. D'Agaro, each lasting about four (4) hours, which did not substantially involve the participation of her mother, who was present only for the first 10 - 15 minutes. As Plaintiff understand the situation, such treatment/sessions need to be "one on one" to be effective. Furthermore, these sessions involve testing which objectively documents issues about a person's cognitive and emotional-behavioral circumstances.

11. Admitted.

12. Denied. In that Plaintiff has permitted the Defense access to all of her relevant medical records, it is a misstatement to say the defense has been provided with "limited" records. Furthermore, given the records, reports and opinions of Drs. Burke, Clark and D'Agaro, it is DENIED that Cheyanne's cognitive, emotional-behaioral issues do not relate to the traumatic brain injury she sustained in said accident.

13. Admitted.

14. Admitted.

15. Admitted.

16. Admitted in part, denied in part. As to what the Defense writes, the same is admitted. However, to the extent the same indicates that the financial difficulties of such trip would be eliminated by their offer, the same is DENIED in that as a teenager (not

fully licensed nor capable of safe driving given her injuries), her mother would need to accompany her and be forced to miss yet another day of employment.

17. Admitted in part, denied in part. As to what is stated, the same is admitted.

However, there are other issues, even on top of the financial situation discussed above, which include:

(a) As Plaintiffs understand such testing, this would require Cheyanne to be alone, for lengthy periods of time, with defense contracted people who do not have her best interests at heart;

(b) Pursuant to Pa.R.Civ.P. 4010(4)(i), Cheyanne would hve the right to have counsel and or her mother present during such examinations, however, as discussed above, Plaintiff understands that implementation of such involvement renders the neuro-psychological testing useless, which places at issue the appropriateness of this whole request;

(c) It should be noted that immediately following the subject accident, Cheyanne was taken to Philipsburg Hospital, which given her injuries, transferred her to Altoona Regional Hospital, which is where she came into contact with Dr. Burke. It was Dr. Burke who recommended Dr. Clark, who in turn recommended Dr. D.Agaro. As such, these physicians are all "treating physcians", not hired guns by the Plaintiff and as such are entitled to more deference;

(d) Given the extensive medical documentation and in light of the very invasive process by which the defense wishes to again victimize Cheyanne, a more appropriate balancing approach would be to require the defense experts be limited to review of the

medical records at which time such experts could either determine they can opine or do need an actual examination and this issue could be properly considered;

(e) It should also be noted that Dr. Clark has also recently recommended that Cheyanne be seen by another expert, also located in the Pittsburgh area, who specializes in adolescent neurology, placing further financial strain on Plaintiff; and

(f) Defendant has failed to meet its burden to justify a trip approaching 150 miles to visit with their experts, especially in light of their options to either (i) locate such experts in this area; or (ii) have their experts come to this area for these purposes.¹

18. Denied. As outlined above, at this point this merely is an assertion by the defense without any supporting documentation from their so called experts, let alone that Pennsylvania Rules of Civil Procedure prevent such examinations when the same are unduly burdensome to the point they become more for harassing or vexation purposes.

19. Plaintiff hereby incorporates its responses hereto as to why said MOTION should be denied under the attenuate circumstances.


20. The same is a legal conclusion for which no response is deemed necessary. It should also be pointed out that what is being requested herein is not really "medical" testing but rather a very invasive process on a sixteen year girl, with cognitive and emotional-behavioral difficulties, for which Defense should have more case law rather than generic medical testing principles, from a Court of Common Pleas decision.

21. For the reasons previously herein stated, the same is DENIED.

WHEREFORE, Plaintiff respectfully requests that the same be DENIED until such time as the Defense presents sufficient evidence that such testing is actually needed and then, determinations can be made as to what exactly is involved, the manner to be done so that Pa.R.Civ.P. 4010(4)(i) can be accommodated, and the issues involving finances and location be resolved.

**Neuropsychological, Psychoeducational and Vocational Evaluations
Cognitive Remediation and Medical Psychotherapy
Forensic Consultation**

As of my last contact with her on April 10, 2008, Cheyanne reported a full resolution of the headaches and periodic dizziness that were not present prior to her December of 2005 accident. Cognitively, however, she was continuing to experience "confusion" that prevented her from following class/subject directions in general and mathematics specifically. She equally remained easily distracted in class, especially large classes (currently biology and algebra) where others are talking, tapping or dropping pencils, and so on. Follow-up neuropsychological testing, which validated continued impairment in her auditory attention and information processing, correlated with Cheyanne's subjective complaints. From an emotional-behavioral perspective, Cheyanne was experiencing anxiety during class examinations, "pressured" to not be the last one to complete testing. She also remained "moody" but believed that she was less depressed. She also denied any self-mutilation (cutting) or suicidal thoughts.

CAUSE THEREOF: The aforementioned difficulties are the direct or the indirect result of the traumatic brain injury that Cheyanne sustained on December 26, 2005 when the automobile that she was a passenger in was involved in a partial rollover accident. Indeed, prior to this motor vehicle accident, Cheyanne was demonstrating none of these difficulties and, from a functional perspective, was doing well in school.

The direct injury would be Cheyanne's diagnosed traumatic brain injury. The indirect injuries would be more symptomatic and include, from a cognitive perspective, the "confusion" that prevents her from following class/subject directions in general and mathematics specifically, as well as neuropsychological test findings that continue to validate the existence of impairment in her auditory attention and information processing. An additional indirect result of her injury is Cheyanne's emotional-behavioral presentation. She is fully cognizant of the fact that she is now struggling more in school to achieve academic success. It is this struggling that is now responsible for her anxiety during class examinations and her ongoing "moodiness" (depression).

DIAGNOSIS: As of my last contact with her on April 10, 2008, per the Fourth Edition of the Diagnostic and Statistical Manual of Mental Disorders and the Ninth Edition of the International Classification of Diseases, the following diagnoses were judged to be most appropriate for Cheyanne:

- Axis I = Cognitive Disorder Not Otherwise Specified (294.9), secondary to
Axis III; Major Depressive Disorder, Single Episode, Moderate (296.22)
+ Anxiety Disorder Not Otherwise Specified (300.00).
- Axis II = No Diagnosis (V71.09) at this time.
- Axis III = Mild Traumatic Brain Injury (850.9), sustained 12/26/05.

TREATMENTS TO DATE: I completed two neuropsychological evaluations but have not been directly involved in any treatment with Cheyanne. She has, however, continued treatment with Dr. Clark that has included the monitoring of both antidepressant and cognitive enhancing medications. Per my last contact with her, Cheyanne also remained involved in individual counseling with Cen-Clear Child Services, Inc., to further address her emotional-behavioral issues.

PROGNOSIS: Given that her traumatic brain injury occurred over two years and three months prior to my last neuropsychological evaluation, I do not believe that Cheyanne will experience any additional spontaneous improvement. She is at the point where any residual physical, cognitive and emotional-behavioral deficits need to be symptomatically treated.

FUTURE NEEDS: First and foremost, Cheyanne needs to continue with all medical

interventions prescribed by those physicians who remain involved in her care, especially Dr. Clark. Specific interventions should include the ongoing use of Citalopram or another antidepressant medication to ensure continued emotional and behavioral stability, as well as Exelon to stabilize and improve her cognitive status.

In addition to any medications, Cheyanne should also remain involved in individual counseling, whether through Cen-Clear Child Services, Inc. or another channel.

Within school, Cheyanne should have the opportunity to take class examinations in a quieter setting to improve her mental focus, should be permitted extra time to complete such examinations, and should be provided with lecture notes or study outlines to ensure that the material that she is studying is appropriate and complete. Cheyanne should also be permitted the use of a calculator to complete mathematical calculations.

Sometime during her junior year of high school, Cheyanne should be referred for an evaluation by the Office of Vocational Rehabilitation, who may be able to assist Cheyanne in obtaining funding for a higher education and, if still necessary, academic accommodations. Such an evaluation would require updated testing that would permit additional comparison against current baseline data from the two neuropsychological evaluations that have already been performed.




AND NOW, this 11th day of February, 2009, upon consideration of Defendant's Motion to Compel Medical and Psychological Examinations of Plaintiff Cheyanne Hahn, and Plaintiff's response thereto, it is hereby ORDERED as follows:

1. Pursuant to Pa. R.C.P. 4010, Plaintiffs shall produce Cheyanne Hahn, for an independent medical examination and an independent neuropsychological examination in the manner set forth herein.
2. The medical examination shall be conducted by Richard Kasdan, M.D., and shall take place on March 24, 2009, at Penn Hills/Monroeville, 665 Rodi Road, Two Rodi Plaza, Suite 103, Pittsburgh, PA 15235. Cheyanne Hahn shall appear at Dr. Kasdan's offices at 9:45 a.m.
3. The neuropsychological examination shall be conducted by James Petrick, PhD., and shall take place on March 24, 2009 beginning at 1:00 p.m. at Dr. Petrick's offices at 607 Washington Road, Suite 302-A, Mount Lebanon, PA 15228.
4. Pursuant to Pa.R.C.P. 4010, Cheyanne Hahn may be accompanied by a representative during the examinations, with the exception that during the psychometrics portion of the neuropsychological examination, a representative may observe the examination, but not be present in the same room during the administration of the testing. During this portion of the neuropsychological examination, arrangements shall be made so that Cheyanne Hahn's representative can observe the examination by visual and auditory means. In the

event it is not possible to arrange for observation by auditory means, then Plaintiffs shall be permitted to create an audio recording of this portion of the examination.

5. Defendant shall provide transportation to and from the examinations through a licensed transportation service, at no cost to Plaintiff.
6. Plaintiff has represented the Cheyanne Hahn is scheduled to have an examination by a pediatric neurologist in the Pittsburgh area on February 24, 2009. Plaintiffs shall produce to Defendant any and all records and reports created as a part of this examination, including results of any testing as may be performed, as soon after the examination as possible, and in any event, by no later than March 16, 2009.
7. Defendant has requested records from Cen-Clear Child Services from March 20, 2008 forward. The Court is advised that Cen-Clear Child Services will not release the records requested without a signed consent by Cheyanne Hahn. Plaintiffs shall fully cooperate so that complete records are provided to Defendant as soon as possible, and in any event by no later than March 10, 2009.
8. If for any reason complete records as referenced in No. 6 and 7 of this Order above are not produced to Defendant by March 10, 2009, Defendant shall have the option of canceling and rescheduling the examinations for a time after the complete records have been secured. This is not intended as a limitation on Defendant's right to seek other relief as may be appropriate.
9. Defendant shall provide Plaintiffs with a copy of the report from Dr. Kasdan and from Dr. Petrick within thirty (30) days of Defendant's receipt of these reports.



**MOTION TO COMPEL PLAINTIFF CHEYANNE HAHN TO SIGN CONSENT
ALLOWING RELEASE OF COMPLETE COUNSELING RECORDS**

1. This action sounds in motor vehicle negligence, and arises from a single-vehicle accident that occurred on December 26, 2005. Minor Plaintiff Cheyanne Hahn was a passenger in a vehicle driven by her father, Defendant Jeffrey Hahn. Plaintiffs bring this action seeking damages for injuries allegedly sustained by Cheyanne Hahn in the accident, including a traumatic brain injury that Plaintiffs contend causes ongoing and potentially permanent cognitive, psychological and emotional-behavioral problems, including learning deficits, depression, and self-mutilation behavior.

2. Plaintiffs initially cooperated in providing Defendant access to medical records, and Defendant obtained initial treatment records via subpoena and/or use of authorizations signed by Lorraine Hahn, as parent and natural guardian of minor Plaintiff Cheyanne Hahn.

3. Inter alia, Defendant obtained initial treatment records from Cen-Clear Child Services relating to Cheyanne Hahn's psychological counseling from February 21, 2008 through March 20, 2008. These records were obtained from Cen-Clear on or about April 4, 2008,

pursuant to an authorization signed by Lorraine Hahn, as parent and natural guardian of Cheyanne Hahn.

4. Defendant is currently in the process of obtaining updated medical and counseling records in anticipation of a defense neurological examination and neuropsychological examination, scheduled to take place on March 24, 2009.

5. Because Plaintiffs refused to voluntarily cooperate with Defendant's request for independent medical and psychological examinations, Defendant was forced to file a Motion to Compel Medical and Psychological Examinations (hereinafter "Rule 4010 Motion"), which was filed on December 1, 2008. The March 24, 2009 date for the defense examinations is pursuant to a Court Order entered on February 11, 2009 after two separate argument sessions concerning Defendant's Rule 4010 Motion.¹

6. Following depositions in this case on December 10, 2008, Defendant sought a second authorization for the release of records from Cen-Clear Child Services so that updated treatment records could be obtained.

7. No objection to this request was asserted on behalf of Plaintiffs, and, in fact, Plaintiff *Lorraine Hahn* provided the fully executed authorization as requested.

8. Defendant sent the authorization signed by Plaintiff Lorraine Hahn with a request for updated records to Cen-Clear Child Services on January 8, 2009. A true and correct copy of Defendant's correspondence to Cen-Clear is attached hereto as Exhibit "A."

¹ March 24, 2009 is the date both examinations are currently scheduled to occur. However, this date was set with the anticipation that all necessary records would be produced, including the Cen-Clear records and records of a consultation with a pediatric neurologist in Pittsburgh. Defendant has recently been advised by Plaintiff that Plaintiffs' production of records of Cheyanne Hahn's February 24, 2009 visit with the pediatric neurologist will likely be delayed. Given these circumstances, Defendant will need to look into the possibility of rescheduling the examinations for a later date.

9. In response, Defendant received correspondence from Cen-Clear Child Services stating that the records could not be released until such time as the minor Plaintiff, Cheyanne Hahn, had the opportunity to review her file. Defendant's counsel was also advised by Cen-Clear that the records could not be released without a signed consent from Cheyanne Hahn. (See correspondence of January 21, 2009 from Cen-Clear Child Services attached hereto as Exhibit "B").

10. During the second argument session on Defendant's Rule 4010 Motion, conducted on February 2, 2009, Defendant advised the Court that Cen-Clear required Cheyanne Hahn's written consent before her additional treatment records would be released, and that Cheyanne Hahn had not, as of that time, given the necessary consent. Defendant understood the Court's directive at the February 2, 2009 argument to be that Plaintiffs would be required to sign any necessary consents to allow Defendant access to Cheyanne Hahn's complete records.

11. The Court's Order of February 11, 2009 specifically addressed this issue as follows at paragraph 7:

7. Defendant has requested records from Cen-Clear Child Services from March 20, 2008 forward. The Court is advised that Cen-Clear Child Services will not release the records requested without a signed consent by Cheyanne Hahn. *Plaintiffs shall fully cooperate so that complete records are provided to Defendant as soon as possible, and in any event by no later than March 10, 2009.*

(emphasis added).

12. In response to the January 8, 2009 request to Cen-Clear for updated records, Defendant received *partial* records, along with correspondence indicating that the records produced are *incomplete*, and that Plaintiff Cheyanne Hahn would not sign a release to allow the production of her complete file. (A copy of the transmittal correspondence accompanying the

partial Cen-Clear Child Services records is attached hereto as Exhibit "C." Out of respect for the privacy interest of the minor Plaintiff Cheyanne Hahn, the partial records produced by Cen-Clear Child Services are not produced herewith).

13. Defendant's counsel made a brief telephone inquiry of Cen-Clear Child Services to confirm that the complete file had not been released. This inquiry confirmed that Cheyanne Hahn has only consented to the release of a *portion* of her records. Defendant understands that, if Cheyanne Hahn will sign an authorization allowing the release of her complete file from Cen-Clear, those records will be released to Defendant.

14. Defendant also contacted Plaintiffs' attorney requesting clarification on this issue. (See correspondence from defense counsel dated February 20, 2009, attached hereto as Exhibit "D").

15. Counsel for the parties further discussed the issue, and Defendant requested that Plaintiff Cheyanne Hahn reconsider her refusal to consent to the release of complete records. (See correspondence from Attorney Noble dated February 23, 2009, and correspondence from defense counsel dated February 25, 2009, attached as Exhibits "E" and "F").

16. The records from Cen-Clear are treatment records for Plaintiff Cheyanne Hahn related to psychological condition(s) that Plaintiffs claim resulted (either in whole or in part) from the motor vehicle accident, and for which Plaintiffs seek damages.

17. Plaintiffs have not raised any substantive objection to production of these records, and any privilege that might otherwise exist was clearly waived by placing Cheyanne Hahn's psychological condition directly at issue. See e.g. Kraus v. Taylor, 710 A.2d. 1142, 1144-45 (Pa. Super. 1998).

18. Plaintiff Cheyanne Hahn's refusal to sign an authorization allowing the production of her complete file from Cen-Clear Child Services works to the severe prejudice of Defendant by preventing Defendant from obtaining highly pertinent treatment records in this case, violates the Court's February 11, 2009 Order, and will thwart Defendant's ability to move forward with the independent medical and neuropsychological examinations if not remedied by this Court.

19. Defendant submits that the imposition of attorneys fees upon Plaintiffs connected with preparing and presenting the within Motion is appropriate, given that Defendant is clearly entitled to the records sought, and that the refusal to provide consent for release of the complete records violates the Court's February 11, 2009 Order requiring Plaintiffs' full cooperation.

WHEREFORE, Defendant respectfully requests that the minor Plaintiff, Cheyanne Hahn, be compelled to sign an authorization allowing the release of her complete file from Cen-Clear Child Services, Inc. Defendant further requests that the Court grant his request for attorneys fees, and enter an Order requiring Plaintiffs to reimburse Defendant for attorneys fees related to preparation and presentation of the within Motion.

§ 5100.33. Patient's access to records and control over release of records.

(a) When a client/patient, 14 years of age or older, understands the nature of documents to be released and the purpose of releasing them, he shall control release of his records. For a client who lacks this understanding, any person chosen by the patient may exercise this right if found by the director to be acting in the patient's best interest. In the event that the client/patient is deceased, control over release of records may be exercised by the client's/patient's chosen executor, administrator or other personal representative of his estate, or, if there is no chosen personal representative, by a person otherwise empowered by court order to exercise control over the records. In the event that the client/patient is less than 14 years of age or has been adjudicated legally incompetent, control over release of the client's/patient's records may be exercised by a parent or guardian of the client/patient respectively.

(b) The term "access" when used in this section refers to physical examination of the record, but does not include nor imply physical possession of the records themselves or a copy thereof except as provided in this chapter.

(c) A person who has received or is receiving treatment may request access to his record, and shall be denied such access to limited portions of the record only:

(1) Upon documentation by the treatment team leader, it is determined by the director that disclosure of specific information concerning treatment will constitute a substantial detriment to the patient's treatment.

(2) When disclosure of specific information will reveal the identity of persons or breach the trust or confidentiality of persons who have provided information upon an agreement to maintain their confidentiality.

(d) A patient may obtain access to his records through the facility, or in the case of those records kept by the county administrator, through the physician or mental health professional designated by the administrator. Any third parties who are granted access to records may discuss this information with the patient only insofar as necessary to represent the patient in legal proceedings or other matters for which records have been released. Discussion of records with patients should be part of the therapeutic process and is not to be undertaken by other than mental health professionals.

(e) The limitations in subsection (c) are applicable to parents, guardians, and others who may control access over records as described in subsection (a) except that the possibility of substantial detriment to the parent, guardian, or other person may also be considered.

(f) If a person wishes to enter a written reaction qualifying or rebutting information in their records which they believe to be erroneous or misleading, they shall have the right to prepare such statement for inclusion as part of their record. The patient's written reaction shall accompany all released records.

(g) The director of the treatment team or the facility director may require that a mental health professional, who is a member of the treatment team, and who has reviewed the record in advance, be present when the patient or other person examines the record to aid in the interpretation of documents in the record. If the records pertain to a former patient, an appropriate mental health professional may be designated by the facility director.

(h) Access to presentence reports, which may be part of the persons' records, is governed Pa.R.Crim.P. No. 1404 (relating to disclosure of reports), and the patient may have access to these records only upon order of the sentencing judge. Any conditions of confidentiality imposed by the sentencing judge must be complied with. Similarly, parole and probation reports shall be released or access to them given only in accordance with 37 Pa. Code Part II (relating to Board of Probation and Parole).

(i) If a person is denied access to all or part of his record, this fact and the basis for the denial shall be noted in the person's record.

(j) When records or information have been forwarded from one agency to another agency, the receiving agency may not refuse the client or patient access to the records received except in accordance with subsection (c). Records received from other agencies become part of the client/patient's active record and are subject to the controls exercised over them by the client, patient, or those with authority over records as defined in § 5100.31 (relating to scope and policy).

Notes of Decisions

Patient access to whatever record was made of commitment hearing, in the form it exists, is a minimal requirement to comport with procedural due process. *In re S.O.*, 492 A.2d 727 (Pa. Super. 1985).



Please accept this as an update on various issues on going and or raised in your letter (FAX) of February 20th.

UPMC-Children Hospital

Please be advised that Cheyanne is scheduled to be examined tomorrow at UPMC-Children's Hospital, in particular by Dr. Inna Vaisleib, from the division of children's neurology. I have asked Ms. Lorraine Hahn while she is there to inquire about the means to have those records available in the shortest time frame possible to assist with your scheduled IMEs and per the Court's Order. It would be my recommendation that you present an appropriate AUTHORIZATION for Ms. Hahn's signature.

Cen-Clear Records

Cheyenne has requested that certain comments she made during therapy sessions be withheld from production. I do not know the contents or the reasoning of this decision, although I have been informed that such statements are rather "benign". Cen-Clear's position, as I understand the matter, is that when a person is of the age of 14 years, it becomes their decision as to whether records are or are not released. As I recall, you have an AUTHORIZATION signed by Ms. Lorraine Hahn, which is why we are facing this issue. Cen-Clear has also informed me that they would produce such records if in fact a court orders as such. It would be my suggestion that these records be produced to the Court for an in camera inspection to determine whether they in fact be released to the defense.

In closing, I will relay Cen-Clear's overall concern. It appears that production of the therapy notes (i.e. Cheyanne's comments) renders therapy useless as even the therapist has concern as to what topics are breached, knowing that disclosure is forthcoming.



Dear Mr. Noble:

Thank you for your letter of February 23, 2009 in follow-up to our telephone conversation of that same day. I understand from Cen-Clear that the only obstacle to the release of Cheyanne's complete counseling records is Cheyanne's refusal to sign a release for all of the records. If Cheyanne will sign a complete release, then all of the records will be forwarded to me, and there would be no need for a Court Order directed to Cen-Clear.

Under the circumstances, it certainly seems that the most efficient approach would be for Cheyanne to simply sign an authorization allowing her complete counseling records to be released. This would avoid the need to directly involve Cen-Clear in the Court proceedings (as would be necessary if I were to seek an Order of production directly against Cen-Clear), and avoid any negative impact that such involvement might have on Cheyanne's counseling. Proceeding in this fashion would also be consistent with the Court Order entered on February 11, 2009, which requires Plaintiffs to cooperate with respect to production of the Cen-Clear records.

As you know, because of the upcoming independent medical examinations, we will need to resolve these issues as quickly as possible. The Court Order requires production of the Cen-Clear records (and cooperation by Plaintiffs in this regard) by no later than March 10th. I would request that Cheyanne reconsider her position and authorize the release of the complete records immediately. In the meantime, I will prepare a motion to the Court seeking to compel Cheyanne to sign the necessary authorizations. In light of the Court's previous Order, and the fact that the records at issue have direct bearing on the injury claims in this case, I also reserve the right to seek counsel fees related to preparing and presenting the motion.



Finally, given that the records at issue are treatment records directly related to Cheyanne's mental health, I do not agree that it would be appropriate for the Court to review the records *in camera* and decide which might be pertinent. I am not sure how the Court would even make this determination without the assistance of appropriate experts. Nonetheless, if Cheyanne is willing to have the complete counseling file produced to the Court, as suggested in your February 23rd letter, please make arrangements to have the records ready for review by Judge Ammerman so that, if he believes *in camera* review to be appropriate, resolution of the motion to compel will not be delayed while we wait for this step to occur.



MOTION TO RECONSIDER

NOW COMES, the Plaintiff, Lorraine L. Hahn, mother and natural guardian for Cheyanne M. Hahn, by and through her counsel of record, Theron G. Noble, Esquire, of Ferraraccio & Noble, who avers as follows in support of her MOTION TO RECONSIDER:

1. On or about February 27, 2009, Defendant filed a MOTION TO COMPEL concerning his attempt to compel Cheyanne Hahn to sign a consent allowing release of her complete counseling records from Cen-Clear.
2. Said MOTION did not contain a notice to plead nor did it contain a Rule to Show Cause as required by Clearfield County Local Rules concerning motion practice.
3. That on March 3, 2009, this Court sua sponte, without benefit of hearing, argument or any reply from the Plaintiff, entered an ORDER, attached hereto as Exhibit "A" granting Defendant's requested relief, including his request for Attorney's fees.
4. That has been documented in previous filings with this Court, the minor child, Cheyanne Hahn suffered a head injury in the automobile accident subject matter of this

lawsuit which has, amongst other issues, effected her "executive function".

5. At issue in Defendant's MOTION TO COMPEL was that the minor child, who has reached the age of 16 years of age, was advised by her therapist at Cen-Clear, from whom she receives counseling, that she has the right to refuse release of her counseling records under Federal law, and temporarily did so, resulting in less than complete disclosure by Cen-Clear of said records.

6. That Plaintiff in this case, Cheyanne's mother and natural legal guardian, had in fact cooperated as per the Court's ORDER, dated February 11, 2009, a true and correct copy of which is attached hereto as Exhibit "B", even signing an AUTHORIZATION permitting Defendant immediate access to said records.

7. That while this matter was on going, Plaintiff's counsel kept Defense Counsel fully abreast of the situation and even communicated that Plaintiff was talking with her daughter about the need, as determined by the Court, for full disclosure of said records, and was in the process of convincing her minor daughter to withdraw her objection to the few records, being private notes from therapy sessions, which had been withheld.

8. That within a few days, Cheyanne Hahn agreed to said complete disclosure, said fact was communicated to Defense Counsel, and on or about March 4, 2009, Cheyanne Hahn communicated to Cen-Clear via FAX that she had released her objection to the withheld records. See Exhibit "C" attached hereto, being a true and correct copy of a letter forwarded to Defense Counsel following the phone conversation in which this fact was so communicated.

9. That upon information and belief, Cen-Clear has, or shortly will, send to Defense Counsel the previously withheld records.

10. That Plaintiff, Lorraine L. Hahn, has at all times fully complied with all Court Orders in this case.

11. That upon information and belief, that defendant will have been provided by March 10, 2009, as per paragraph 7 of the February 11th ORDER, all records from Cen-Clear, including those records that the minor child had not previously consented to release.


12. That Plaintiff has not violated said ORDER nor engaged in any conduct which even remotely places her in a position to be sanctioned.



ORDER

AND NOW, this 11th day of February, 2009, upon consideration of Defendant's Motion to Compel Medical and Psychological Examinations of Plaintiff Cheyanne Hahn, and Plaintiff's response thereto, it is hereby ORDERED as follows:

1. Pursuant to Pa. R.C.P. 4010, Plaintiffs shall produce Cheyanne Hahn, for an independent medical examination and an independent neuropsychological examination in the manner set forth herein.
2. The medical examination shall be conducted by Richard Kasdan, M.D., and shall take place on March 24, 2009, at Penn Hills/Monroeville, 665 Rodi Road, Two Rodi Plaza, Suite 103, Pittsburgh, PA 15235. Cheyanne Hahn shall appear at Dr. Kasdan's offices at 9:45 a.m.
3. The neuropsychological examination shall be conducted by James Petrick, PhD., and shall take place on March 24, 2009 beginning at 1:00 p.m. at Dr. Petrick's offices at 607 Washington Road, Suite 302-A, Mount Lebanon, PA 15228.
4. Pursuant to Pa.R.C.P. 4010, Cheyanne Hahn may be accompanied by a representative during the examinations, with the exception that during the psychometrics portion of the neuropsychological examination, a representative may observe the examination, but not be present in the same room during the administration of the testing. During this portion of the neuropsychological examination, arrangements shall be made so that Cheyanne Hahn's representative can observe the examination by visual and auditory means. In the

event it is not possible to arrange for observation by auditory means, then Plaintiffs shall be permitted to create an audio recording of this portion of the examination.

5. Defendant shall provide transportation to and from the examinations through a licensed transportation service, at no cost to Plaintiff.
6. Plaintiff has represented the Cheyanne Hahn is scheduled to have an examination by a pediatric neurologist in the Pittsburgh area on February 24, 2009. Plaintiffs shall produce to Defendant any and all records and reports created as a part of this examination, including results of any testing as may be performed, as soon after the examination as possible, and in any event, by no later than March 16, 2009.
7. Defendant has requested records from Cen-Clear Child Services from March 20, 2008 forward. The Court is advised that Cen-Clear Child Services will not release the records requested without a signed consent by Cheyanne Hahn. Plaintiffs shall fully cooperate so that complete records are provided to Defendant as soon as possible, and in any event by no later than March 10, 2009.
8. If for any reason complete records as referenced in No. 6 and 7 of this Order above are not produced to Defendant by March 10, 2009, Defendant shall have the option of canceling and rescheduling the examinations for a time after the complete records have been secured. This is not intended as a limitation on Defendant's right to seek other relief as may be appropriate.
9. Defendant shall provide Plaintiffs with a copy of the report from Dr. Kasdan and from Dr. Petrick within thirty (30) days of Defendant's receipt of these reports.




This letter follows our phone conversation of today.

DEFENDANT'S RESPONSE TO PLAINTIFFS' MOTION
TO RECONSIDER

AND NOW, comes Defendant Jeffrey K. Hahn, by and through his attorneys, McQuaide, Elasko, Fleming & Faulkner, Inc. and files the following Response to Plaintiffs' Motion to Reconsider.

1. Admitted in part and denied in part. It is admitted that Defendant filed a Motion to Compel Plaintiff Cheyanne Hahn to Sign Consent Allowing Release of Complete Counseling Records on or about February 27, 2009 (hereinafter "Motion to Compel"). It is denied that Plaintiffs' allegations in paragraph 1 accurately and completely reflect the contents of the aforementioned Motion. Defendant's Motion to Compel, being a written document of record, speaks for itself.

2. Admitted in part and denied in part. It is admitted only that Defendant did not file a Notice to Plead or Rule to Show Cause at the time the Motion was filed with the Court. By way of further response, under the circumstances presented by this matter, Defendant denies that a Notice to Plead and/or Rule to Show Cause were necessary.

3. The Court's Order dated March 3, 2009, being a written document of record, speaks for itself. By way of further response, Defendant received the aforementioned Court Order on March 4, 2009, and served a copy of the Order upon Plaintiffs on that same date.

4. Denied.

5. Denied as stated. After reasonable investigation, Defendant lacks sufficient knowledge or information to form a belief as to the truth of the allegations as to discussions between Cen-Clear and Plaintiff Cheyanne Hahn. It is denied that any advice from Cen-Clear was an issue in Defendant's Motion to Compel. Rather, the issue raised therein was Cheyanne Hahn's refusal to consent to disclosure of her complete records from Cen-Clear, such that Cen-Clear could not release her complete counseling records to Defendant. Given that the partial consent form signed by Cheyanne Hahn was dated February 16, 2009, (see Exh. C to Defendant's Motion to Compel), it appears that this refusal continued even after entry of the Court's February 11, 2009 Order requiring full cooperation by Plaintiffs with respect to the Cen-Clear records.

6. Denied as stated. It is admitted that Lorraine Hahn had provided an authorization permitting the release of Cheyanne Hahn's records, which authorization had been provided to Defendant on or about December 22, 2008. This fact which was specifically acknowledged in Defendant's Motion to Compel at paragraphs 6 through 8. By way of further response, the necessity for Cheyanne Hahn, specifically, to consent to the release of her records was raised during the second argument on Defendant's Rule 4010 Motion seeking to compel independent medical examinations, and paragraph 7 of the Court's February 11, 2009 Order was addressed to the need for Cheyanne Hahn to sign a consent allowing the release of her treatment records.

7. Denied as stated. It is admitted only that counsel communicated regarding the situation after defense counsel had been provided only partial records and had been advised that

Cheyenne Hahn refused to consent to the release of her entire file from Cen-Clear. Any implication that defense counsel was assured that Cheyanne Hahn would be “convinced” to withdraw her objections and allow for release of the complete file is expressly denied. Defense counsel was never given any assurance that the complete file would be released absent another Order from the Court, and certainly was not assured that the records would be released in a timely fashion as required by the Court’s February 11, 2009 Order.

8. Denied as stated. It is admitted, on information and belief, that Cheyanne Hahn ultimately signed a release allowing for complete counseling records from Cen-Clear to be provided to Defendant. However, Cheyanne Hahn did not do so until after Defendant was forced to file a motion to compel, despite the Court’s February 11, 2009 Order specifically requiring cooperation in this regard from Plaintiffs. Please also see paragraph 7, above, incorporated herein by reference. Defendant was not informed that Cheyanne Hahn had agreed to sign the full release before Defendant’s Motion to Compel was filed.

9. Admitted. Defendant received supplemental records from Cen-Clear on or about March 5, 2009. Copies of these records have been provided to Plaintiffs’ attorney.

10. It is admitted only that Plaintiff Lorraine Hahn had signed an authorization allowing for the release of Cheyanne’s records from Cen-Clear, and that this authorization had been provided prior to the Court’s February 11, 2009 Order, as noted in paragraph 6, *supra*. This fact is acknowledged in Defendant’s Motion to Compel, at paragraph 6 through 8.

11. Please see response to paragraph 9, above.

12. Denied for the reasons further stated herein and in Defendant’s Motion to Compel filed on February 27, 2009.

13. Denied. In an attempt to gather all treatment records needed in advance of independent medical and neuropsychological examinations scheduled for March 24, 2009, and in light of Cheyanne Hahn's refusal to sign a complete authorization as of February 16, 2009 and the lack of assurance that the complete authorization would be given, Defendant was forced to file his Motion to Compel. It was only after the Motion to Compel was filed that defense counsel was advised that Cheyanne Hahn would, in fact, sign a release to authorize release of her complete records.

14. Denied for the reasons further stated herein and in Defendant's Motion to Compel filed on February 27, 2009.

WHEREFORE, Defendant respectfully requests that Plaintiffs' Motion to Reconsider be denied.





MOTION FOR PERMISSION TO RESCHEDULE
INDEPENDENT MEDICAL EXAMINATIONS AND
AMEND COURT ORDER DATED FEBRUARY 11, 2009

AND NOW, comes Defendant, Jeffery K. Hahn, by and through his attorneys, McQuaide, Blasko, Fleming & Faulkner, Inc., and files the instant Motion for Permission to Reschedule Independent Medical Examinations and Amend Court Order Dated February 11, 2009. In support thereof, Defendant avers as follows:

1. This action sounds in motor vehicle negligence, and arises from a single-vehicle accident that occurred on December 26, 2005. Minor Plaintiff Cheyanne Hahn was a passenger in a vehicle driven by her father, Defendant Jeffrey Hahn. Plaintiffs bring this action seeking damages for injuries allegedly sustained by Cheyanne Hahn in the accident, including a traumatic brain injury that Plaintiffs contend causes ongoing and potentially permanent cognitive, psychological and emotional-behavioral problems, including learning deficits, depression, and self-mutilation behavior.

2. Pursuant to the Court Order dated February 11, 2009, Plaintiff is required to produce Cheyanne Hahn for an independent medical examination and an independent

neuropsychological examination on March 24, 2009. (A copy of the February 11, 2009 Court Order is attached hereto as Exhibit "A").

3. The medical examination and the neuropsychological examination were both scheduled to occur on March 24, 2009 with the anticipation that all necessary records would be produced, including records from Cen-Clear Child Services and records of a consultation with Inna Vaisleib, M.D., a pediatric neurologist in Pittsburgh.¹

4. Various issues arose between the parties with respect to the records from Cen-Clear Child Services, but these issues have since been resolved. However, there remains an issue with the records received from Cheyanne Hahn's consultation with Dr. Vaisleib.

5. In this regard, Defendant acknowledges receipt on March 9, 2009 of a document entitled "Preliminary Report" from Cheyanne Hahn's consultation with Dr. Vaisleib on February 24, 2009. (A copy of the Preliminary Report of Inna Vaisleib, M.D. is attached hereto as Exhibit "B").

6. Dr. Vaisleib's report is preliminary only, and it is clear that she has deferred any opinion relative to Cheyanne Hahn's ostensible brain injury symptoms because she did not have Cheyanne Hahn's prior treatment records and diagnostic test results available to her at the time of the February 24, 2009 visit.

7. It is also apparent that Dr. Vaisleib anticipates doing additional testing to assess the ongoing problems that Cheyanne Hahn reportedly experiences.

¹ This issue was addressed at the time of the second argument on Defendant's Motion to Compel the examinations. At that time, Defendant's counsel suggested that the exams be scheduled further out if that would be necessary to ensure that complete records of the pediatric neurological consultation would be produced. Furthermore, this matter is specifically addressed in the Court Order dated February 11, 2009 at paragraph 6.

8. Moreover, Dr. Vaisleib's report also states that Lorraine Hahn was to contact Dr. Vaisleib's office within a matter of days to ensure that the previous records were received and to finalize the future testing plans.

9. Specifically, Dr. Vaisleib's report states:

"In the meantime, I am hoping that we will receive the medical records from Altoona Hospital, and I would be able to review MRI scan as well as EEG reports and all additional reports to determine if further testing will be necessary. Most likely, we will need to obtain MRI scan of the brain to see the consequences of injury as well as obtain an EEG, as mom reports occasional occurrences of staring episodes. Also, it would be beneficial to obtain an EEG in view of the memory problems to make sure the child does not have subclinical seizures...Mom is to contact us in a couple days to make sure that we received prior medical records and finalize future testing plans."

(See Exhibit B attached hereto, page 4).

10. Due to the preliminary nature of Dr. Vaisleib's report, the need for her additional analysis of records, and the planned course for further testing, Defendant requests permission to reschedule the exams to a later date.

11. After the initial independent medical and neuropsychological examinations take place with Dr. Kasdan and Dr. Petrick, Defendant will not be in a position to seek other exams.

12. Accordingly, it is critical and very important that Defendant has complete information to provide to Drs. Kasdan and Petrick in advance of their examinations.

13. Defendant's counsel discussed with Plaintiff's counsel the possibility of rescheduling the examinations, but an agreement between the parties could not be finalized. (See correspondence dated March 10, 2009 attached hereto as Exhibit "C").

14. If the examinations are rescheduled, Plaintiff will not suffer any prejudice because the same arrangements and accommodations as set forth in the Court Order dated February 11, 2009 will be followed.²

15. Defendant needs to have these examinations rescheduled immediately to avoid incurring substantial, nonrefundable cancellation fees involved with the cancellation of expert exams.

16. Accordingly, Defendant seeks this Court's permission to reschedule the medical examination and neuropsychological examination and amend the Court Order dated February 11, 2009 accordingly.

WHEREFORE, Defendant respectfully requests that the Court grant the instant Motion and permit Defendant to reschedule the medical examination and neuropsychological examination to occur on a date and time after Defendant's receipt of a final report from Inna Vaisleib, M.D., as well as her final conclusions, analyses and impressions of Cheyanne Hahn, including any and all results of testing to be performed. Defendant further requests that this Court amend the Order dated February 11, 2009 accordingly.

² This includes, inter alia, having both exams take place on the same day and to have transportation to and from the exams at no cost to Plaintiff.

ORDER

AND NOW, this 11th day of February, 2009, upon consideration of Defendant's Motion to Compel Medical and Psychological Examinations of Plaintiff Cheyanne Hahn, and Plaintiff's response thereto, it is hereby ORDERED as follows:

1. Pursuant to Pa. R.C.P. 4010, Plaintiffs shall produce Cheyanne Hahn, for an independent medical examination and an independent neuropsychological examination in the manner set forth herein.
2. The medical examination shall be conducted by Richard Kasdan, M.D., and shall take place on March 24, 2009, at Penn Hills/Monroeville, 665 Rodi Road, Two Rodi Plaza, Suite 103, Pittsburgh, PA 15235. Cheyanne Hahn shall appear at Dr. Kasdan's offices at 9:45 a.m.
3. The neuropsychological examination shall be conducted by James Petrick, PhD., and shall take place on March 24, 2009 beginning at 1:00 p.m. at Dr. Petrick's offices at 607 Washington Road, Suite 302-A, Mount Lebanon, PA 15228.
4. Pursuant to Pa.R.C.P. 4010, Cheyanne Hahn may be accompanied by a representative during the examinations, with the exception that during the psychometrics portion of the neuropsychological examination, a representative may observe the examination, but not be present in the same room during the administration of the testing. During this portion of the neuropsychological examination, arrangements shall be made so that Cheyanne Hahn's representative can observe the examination by visual and auditory means. In the

event it is not possible to arrange for observation by auditory means, then Plaintiffs shall be permitted to create an audio recording of this portion of the examination.

5. Defendant shall provide transportation to and from the examinations through a licensed transportation service, at no cost to Plaintiff.
6. Plaintiff has represented the Cheyanne Hahn is scheduled to have an examination by a pediatric neurologist in the Pittsburgh area on February 24, 2009. Plaintiffs shall produce to Defendant any and all records and reports created as a part of this examination, including results of any testing as may be performed, as soon after the examination as possible, and in any event, by no later than March 16, 2009.
7. Defendant has requested records from Cen-Clear Child Services from March 20, 2008 forward. The Court is advised that Cen-Clear Child Services will not release the records requested without a signed consent by Cheyanne Hahn. Plaintiffs shall fully cooperate so that complete records are provided to Defendant as soon as possible, and in any event by no later than March 10, 2009.
8. If for any reason complete records as referenced in No. 6 and 7 of this Order above are not produced to Defendant by March 10, 2009, Defendant shall have the option of canceling and rescheduling the examinations for a time after the complete records have been secured. This is not intended as a limitation on Defendant's right to seek other relief as may be appropriate.
9. Defendant shall provide Plaintiffs with a copy of the report from Dr. Kasdan and from Dr. Petrick within thirty (30) days of Defendant's receipt of these reports.

I had the pleasure to see your patient, Cheyanne, a 16-year-old right-handed Caucasian female for evaluation of numerous complaints including memory loss, depression, and severe headaches. She is here today with her mother who reported to me that child was in motor vehicle accident on December 26, 2005. At that time, according to the mother, she suffered traumatic brain injury and was in Intensive Care in Altoona Hospital for three days. She was unconscious for an undetermined period of time. Accident happened at 5:30, she arrived to the hospital at 6:30 and had zero recollection of the accident including amnesia regarding the fact that the roof was cut off of the truck. She also did not recall ambulance ride either. Mother reports to me that the patient had some degree of temporal bleeding, but I do not have any formal medical records to review at the present time. Since that time, mom reports that depression and memory loss have not been improving despite of the medications. Also, she had some headaches during the time of the accident that subsequently subsided but in the last four months she had severe headaches. They are usually not preceded by any aura. They are associated with photosensitivity and photosensitivity, nausea and occasional vomiting, describing as 8/10, lasting for few hours and up to a week, once or twice per week. The headache improves with sleep and rest, and worsening with light and crying. The headache is usually present on the right side of the head and presents primarily in the afternoons and child did not miss any school because of the headaches.

IMPRESSION

Cheyenne is a 16-year-old right-handed white female with previous history of motor vehicle accident and reported traumatic brain injury with prolonged, postconcussive syndrome, present itself with depression, memory problems. She also has migraine headaches, and it is impossible to determine if it is related to the traumatic brain injury as they started almost four years after the accident although child did have some headaches during the time of the injury.

We discussed in details nonmedical preventive measures for the migraine headaches including a regular sleep-awake cycle, regular food intake, avoiding overheating, dehydration and food triggers such as monosodium glutamate, artificial sweeteners, nitrates, processed meat, and strong cheeses. I agree with primary doctor approach of trying Imitrex 100 mg at the onset of the migraine. The mother of the patient was advised against using that medication more than twice a week. Although the child has the medication, she has not tried it yet. Because of the side fact, she can go for some period of time without migraines I would advise that for prophylactic measures of the migraines, she would try to use magnesium supplements but this is not the medication that can be obtained in GNC store, one to two tablets a day for a couple of months would be recommended. In the meantime, I am hoping that we will receive the medical records from Altoona Hospital, and I would be able to review MRI scan as well as EEG reports and all additional reports to determine if further testing will be necessary. Most likely, we will need to obtain MRI scan of the brain to see the consequences of injury as well as obtain an EEG, as mom reports occasional recurrence of the staring episodes. Also, it would be beneficial to obtain an EEG in view of the memory problems to make sure child that does not have subclinical seizures. In addition, Child Developmental Unit evaluation with formal cognitive testing most likely will be also recommended. Mom is to contact us in a couple of days to make sure that we received prior medical records and finalize the future testing plans. Due to the fact that the family is living far away from us, we will try to combine all the testing in the minimal amount of visits. Follow up will be as necessary with Neurology. For the communications and test results, mom is to contact my nurse practitioner, Robyn Neft, 412-692-8484.

Dear Attorney Noble:

I received a copy of the Preliminary Report from Dr. Vaisleib yesterday, along with Plaintiffs' Motion to Reconsider. Defendant's Response to the Motion to Reconsider will be filed of record, although I am willing to discuss the issue of the attorney fees to see whether that can be resolved. Please accept this letter to address the concerns raised by the Preliminary Report from Dr. Vaisleib with respect to the independent medical examinations scheduled for March 24th.

When the IMEs were scheduled for March 24th with Drs. Kasdan and Petrick, it was anticipated that the UPMC consultation would have effectively taken place. As you know, this issue was addressed at the time of the second argument on Defendant's Motion to Compel the exams, and I suggested at that time that we schedule the exams further out if that would be necessary to ensure that we would have complete records of the anticipated February 24, 2009 consult at UPMC. This matter was also specifically addressed in paragraph 6 of the Court's February 11, 2009 Order pertaining to the IME's and setting the March 24th date.

I understand from your previous communications that Dr. Vaisleib did not have the records necessary for a complete consultation on February 24th as had been expected, and I do appreciate your efforts to obtain a record of what transpired at the visit. It is clear from Dr. Vaisleib's Preliminary Report, however, that she has deferred any opinion relative to Cheyenne's ostensible brain injury symptoms because she did not have Cheyenne's prior treatment records and diagnostic test results available to her at the time of the February 24th visit. It is also apparent from page 4 of the Preliminary Report that Dr. Vaisleib anticipates doing additional testing to assess the on-going problems that Cheyenne reportedly experiences, although that may

be dependent on her review of the prior treatment records when received. The Preliminary Report also states that Lorraine Hahn was to contact Dr. Vaisleib's office within a matter of days to ensure that the previous records were received and to finalize the future testing plans. Please advise me whether this contact has occurred.

As you are aware, Defendant will not be in a position to seek multiple exams for Cheyanne after the initial independent neurological and neuropsychological exams take place with Dr. Kasdan and Dr. Petrick. For this reason, it is very important that we have complete information to provide to Drs. Kasdan and Petrick in advance of the examinations.


In that the record from Dr. Vaisleib is clearly a Preliminary Report expressly anticipating additional analysis of records and potential further testing, I am compelled at this point to reschedule the exams for a later date. I will make the same arrangements as set forth in the Court's Order of February 11, 2009 to have both exams take place on the same day, and to have transportation to and from the exams. As I advised you previously, I am willing to try to reschedule the exams to take place in June after school is out for the summer if that is preferable to Lorraine Hahn and Cheyanne. In any event, I will need to hear from you regarding plans for the future testing with Dr. Vaisleib before setting specific dates so we do not run into an issue with records a second time.

Please contact me to discuss the timeframe for rescheduling the IMEs. In order to avoid incurring nonrefundable cancellation fees involved with the expert exams, I will need to have this matter resolved immediately. I would think we could resolve this issue without involving the Court, but if we cannot, I will need to move head with filing a motion and requesting an expedited ruling. I would, therefore, ask that you please contact me immediately to discuss this issue.

MOTION TO COMPEL EXPERT DISCOVERY

AND NOW, comes Defendant, Jeffrey K. Hahn, by and through his counsel, McQuaide Blasko, Inc., and files the following Motion to Compel Expert Discovery pursuant to Pa.R.C.P. 4003.5, 4007.4 and 4019. In support of this Motion, Defendant avers as follows:

Brief Factual and Procedural Background

1. This action sounds in motor vehicle negligence, and arises from a single vehicle accident that occurred on December 26, 2005. Defendant Jeff Hahn was the driver of the vehicle, and his daughter Cheyanne Hahn was a passenger.
2. Plaintiffs¹ filed a Complaint on or about June 7, 2007, to which Defendant filed an Answer with New Matter on June 28, 2007. Plaintiffs filed a Reply to New Matter on July 2, 2007, thereby closing the pleadings.
3. Plaintiffs contend that Cheyanne Hahn sustained a traumatic brain injury in the accident that has resulted in allegedly permanent cognitive, emotional and behavioral deficits and problems. Defendant disputes these claims.

¹ "Plaintiffs" refers to both Lorraine L. Hahn and Cheyanne M. Hahn. Cheyanne M. Hahn, a minor when this action was initiated, has since reached the age of majority.

4. Written discovery has been exchanged, and Defendant has subpoenaed records from Cheyanne's medical providers and counselors, and educational and vocational rehabilitation records concerning Cheyanne Hahn.

5. Medical records from the time period shortly after the accident reflect that Cheyanne Hahn sustained a small temporal lobe contusion and facial lacerations in the accident, but that she was recovering well from any accident-related injuries very shortly after the accident.

6. Indeed, Cheyanne was released from follow-up care with the neurosurgeon who had initially evaluated her injuries, Dr. James Burke, as of January 17, 2006. It was noted at that time that the temporal lobe contusion was resolved. (A true and correct copy of Dr. Burke's visit record, dated February 22, 2006, is attached hereto as Exhibit A).

7. Almost eleven months later, Cheyanne began treatment with various providers for claimed physical and psychological/behavioral problems that Plaintiffs contend are the result of an accident-related injury, including headaches, depression, memory and judgment problems, and behavioral problems, including self-mutilation.

8. Evidence adduced through discovery, including records and reports from Cheyanne Hahn's providers, has revealed numerous potential sources for Cheyanne's claimed symptoms and problems.

Expert Discovery Requests

9. Defendant served Interrogatories and Requests for Production of Documents on Plaintiffs on July 11, 2007, seeking, inter alia, to establish the identity of any experts to be called in support of Plaintiffs' claims and requesting reports from any such experts. (See Exhibits B and C hereto, Interrog. Nos. 18-21, and RFP No. 4).

10. Plaintiffs responded to Defendant's expert interrogatories by stating: "This answer will be supplied separately." (See id.).

11. Despite the fact that discovery has been ongoing for nearly four years and despite Defendant's repeated requests, Plaintiffs have not identified the medical witnesses they will call at trial to meet their *prima facie* burden of proof as to Cheyanne Hahn's condition and the cause of any claimed problems.

12. Cheyanne Hahn has seen multiple providers and counselors over the years for her alleged physical and cognitive/psychological/emotional deficits.

13. Records and reports produced from Cheyanne Hahn's providers do not set forth consistent competent opinions that the December 26, 2005 vehicle accident caused the cognitive, emotional and/or behavioral deficits allegedly experienced by Cheyanne Hahn, or that she suffered an injury in the accident that has continued to cause her any physical or psychological problems.

14. To date, Plaintiffs have produced reports from the following providers who ostensibly support Plaintiffs' claims in this litigation: Wayne D'Agaro, Psy.D. (neuropsychologist); Dr. Joseph Clark (neurologist); Dr. Inna Vasleib (pediatric neurologist); Hillary Feldman, Ph.D. (neuropsychologist); and Dr. Laura Harvatine (psychiatrist).²

15. Defendant retained a neurologist, Dr. Richard Kasdan, and a neuropsychologist, Dr. James Pettrick, for assistance in evaluating Plaintiffs' claims in this case. Independent medical examinations took place on October 24, 2011.³

² Records from other providers and counselors have also been exchanged in discovery.

³ Plaintiffs refused to voluntarily present Cheyanne for these examinations, and Defendant filed a motion to compel medical examinations on or about December 1, 2008. The Court granted Defendant's motion, with the condition that Defendant provide transportation and have both examinations conducted on the same day. Shortly

16. As summarized in paragraphs 17 through 35, below, the reports produced by Plaintiffs contain conflicting and inconsistent opinions as to the cause of any physical, cognitive and emotional problems that Plaintiffs contend were caused by the accident, opinions which do not meet the reasonable certainty standard required under Pennsylvania law, and in some instances opinions clearly lacking in adequate factual foundation.

Wayne D'Agaro, Psy.D.

17. Plaintiffs initially produced reports from a neuropsychologist, Wayne D'Agaro, Psy.D., reflecting opinions that Cheyanne Hahn had various cognitive, emotional and behavioral problems stemming from the December 2005 motor vehicle accident. True and correct copies of Dr. D'Agaro's reports dated March 30, 2007; April 16, 2008; and, December 5, 2008 are attached hereto as Exhibits D-1 through D-3.

18. Significantly, in a letter written to Attorney Noble dated January 23, 2009, Dr. D'Agaro retracted these opinions. In the January 23, 2009 letter, Dr. D'Agaro states:

... with respect to the issue of (a) previous sexual assault, (b) experimental street drug use, (c) adolescence, (d) sexual orientation, and/or (e) anger brought on by her parents separation and father's subsequent remarriage playing a role in Cheyanne's cognitive, emotional and/or behavioral difficulties, any of these issues could, indeed, be possible factors. These same issues, alone or in any combination could equally account for the obtained test scores noted in the prior paragraph, especially given the fact that these scores reflected no more than borderline to mild compromise.

after the Court's initial Order and after the examinations were scheduled, Plaintiffs informed Defendant that Cheyanne Hahn was going to consult with Dr. Inna Vasleib, a pediatric neurologist in Pittsburgh, with respect to her claimed accident-related injuries. Only a preliminary report was available from Dr. Vasleib as of the time the IMEs were originally scheduled. On motion of Defendant, the Court entered an Order permitting the IMEs to be postponed until Dr. Vasleib could complete the consultation. (See Order dated March 12, 2009). This did not occur until September of 2010, and Defendant was not provided with Dr. Vasleib's "final" report until April 4, 2011. Dr. Vasleib's final report is not supportive of Plaintiffs' claims in this lawsuit. See paragraphs 23-26 of the within motion, and Exhibit G, hereto.

(See Exhibit E hereto, January 23, 2009 letter of Dr. Wayne D'Agaro, at 2)(emphasis added).⁴

Dr. Clark

19. Plaintiffs also produced a report from a neurologist, Dr. Joseph Clark, dated June 28, 2008. A true and correct copy of Dr. Clark's report is attached hereto as Exhibit F.

20. In that report, Dr. Clark set forth opinions regarding Cheyanne Hahn's symptoms which appear to be premised entirely upon Dr. D'Agaro's opinions described in his 2008 reports. (See Exh. F).

21. Significantly, Dr. Clark could not have been aware of the January 23, 2009 letter to Plaintiffs' lawyer in which Dr. D'Agaro retracted his causation opinions, because that letter had not yet even been written.

22. Given Dr. Clark's almost complete deference to Dr. D'Agaro, and given that Dr. D'Agaro has retracted his previous causation opinions, it is highly questionable whether Dr. Clark is willing and/or able to testify in support of Plaintiffs' claims at trial.⁵

Dr. Inna Vasleib

23. Plaintiffs also produced reports from Dr. Inna Vasleib, a pediatric neurologist from Children's Hospital of Pittsburgh. (See reports dated February 24, 2009 (Preliminary) and September 21, 2010 (Final) attached hereto as Exhibits G-1 and G-2).

24. Dr. Vasleib's reports do not set forth opinions sufficient to support Plaintiffs' claims in this case.

25. In fact, in her "final" report Dr. Vasleib concludes:

⁴ Plaintiffs did not produce Dr. D'Agaro's letter to Defendant until September 2, 2009, nearly nine months after the report was written.

⁵ Although Plaintiffs have recently suggested that additional reports might be produced by Dr. Clark, (see ¶¶ 37-39, below, and accompanying exhibits), no further information has been provided by Plaintiffs.

"The causal relationship between [sic] motor vehicle accident and history of the conditions outlined is unclear."

(See Exhibit G-2, p. 4).

26. This opinion clearly would not suffice for Plaintiffs to meet their *prima facie* burden in this case.

Hillary Feldman, Ph.D.

27. A report from Dr. Hillary Feldman from Children's Hospital of Pittsburgh was produced on August 21, 2009. Dr. Feldman's evaluation was ordered as part of the data requested by Dr. Vasleib. (See Exhibit G-1, at 4). A true and correct copy of Dr. Feldman's report is attached as Exhibit H.

28. With respect to the alleged relationship between Cheyanne's cognitive and psychological/emotional difficulties and the December 2005 accident, at best, Dr. Feldman's report contains opinions that it is "likely" that there is some relation to the accident:

It was discussed that difficulties that Cheyanne is experiencing are likely related to her motor vehicle accident; however, it is felt that there may also be premorbid factors and stresses which have exacerbated difficulties. In particular, there is a history of sexual molestation which occurred prior to the motor vehicle accident and there is a history of significant family conflict. However, based on information received, it is likely that at least some factors are related to the motor vehicle accident and has exacerbated problems that may have been evident prior to the time of the accident.

(See Exhibit H, at pp. 9-10).

29. Dr. Feldman's statements as to a "likely" relationship between Cheyanne's symptoms and the accident are not sufficient to carry Plaintiffs' *prima facie* burden with respect to causation.

30. Plaintiffs have not produced any reports or records from Dr. Feldman expressing an opinion that an injury from the accident did, in fact, cause any of Cheyanne's problems, either in whole or in part.

Dr. Laura Harvatiné

31. Records of several visits Cheyanne had with Dr. Laura Harvatiné, a psychiatrist at SunPointe Health, were also produced by Plaintiffs.

32. Cheyanne began seeing Dr. Harvatiné in September of 2009, almost four years after the accident.

33. There is no indication from the records produced that Dr. Harvatiné had any medical records or other information pertaining to Cheyanne's treatment history following the accident beyond information provided by Plaintiffs themselves.

34. Defendant submits that it is highly questionable whether an adequate foundation exists with respect to any opinions set forth in Dr. Harvatiné's records.

35. Plaintiffs have not at any time produced an expert report from Dr. Harvatiné with respect to Plaintiffs' claims in this lawsuit.

**Supplemental Request for Identification of Experts and
Plaintiffs' Refusal to Cooperate**

36. Defendant has repeatedly requested that Plaintiffs provide supplemental responses to his expert discovery requests, and that Plaintiffs identify the name(s) of all persons to be called as witnesses to support the injury claims in this case and provide a report from all such individuals. (See e.g. letters from defense counsel dated April 28, 2011; May 23, 2011, and December 14, 2011, attached hereto as Exhibit I-1 through I-3).

37. Defendant most recently requested the identity of physicians and experts to be called on behalf of Plaintiffs by letter dated December 14, 2011. (See Exh. I-3).

38. Plaintiffs' counsel responded by referring vaguely to an unidentified "vocational rehabilitation specialist," and by stating that he would try to contact Dr. Harvatin, who has apparently since left the area, "to see if she has interest in testifying about Cheyanne's care, diagnosis, prognosis and causative factors." (See Correspondence of Attorney Noble dated December 27, 2011, attached hereto as Exhibit J). Plaintiffs' counsel also advised of a plan for additional testing to be done by Dr. Clark. (Id.).

39. Although Plaintiffs' counsel stated an ostensible willingness to work toward a case management scheduling order, (see id.), counsel has refused to acknowledge Plaintiffs' obligation in the first instance to provide complete responses to the expert discovery requests served over four years ago, and has continually refused to identify who will be called to testify to meet Plaintiffs' *prima facie* burden at trial.

40. In light of the nature of Cheyanne Hahn's claimed injuries, identification of any experts Plaintiffs will call to support Plaintiffs' claims of ongoing and potentially permanent problems and deficits from the December 26, 2005 vehicle accident is essential so that Defendant can prepare to defend the claims against him, and can assess whether any additional defense experts will be necessary in this case, and whether supplemental review by Drs. Kasdan and Pettrick will be necessary to address any new information and/or theories.

41. Plaintiffs, as the parties with the burden of proving a causal relationship between any claimed injuries/conditions and the December 26, 2005 motor vehicle accident, must be required to come forward with reports from any experts to be called at trial so as to apprise

Defendant of those injuries and/or conditions that Plaintiffs can actually support with competent testimony at trial.

42. Particularly in light of the nature of Cheyanne's claimed injuries, and the conflicting and speculative opinions in the reports produced to date, Defendant cannot meaningfully assess the extent of any further expert evaluation as may be necessary to a proper defense until Plaintiffs provide expert reports identifying those injuries/conditions for which Plaintiffs can meet their *prima facie* burden of proof.

43. Until such time as Plaintiffs have identified the witnesses to be called to support the claimed injuries and damages at trial, and have produced reports of any such experts, Defendant will be virtually forestalled in completing trial preparation and moving ahead toward resolution of this case, or even determining whether a trial listing is appropriate.

44. Accordingly, pursuant to Pennsylvania Rule of Civil Procedure 4003.5, 4007.4, and 4019, Defendant hereby respectfully requests that his Motion to Compel Expert Discovery be granted, and that Plaintiffs be required to identify all physician(s), counselor(s), or other expert(s) to be called by Plaintiffs at the trial of this case, and to provide report(s) from any such expert(s), within 30 days from the date of the Order.



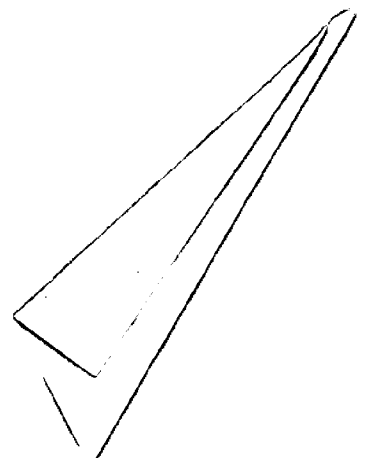

As you know, she is a 13-year-old female who was an unrestrained front seat passenger in motor vehicle accident with partial rollover on 12/26/05. 
Neurologic: Ms. Hahn is awake, alert and oriented x 3. Her pupils are equal, round and reactive to light. Cranial nerves 2 through 12 were sequentially tested and found to be within normal limits. Her speech is clear and fluent. She has 5/5 strength throughout the upper and lower extremities with normal light touch and pin prick sensation. Deep tendon reflexes are 2+ and symmetric. Toes are down going bilaterally. There is no clonus. There is no drift.

Radiographic Studies: I reviewed the head CT dated 1/10/06 and compared this with the head CT dated 12/29/05 which revealed a resolved right temporal lobe contusion.

Recommendations: Ms. Hahn has radiographic evidence of a resolved right temporal lobe contusion. She is not allowed to participate in any gym classes for the next month. Currently, no bicycling or skateboarding is allowed during that period. I have asked the patient and her parents to call our office in one month to update us on her progress. If she has had no problems in this month, at that time, she may be released back to participating in gym.





Per your request for neuropsychological consultation, I completed a clinical interview with Cheyanne Hahn and her mother, Ms. Lorraine Hahn, on March 16, 2007 and followed up with the following procedures that same date: Luria-Nebraska Neuropsychological Battery, Children's Version (LNNB-C), Visual and Motor Scale items; Speech Sounds Perception Test (SSPT); Seashore Rhythm Test (SRT); Trail Making Test (TMT); Neurobehavioral Cognitive Status Examination, Auditory Comprehension and Oral Repetition subtests; Boston Naming Test (BNT); Controlled Oral Word Association Test (COWAT); Rey Auditory-Verbal Learning Test (RAVLT); Children's Memory Scale (CMS), Stories and Family Picture subtests; Rey-Osterrieth Complex Figure Test (ROCF); Wechsler Intelligence Scale For Children - IV (WISC-IV), Coding, Symbol Search, Digit Span, Letter-Number Sequencing, Vocabulary, Similarities, Comprehension, Picture Concepts, Matrix Reasoning, and Block Design subtests; Wide Range Achievement Test - 3 (WRAT-3); Children's Category Test (CCT); Beck Youth Inventories (BYI).

The purpose of this evaluation was to delineate Cheyanne's cognitive and behavioral strengths and weaknesses, functional implications of the same, and recommendations for treatment (including academic interventions) secondary to a closed head injury.

BACKGROUND INFORMATION:

Cheyanne is a 14-year-old, right-hand dominant female who sustained a traumatic brain injury on December 26, 2005 when the automobile that she was a passenger in was involved in a partial rollover accident. She was not wearing a seatbelt at the time. Cheyanne was evaluated at the Altoona campus of Altoona Regional Health System where a CT-scan revealed evidence of a "small right temporal contusion". She remained hospitalized for three to four days before being discharged with no

recommendation for follow-up rehabilitation.

Cheyanne's medical history was otherwise unremarkable and free of any other neurological disorders or symptoms, including prior blows to the head. There no psychiatric or substance abuse histories.

Cheyanne was an 8th grade student in the West Branch Area School District at the time of her accident. She had no grade repetitions or special education involvement. She is currently a 9th grade student in the same school district. Cheyanne continues to report headaches that were not present prior to her December of 2005 accident, as well as periodic dizziness. Cognitively, she has experienced "confusion" as she has gone from her home to a friend's home, and vice versa, but has never gotten so disoriented or lost to the degree that she was unable to reach her destination. Cheyanne will also forget conversations that she has had with others, will experience easy distractibility while in classroom settings, has had difficulty completing class examinations, and doesn't always write coherent or complete class notes. Her academic averages the first and second nine-week marking period were 88.2% both times. Emotionally, Cheyanne also noted increased "moodiness" and "depression", and was recently prescribed an unknown antidepressant. Within this same context, Cheyanne stated that she has engaged in subtle self-mutilation (cutting) and has had suicidal thoughts without any intentions or plans of acting on these ideations.

Cheyanne and her parents are divorced. She reported having a "good, normal" relationship with her mother, with whom she resides, but acknowledged having difficulty "getting along" with her father, who is undependable and prone to break promises and "change his mind". In discussing her future, Cheyanne stated that she plans on attending college following high school. She is currently interested in possibly studying Criminal Justice.

BEHAVIORAL OBSERVATIONS:

Cheyanne was on time for her evaluation session, accompanied by her mother who was responsible for his transportation. She was appropriately dressed for the weather and neatly groomed, alert and oriented in all spheres, and fully cooperative with the evaluation process. Although initially only responsive to my questions, as the evaluation progressed and she became more relaxed, Cheyanne became more spontaneous. Her affect was generally stable, except for a brief period when she began to tear up while discussing her depression and mood swings. Her affect also reflected at least a mild decrease in range and intensity that would be consistent with a depressive process. There was no evidence of gross distraction during the evaluation. Cheyanne also demonstrated no lower or upper extremities and was capable of

completing manual-dependent tasks. Her vision and hearing were within functional limits. Her speech was articulate and characterized by a normal amplitude and a constant rate of speed.

TEST RESULTS:

Age, gender, and/or education corrected normative values were used to compare Cheyanne's test performance against estimated premorbid abilities. Her test scores are summarized in the attached addendum.

Sensory-Perceptual, Spatial-Constructional and Motor Functions. Cheyanne demonstrated no apparent visual or auditory limitations when presented with stimuli requiring primary sensory-perceptual processing and secondary sensory-perceptual integration.

Simple and more complex visuo-perceptual and visuospatial organization, conceptualization, and reasoning were appropriate. Cheyanne's constructional abilities were borderline compromised for an object assembly task but within expected limits for a graphomotor task.

Cheyanne's manual strength was within expected limits as were her results on screening measures designed to assess unimanual sequencing and bimanual coordination, motor planning and execution (praxis), and the ability to regulate simple motor actions in response to equally simple oral commands.

Attention, Concentration and Mental Tracking. Cheyanne experienced mild difficulty when required to attend to, register and immediately recall auditory stimuli. She had an equal degree of difficulty with both the passive storing and the active processing of this information. Cheyanne also demonstrated borderline difficulty on a more sustained measure of auditory attention that involved verbal stimuli. On a similar measure of auditory attention that required more rapid processing of nonverbal stimuli, Cheyanne had a mild to moderate degree of difficulty.

Cheyanne's psychomotor processing speed was within expected limits. So too was her basic visuomotor attention, scanning and sequencing. On a similar visuomotor measure that required her to mentally shift and alternate attention between equally demanding cognitive tasks, Cheyanne had borderline difficulty; she needed to work at a slower rate to avoid making an error (as she did when presented with a sample trial immediately prior to the actual administration of this task).

New Learning and Memory. Cheyanne's ability to encode, retain and retrieve

auditory-verbal information was below expectations. On an unstructured, 15-item word list presented five consecutive times, Cheyanne demonstrated a positive but slow-to-develop learning curve that reflected an overall learning efficiency that was borderline compromised. Her recalls for this same word list immediately following both the presentation of an interference task (another but similar 15-item word list), and a delay of approximately 25 to 35 minutes, were mildly impaired. On a more structured, prose task involving the presentation of paragraph-length material, Cheyanne's initial learning was mildly impaired but her 25 to 35 minute delayed recall was within expected limits.

Cheyanne's ability to encode, retain and retrieve visual-nonverbal information was also below expectations. On a "concrete" task involving the presentation of four separate pictures of individuals engaged in various activities, each picture exposed for only 10 seconds, Cheyanne's initial learning was borderline compromised. Her delayed free recall for these same pictures 25 to 35 minutes following their initial presentation was equally compromised. Cheyanne had more difficulty on a more "abstract" task that first required the pencil-and-paper reproduction of a complex, two-dimensional pattern with the stimulus figure present and then immediately following the removal of her drawing and this stimulus figure. Moderate to severe difficulty was evident during both the immediate recall phase and following a delay of 25 to 35 minutes.

Language and Communication. Cheyanne's auditory comprehension of simple and complex language, oral repetition, and expressive vocabulary level were within expected limits. Despite this, her confrontation naming for pictorial representations of objects was borderline impaired, with more mild impairment noted on a measure of phonemic (e.g., word) verbal fluency.

Conceptual Reasoning and Executive Abilities. Cheyanne's verbal abstract reasoning was within expected limits as was her nonverbal abstract reasoning, conceptual formation and cognitive flexibility. Cheyanne also demonstrated good social judgment and reasoning.

General Intelligence and Academic Skills. Cheyanne's estimated auditory-verbal and visual-nonverbal intellectual abilities clearly fell within the Average classification range, with a slightly significant (.15), 8-point difference, in favor of the former. Measures of academic achievement that assessed Cheyanne's word recognition and word attack skills, spelling, and written arithmetic (without the use of a calculator) were below expectations and approximated a functional level equivalent to that of the average 5th to 6th grade student. These findings were also inconsistent with her grades during her current academic year. When permitted the use of a calculator to complete the same mathematical operations, Cheyanne's score significantly improved,

minimally consistent with her current academic standing.

Emotional and Behavioral Status. Cheyanne's result on a screening measure of depression and anxiety, minimally revealed a mild degree of both depression and anxiety.

CLINICAL IMPRESSIONS:

The results of this evaluation revealed a number of problem areas, both cognitive and emotional-behavioral. These would primarily include borderline to mild difficulty with visual confrontation naming and phonemic verbal fluency, attention and information processing, and new learning and memory. Her reading, spelling and arithmetic results on a screening measure of academic achievement were also lower than expected but inconsistent with her grades the first and second nine weeks of her freshman year. Emotionally, Cheyanne is also experiencing a moderate degree of depression and anxiety, as well as cutting behavior. These collective problems, in my professional opinion, were not present prior to Cheyanne's closed head injury.

DIAGNOSIS:

Per the Fourth Edition of the Diagnostic and Statistical Manual of Mental Disorders and the Ninth Edition of the International Classification of Diseases (ICD-9), the following diagnoses are appropriate at this time:

- Axis I = Cognitive Disorder Not Otherwise Specified (294.9), secondary to Axis III; Major Depressive Disorder, Single Episode, Moderate (296.22); Anxiety Disorder Not Otherwise Specified (300.00).
- Axis II = No Diagnosis (V71.09) at this time.
- Axis III = Mild Traumatic Brain Injury (850.9), sustained 12/26/05.

RECOMMENDATIONS:

1. Cheyanne needs to continue with all medical interventions prescribed by those physicians who remain involved in her care. This would specifically include the continued use of her recently prescribed antidepressant medication or other psychotropic medication regime to ensure emotional and behavioral stability. I also question if a psychostimulant medication may be appropriate on a trial basis to assess its effectiveness, if any, on Cheyanne's attentional matrix.
2. I would strongly recommend, especially given her cutting behavior and suicidal ideation, that Cheyanne also involve herself in individual counseling.

3. Within school, Cheyanne should have the opportunity to take class examinations in quieter settings, should be permitted extra time to complete such examinations, should be provided with lecture notes or study outlines to ensure that the material that she is studying is appropriate and complete. Cheyanne should also be permitted the use of a calculator to complete mathematical calculations.

4. A copy of this report is being provided to Cheyanne's mother so that she may share it with school personnel, who ultimately have the responsibility for improving the academic accommodations recommended above. They may also wish to complete more comprehensive academic testing to determine if the results that I obtained are truly an accurate representation of her current standing.

5. Given that she is still within the 24-month recovery period expected for traumatic brain injury, Cheyanne should be re-evaluated in 6 months to compare results against the baseline neuropsychological data that is now available for this purpose.

6. Some during her junior year of high school, Cheyanne should be referred for an evaluation by the Office of Vocational Rehabilitation, who may be able to assist Cheyanne in obtaining funding for a higher education and, if still necessary, academic accommodations.

I completed a clinical interview with Cheyanne Hahn and her mother, Ms. Lorraine Hahn, on April 10, 2008, and followed up with the administration of the following tests that same day: Luria-Nebraska Neuropsychological Battery, Children's Version (LNNB-C), Visual and Motor Scale items; Speech Sounds Perception Test (SSPT); Seashore Rhythm Test (SRT); Trail Making Test (TMT); Neurobehavioral Cognitive Status Examination, Auditory Comprehension and Oral Repetition subtests; Boston Naming Test (BNT); Controlled Oral Word Association Test (COWAT); Rey Auditory-Verbal Learning Test (RAVLT); Wechsler Memory Scale - III (WMS-III), Logical Memory and Family Picture subtests; Rey-Osterrieth Complex Figure Test (ROCF); Wechsler Intelligence Scale For Children - IV (WISC-IV), Coding, Symbol Search, Digit Span, Letter-Number Sequencing, Vocabulary, Similarities, Comprehension, Picture Concepts, Matrix Reasoning, and Block Design subtests; Wide Range Achievement Test - 3 (WRAT-3), Reading, Spelling and Arithmetic subtests; Children's Category Test (CCT); Brown Attention Deficits Disorder Scale (BADDs).

The purpose of this evaluation was to compare Cheyanne's current cognitive and behavioral status against baseline data that was obtained when I first assessed her on March 16, 2007.

BACKGROUND INFORMATION: Cheyanne is a now 15-year-old, right-hand dominant female who sustained a traumatic brain injury on December 26, 2005 when the automobile that she was a passenger in was involved in a partial rollover accident. Additional information regarding that accident and the treatment that she received can be found in the initial neuropsychological evaluation, dated March 30, 2007.

At the time of her injury, Cheyanne was an 8th grade student in the West Branch Area School District. She is now a 10th grade student in that same school district.

Since my last contact with her, Cheyanne reported a full resolution of the headaches and periodic dizziness that were not present prior to her December of 2005 accident. Cognitively, however, she continues to experience "confusion" that prevents her from following class/subject directions in general and mathematics specifically. She equally remains easily distracted in class, especially large classes (currently biology and algebra) where others are talking, tapping or dropping pencils, and so on. She also experiences anxiety during class examinations, "pressured" to not be the last one to complete testing. Her academic averages the first and second nine-week marking period were 87% and 85.6%, respectively. Cheyanne also remains "moody" but denied depression and more specific self-mutilation (cutting) and suicidal thoughts.

Cheyanne is currently taking Citalopram (40mg per day) for depression and initiated individual counseling approximately one month ago at Cen-Clear Child Services, Inc. Such counseling takes place every two weeks. From a more cognitive perspective, Cheyanne was recently prescribed the Exelon Patch (4.6mg per 24 hours). She was previously prescribed Aricept (5mg per day) but this was discontinued secondary to sleep disturbance. Since my last contact with Cheyanne, she was involved in a dirt bike accident the Fall of 2007 but denied hitting her head; she also denied any additional blows to the head since December of 2005, seizure activity or other neurological issues. She denied any substance abuse.

Cheyanne continues to reside with her mother, with whom she reported a "normal" teenager-mother relationship. As before, she acknowledged ongoing difficulty "getting along" with her father, who is undependable, prone to break promises, and "uncaring" secondary to believing that "nothing is wrong" with her. In discussing her future, Cheyanne stated that she would like to become a paramedic following high school so that she can "help people".

BEHAVIORAL OBSERVATIONS: Cheyanne was on time for her evaluation session, accompanied by her mother who was responsible for her transportation. She was appropriately dressed for the weather and neatly groomed, alert and oriented in all spheres, and fully cooperative with the evaluation process. Cheyanne fully cooperated with the evaluation process by responding to questions and engaging in spontaneous conversation, and putting forth her best effort on the testing that was presented. Her affect was stable. Compared to my last contact with her when she began to tear up while discussing her mood swings, Cheyanne demonstrated no lability. Cheyanne remained capable of completing manual-dependent tasks. Her vision, hearing and speech were functionally intact.

TEST RESULTS: Age, gender, and/or education corrected normative values were used to compare Cheyanne's test performance against estimated premorbid abilities. Her test scores are summarized in the attached addendum.

Sensory-Perceptual, Spatial-Constructional and Motor Functions

Cheyanne demonstrated no apparent visual or auditory limitations when presented with stimuli requiring primary sensory-perceptual processing and secondary sensory-perceptual integration.

Simple and more complex visuoperceptual and visuospatial organization, conceptualization, and reasoning were appropriate. Cheyanne's constructional ability for an object assembly task remained borderline compromised but was within expected limits for a graphomotor task.

Cheyanne's manual strength was within expected limits as were her results on screening measures designed to assess unimanual sequencing and bimanual coordination, motor planning and execution (praxis), and the ability to regulate simple motor actions in response to equally simple oral commands.

Attention, Concentration and Mental Tracking

Cheyanne experienced borderline to mild difficulty when required to attend to, register and immediately recall auditory stimuli, demonstrating an equal degree of difficulty with both the passive storing and the active processing of this information. Cheyanne did well on a sustained measure of auditory attention that involved verbal stimuli but, consistent with her initial evaluation, still had mild to moderate difficulty on a similar measure of auditory attention that required more rapid processing of nonverbal stimuli.

Cheyanne's psychomotor processing speed was within expected limits. So too was her basic visuomotor attention, scanning and sequencing. On a similar visuomotor measure that required her to mentally shift and alternate attention between equally demanding cognitive tasks, Cheyanne had borderline difficulty; she produced no errors but her response speed was below normative expectations.

New Learning and Memory

Cheyanne's ability to encode, retain and retrieve auditory-verbal information was within expected limits except for mild difficulty on the initial trial of an unstructured, 15-item word list presented five consecutive times. Her overall learning efficiency and recalls this same word list immediately following both an interference task (another but

similar 15-item word list), and a delay of approximately 25 to 35 minutes, were within expected limits. Cheyanne did equally well on a structured, prose task involving the presentation of paragraph-length material.

Cheyanne's ability to encode, retain and retrieve visual-nonverbal information was also better and grossly within expected limits.

Language and Communication

Cheyanne's auditory comprehension, oral repetition, and expressive vocabulary level were within expected limits. Her confrontation naming for pictorial representations of objects, however, remained borderline impaired, with mild impairment noted on a measure of phonemic (e.g., word) verbal fluency.

Conceptual Reasoning and Executive Abilities

Cheyanne's verbal abstract reasoning was within expected limits as was her nonverbal abstract reasoning, conceptual formation and cognitive flexibility. Cheyanne also demonstrated good social judgment and reasoning.

General Intelligence and Academic Skills

Cheyanne's estimated auditory-verbal and visual-nonverbal intellectual abilities fell within the central limits of the Average to the lowest limit of the High Average classification ranges, with a 16-point difference, in favor of the former.

Measures of academic achievement that assessed Cheyanne's word recognition and word attack skills, spelling, and written arithmetic (without the use of a calculator) were below expectations and approximated a functional level equivalent to that of the average 7th to 8th grade student. When permitted the use of a calculator to complete the same mathematical operations, Cheyanne's score significantly improved, consistent with her current academic standing.

Emotional and Behavioral Status

Cheyanne's results on a screening measure of attention deficit disorder symptomology inferred the presence of attention and memory problems.

CLINICAL IMPRESSIONS: The results of this evaluation revealed improvement in Cheyanne's ability to learn and retain new information, although her auditory attention and information processing, and visual confrontation naming and phonemic verbal



Per your request, I am submitting a narrative report regarding Ms. Cheyanne Hahn, a now 16-year-old (DOB: 07/25/92), right-hand dominant female whom I have seen on two separate occasions to complete neuropsychological evaluations. These evaluations, completed March 16, 2007 and April 10, 2008, were ordered by Joseph Clark, M.D., a neurologist in Altoona, Pennsylvania. I will structure this narrative report according to the specific questions that you presented, namely, "Cheyanne's (a) injuries, (b) causation thereof, (c) diagnosis, (d) treatments to date, (e) prognosis, (f) reasonably anticipated future medical needs related to her injuries from this accident, and (g) any limitations on Cheyanne related to her injuries".

INJURIES and ONGOING LIMITATIONS RELATED TO INJURIES: Cheyanne sustained a traumatic brain injury that was responsible for a number of physical, cognitive and emotional-behavioral injuries.

As of my last contact with her on April 10, 2008, Cheyanne reported a full resolution of the headaches and periodic dizziness that were not present prior to her December of 2005 accident. Cognitively, however, she was continuing to experience "confusion" that prevented her from following class/subject directions in general and mathematics specifically. She equally remained easily distracted in class, especially large classes (currently biology and algebra) where others are talking, tapping or dropping pencils, and so on. Follow-up neuropsychological testing, which validated continued impairment in her auditory attention and information processing, correlated with Cheyanne's subjective complaints. From an emotional-behavioral perspective, Cheyanne was experiencing anxiety during class examinations, "pressured" to not be the last one to complete testing. She also remained "moody" but believed that she was less depressed. She also denied any self-mutilation (cutting) or suicidal thoughts.

CAUSE THEREOF: The aforementioned difficulties are the direct or the indirect result of the traumatic brain injury that Cheyanne sustained on December 26, 2005 when the automobile that she was a passenger in was involved in a partial rollover accident. Indeed, prior to this motor vehicle accident, Cheyanne was demonstrating none of these difficulties and, from a functional perspective, was doing well in school.

The direct injury would be Cheyanne's diagnosed traumatic brain injury. The indirect injuries would be more symptomatic and include, from a cognitive perspective, the "confusion" that prevents her from following class/subject directions in general and mathematics specifically, as well as neuropsychological test findings that continue to validate the existence of impairment in her auditory attention and information processing. An additional indirect result of her injury is Cheyanne's emotional-behavioral presentation. She is fully cognizant of the fact that she is now struggling more in school to achieve academic success. It is this struggling that is now responsible for her anxiety during class examinations and her ongoing "moodiness" (depression).

DIAGNOSIS: As of my last contact with her on April 10, 2008, per the Fourth Edition of the Diagnostic and Statistical Manual of Mental Disorders and the Ninth Edition of the International Classification of Diseases, the following diagnoses were judged to be most appropriate for Cheyanne:

- Axis I = Cognitive Disorder Not Otherwise Specified (294.9), secondary to
Axis III; Major Depressive Disorder, Single Episode, Moderate (296.22)
+ Anxiety Disorder Not Otherwise Specified (300.00).
- Axis II = No Diagnosis (V71.09) at this time.
- Axis III = Mild Traumatic Brain Injury (850.9), sustained 12/26/05.

TREATMENTS TO DATE: I completed two neuropsychological evaluations but have not been directly involved in any treatment with Cheyanne. She has, however, continued treatment with Dr. Clark that has included the monitoring of both antidepressant and cognitive enhancing medications. Per my last contact with her, Cheyanne also remained involved in individual counseling with Cen-Clear Child Services, Inc., to further address her emotional-behavioral issues.

PROGNOSIS: Given that her traumatic brain injury occurred over two years and three months prior to my last neuropsychological evaluation, I do not believe that Cheyanne will experience any additional spontaneous improvement. She is at the point where any residual physical, cognitive and emotional-behavioral deficits need to be symptomatically treated.

FUTURE NEEDS: First and foremost, Cheyanne needs to continue with all medical

Specific interventions should include the ongoing use of Citalopram or another antidepressant medication to ensure continued emotional and behavioral stability, as well as Exelon to stabilize and improve her cognitive status.



This is in response to your correspondence, dated 12/16/08.

First, you are correct in assuming that the statement "Follow-up neuropsychological testing, which validated continued impairment in her auditory retention and information processing, correlated with Cheyanne's subjective complaints" is an objective finding primarily based on (a) the Working Memory Index from the Wechsler Intelligent Scale for Children and the two subtests [Digit Span and Arithmetic] comprising this Index, (b) the Seashore Rhythm Test, and (c) the initial learning trial of the Rey Auditory Verbal Learning Test. These scores reflected borderline to mild compromise when compared against normative samples similar to Cheyanne in chronological age at the time this testing was administered.

Second, with respect to the issue of (a) previous sexual assault, (b) experimental street drug use, (c) adolescence, (d) sexual orientation, and/or (e) anger brought on by her parents separation and father's subsequent remarriage playing a role in Cheyanne's cognitive, emotional and/or behavioral difficulties, any of these issues could, indeed, be possible factors. These same issues, alone or in any combination, could equally account for the obtained test scores noted in the prior paragraph, especially given the fact that these scores reflected no more than borderline to mild compromise.


Any factor or situation that can cause stress, anxiety or depression can negatively impact such cognitive processes as attention and concentration, motor and cognitive processing speed, and new learning and memory. There is, unfortunately, no way to definitively clarify what may or may not be due to a traumatic brain injury versus what may or may not be due to the above, more psychological issues.

My narrative concerns Ms. Cheyanne Hahn. I saw Ms. Hahn in my Neurology Clinic for the first time January 23, 2007. The patient, at that point, was a 14-year-old right-handed female who was having blackout spells, headaches, memory loss, and dizziness. She was having these spells so they were actually lost time episodes and no loss of consciousness. The patient states she had headaches over her whole head again several times a week. Motrin was helping but she could not take it every day. She also had dizziness with a spinning sensation in her head feeling like she could fall over and this happened several times a week. She also describes short-term memory loss, forgetting things that she was told, forgetting who she had seen in the past. She relates all this back to a motor vehicle accident in 2005 when she struck her head, all of these have been since then. The patient did have a right temporal contusion at the time and was cared for by Dr. Burke; no surgery was required. Therefore, the patient was evaluated in my Clinic for the other symptoms she was having.

I follow her at this time because of her symptomatology that she had, post-concussive syndrome. At that point, I took the liberty of ordering a CT of her head. I did not do an MRI as the patient had braces, and this would cause too much artifact, an EEG and neuropsychological testing, and I treated the patient with Pamelor 10mg at bedtime for the headaches and for the dizziness. The patient had a CT scan of her head completed, which showed an essentially normal study with resolution of the area of hematoma. The patient also had an electroencephalogram done, which was normal.

The patient was seen by Dr. Wayne D'Agaro, a neuropsychologist, for neuropsychological testing. His results showed a diagnosis of cognitive disorder

not otherwise specified secondary to major depressive disorder, anxiety disorder, and traumatic brain injury.

The patient was next seen by me on May 10, 2007. At that point, the findings of the neuropsychological testing were explained to the patient showing there was a great deal of depression causing most of her current symptomatology, although again this all stemmed back to the motor vehicle accident. She was having side effects of the Pamelor that was stopped and Lexapro was added, 10mg by mouth q day.

The patient was seen back next on September 27, 2007. We could not get insurance to pay for the Lexapro so I gave her a trial of Celexa which is a generic family member of Lexapro. The patient was started on 20mg and was feeling sleepy, therefore, she decreased to 10mg.

She was next seen on January 10, 2008. She was tolerating the Celexa at 10mg a day, and her headaches seemed to be better at that point. The patient, at that point, was started on Aricept due to the memory loss.

She was next seen on April 10, 2008. The Aricept was stopped due to the drowsiness. She was having more trouble with school since stopping it, and her Celexa was increased back to 20mg and then 40mg a day. Because the patient has stopped the Aricept, she was started on an Exelon patch.

The patient had a follow up with Dr. D'Agaro on April 10, 2008, and basically, he reiterated the diagnoses as before. Further elaboration should be gleaned from Dr. D'Agaro.

So my final diagnosis of this patient is post-concussive syndrome sustained due to a motor vehicle accident on December 26, 2005. I believe at this point all her symptomatology is related back to that accident to include the depressive-type symptoms.

I had the pleasure to see your patient, Cheyanne, a 16-year-old right-handed Caucasian female for evaluation of numerous complaints including memory loss, depression, and severe headaches. She is here today with her mother who reported to me that child was in motor vehicle accident on December 26, 2005. At that time, according to the mother, she suffered traumatic brain injury and was in Intensive Care in Altoona Hospital for three days. She was unconscious for an undetermined period of time. Accident happened at 5:30, she arrived to the hospital at 6:30 and had zero recollection of the accident including amnesia regarding the fact that the roof was cut off of the truck. She also did not recall ambulance ride either. Mother reports to me that the patient had some degree of temporal bleeding, but I do not have any formal medical records to review at the present time. Since that time, mom reports that depression and memory loss have not been improving despite of the medications. Also, she had some headaches during the time of the accident that subsequently subsided but in the last four months she had severe headaches. They are usually not preceded by any aura. They are associated with photosensitivity and photosensitivity, nausea and occasional vomiting, describing as 8/10, lasting for few hours and up to a week, once or twice per week. IMPRESSION

Cheyenne is a 16-year-old right-handed white female with previous history of motor vehicle accident and reported traumatic brain injury with prolonged, postconcussive syndrome, present itself with depression, memory problems. She also has migraine headaches, and it is impossible to determine if it is related to the traumatic brain injury as they started almost four years after the accident although child did have some headaches during the time of the injury.

We discussed in details nonmedical preventive measures for the migraine headaches including a regular sleep-awake cycle, regular food intake, avoiding overheating, dehydration and food triggers such as monosodium glutamate, artificial sweeteners, nitrates, processed meat, and strong cheeses. I agree with primary doctor approach of trying Imitrex 100 mg at the onset of the migraine. The mother of the patient was advised against using that medication more than twice a week. Although the child has the medication, she has not tried it yet. Because of the side effect, she can go for some period of time without migraines I would advise that for prophylactic measures of the migraines, she would try to use magnesium supplements but this is not the medication that can be obtained in GNC store, one to two tablets a day for a couple of months would be recommended. In the meantime, I am hoping that we will receive the medical records from Altoona Hospital, and I would be able to review MRI scan as well as EEG reports and all additional reports to determine if further testing will be necessary. Most likely, we will need to obtain MRI scan of the brain to see the consequences of injury as well as obtain an EEG, as mom reports occasional recurrence of the staring episodes. Also, it would be beneficial to obtain an EEG in view of the memory problems to make sure child that does not have subclinical seizures. In addition, Child Developmental Unit evaluation with formal cognitive testing most likely will be also recommended. Mom is to contact us in a couple of days to make sure that we received prior medical records and finalize the future testing plans. Due to the fact that the family is living far away from us, we will try to combine all the testing in the minimal amount of visits. Follow up will be as necessary with Neurology. For the communications and test results, mom is to contact my nurse practitioner, Robyn Neft, 412-692-6484.

I had pleasure to see your patient Cheyanne, 18-year-old right handed Caucasian female for a follow up of her numerous complaints. She was last time in February of 2009. At that time she was evaluated for memory loss, depression, and severe headaches. Mother reported to me that child had been involved in motor vehicle accident in December of 2005.

At that point in time, I diagnosed her with the migraine headache. It was impossible to determine if that was related to the traumatic brain injury as headaches started almost four years later after the accident, although she had some headaches during the time of the injury. Subsequently, we obtained an MRI of the brain to evaluate for possible sequela of the head trauma. That MRI was performed on May 5, 2009 and it was within normal limits without any findings to suggest sequela of trauma. The patient also had an ambulatory three day EEG on November 3, 2009 through November 5, 2009 which was completely within normal limits. Multiple events of headaches recorded during that time without EEG correlation. The patient also had a formal neuropsychological evaluation performed on July 16, 2009 by Dr Hilary Feldman. The results of the evaluation indicated average cognitive abilities with some difficulties with respect to the executive functioning skills. Dr Feldman indicated that these difficulties may be related to residual effects of the motor vehicle accident and head injury. CLINICAL HISTORY:

Severe headaches, memory loss and depression. The patient had head injury in December 2005.

TECHNIQUE:

Sagittal short TR/short TE, axial long TR/short TE and MPGR, axial and coronal long TR/long TE and FLAIR images were obtained. The study is performed without intravenous contrast.

REASON FOR REFERRAL

Cheyenne is a 16-year, 11-year-old white female who was referred for the present neuropsychological evaluation by Dr Inna Vaisleib in the Neurology Department for evaluation of her functioning in order to make a diagnosis and make recommendations. Her mother and Cheyanne both question whether Cheyanne will continue to have to live with behavioral and memory impairments as a result of a motor vehicle accident which occurred in December 2005 when she was 13-1/2 years of age. Cheyanne questions whether she will be able to pursue more independent functioning, including attending college. Her mother questions what is wrong and what she needs to do. Her mother also indicated that she presently has a lawyer and that they are pursuing legal action against Cheyanne's father who was driving a car at the time of the motor vehicle accident.

BACKGROUND INFORMATION

Cheyenne and her mother had no reported concerns prior to the MVA in which she was involved in December 2005. At that time her father was driving a car in inclement weather, lost control, and Cheyanne was unconscious and taken to Altoona Hospital. Cheyanne was not wearing a seat belt at the time of the accident. Her father was not significantly hurt. Cheyanne was reportedly unconscious for at least half an hour. She stated that she remembered driving in the car with her father and being concerned about the weather prior to the accident. She remembers waking up several times for brief periods while being taken to the hospital and then remembers waking up in the hospital. Cheyanne remained in the NICU for 3-4 days prior to going to a regular room for a short period of time and then being discharged. She had two brain bleeds and the previous report from the neuropsychologist indicated that a CT scan revealed evidence of a "small right temporal contusion." No specific treatment or rehabilitation was recommended at the time of discharge. She was referred to Dr. Clark, a neurologist in the family's local area, who has continued to follow her. Initially, Cheyanne had no significant problems that were noted and she returned to school as scheduled after the winter holiday. Her mother stated that school staff were not aware of the accident. In April-May 2006, Cheyanne started to complain that she didn't remember how she got from one place to another which resulted in Cheyanne's being referred for further evaluation. At approximately this time, her grades started to drop and one of her teachers reported to her mother that he saw a change in Cheyanne's behavior. Dr. Clark subsequently referred Cheyanne for neuropsychological assessment by Dr. D'Agora in the family's local area who saw her on two occasions in March 2007 and April 2008. Dr. D'Agora did find some deficits with respect to

memory and did recommend that some modifications be made within the school setting. (Please see the next section headed "Previous Evaluation" for more detailed information.) The report was reportedly given to the school, but no IEP was obtained until March 2009.

Cheyenne reportedly was able to maintain average grades between 7th and 9th grades, although her performance was not as good as it had been prior to her MVA with her grades dropping from As and Bs to Bs and Cs. There was a marked deterioration in her skills and behavior in 10th grade at which time she had increased frustration. Cheyanne has complained of memory loss. She was noted to have "confusion" initially after the MVA, but this has subsided. During the past academic year, in 11th grade, Cheyanne went to a vo tech program where she took academic classes at the high school for one-half of the day and she attended vo tech classes for the other half of the day. She also obtained an IEP in the spring of this year. She reportedly did well in her vo tech program where she took courses in health occupations and she obtained a 4.0 grade point average. She obtained poor grades in her regular subjects in school and failed math. However, since she has an IEP, she did pass 11th grade and will be a senior for the next academic year.

Behaviorally, Cheyanne has had most difficulty with respect to emotional lability with her becoming easily frustrated and acting out behaviorally. Her mother states that she "panics and cannot express her emotions as she used to." Prior to the time of the MVA, Mrs. Hahn stated that the only behavioral concerns were that Cheyanne would want to hug teachers. Over the past several years, Cheyanne has displayed behavioral difficulties. In 10th grade, she became angry with peers at school and stated that she was going to go home, get a gun, and kill everyone. She also got into trouble for arguing with a bus driver. She previously was a social youngster, but now has fewer friends and often prefers to stay at home and sleep. Cheyanne was referred to the local counseling center in April 2008 and she has obtained counseling services since this time. Services have been provided both at school and in the counseling center. She is presently being seen on a biweekly basis and sessions occur individually with Cheyanne and her mother as well as jointly with both Cheyanne and her mother. Cheyanne previously had a history of depression resulting in self mutilation (cutting), but this is not reportedly occurring at the present time. She has had a history of suicidal ideation and two previous suicidal attempts which she has told her mother about well after the events. She stated that approximately two years ago she sat down in middle of a road waiting for a car to hit her which she disclosed to her mother shortly after another youngster, several years younger than Cheyanne, apparently died as a result of the same behavior. Cheyanne also indicated that she had taken a handful of pills previously, but her mother was not aware of this until well after the time that it occurred and she apparently did not require any medical treatment. Due to depressive symptoms, Cheyanne has been prescribed Celexa (20 mg. tid) by her neurologist which has been helpful in alleviating symptoms of major depression and suicidal ideation. She also had been previously prescribed Aricept and the Exelon patch due to memory loss, but these were discontinued due to negative side effects.

Other emotional and behavioral concerns include attentional problems, distractibility, difficulty starting and completing tasks, and difficulty with sustained attention. Cheyanne complains of continual mood swings and nervousness, as well as depression, excessive sleeping, and concerns about her future. She often feels keyed up and panicky. She tries hard not to act on impulses when frustrated; for instance, she came to the appointment with an ambulatory EEG and verbalized that she felt like taking it off or throwing it. She is very impulsive and will blurt out many things that come to her mind. Cheyanne does have a driver's permit, but her mother does not want her to obtain her license and drive independently due to concerns about her judgment, lack of concentration, and impulsive behavior. However, she reportedly is able to drive a motorcycle when she visits her father.

Cheyenne has a history of migraine headaches which reportedly have become increasingly severe. She was seen by Dr. Vaisleib in the Neurology Department at Children's Hospital in February 2009 and was prescribed Imitrex as well as magnesium supplements. Cheyanne complained that Imitrex made her feel ill so she is not using this medication. She continues to complain of migraines on an intermittent basis. She did complain of one at the time of the current evaluation which she related to her having an ambulatory EEG for the past several days which was bothering her. Her mother stated that she had previously had a migraine approximately one month ago which may have been related to stress, when there was legal action taken against her father.

There have been significant psychosocial stresses. Cheyanne's father reportedly was emotionally abusive to Cheyanne and her mother with him belittling them and calling both Cheyanne and her mother names and swearing. He reportedly has significant difficulty with anger control and has smashed objects, including glass objects. Cheyanne's mother denied any concerns about physical or sexual maltreatment toward Cheyanne. When asked, Cheyanne also denied physical or sexual maltreatment by her father. Her mother endorsed one incident of domestic violence. Cheyanne was reportedly sexually molested on an ongoing basis by her friend's older brother who is 3 years older than Cheyanne when Cheyanne was 10-13 years of age. This information was disclosed during the evaluation with Dr. D'Agara and there are presently legal proceedings with a hearing occurring on August 26, 2009. Cheyanne's mother was not aware of any behavioral changes at the time that the maltreatment was occurring. Cheyanne denied any other history of sexually inappropriate behavior toward her. When questioned, Cheyanne presently endorsed some alcohol usage and stated that she had previously gotten drunk on one occasion. She also endorsed smoking marijuana in the past. Cheyanne does smoke cigarettes, particularly during the summer, with her smoking approximately 1 1/2 packs a day. In terms of sexuality, Cheyanne states that she is gay and she has had a relationship with another female.

PREVIOUS EVALUATIONS

Cheyanne had been previously evaluated by Dr Wayne D'Agara, a neuropsychologist in the family's local area. She was first evaluated in March 2007 based on referral by her neurologist, Dr Clark, for a neuropsychological consultation in order to clarify her functioning after the motor vehicle accident in December 2005. At that time she was found to meet criteria for a diagnosis of Cognitive Disorder NOS secondary to the motor vehicle accident resulting in a mild traumatic brain injury. She was also diagnosed with a Major Depressive Disorder and Anxiety Disorder NOS. The results of the evaluation revealed a number of problem areas cognitively, emotionally, and behaviorally. This included "borderline-to-mild difficulty with visual confrontation naming and phonemic verbal fluency, attention and information processing, and new learning and memory." She was noted to have some weaknesses with respect to her academic achievement. Emotionally, she was described as "experiencing a moderate degree of depression and anxiety." Dr D'Agara stated that "these collective problems, in my professional opinion, were not present prior to Cheyanne's closed head injury." Recommendations were made for follow-up medically, individual counseling, modifications within her school program, sharing the report with the school, and referral during her junior year of high school to the Office of Vocational Rehabilitation. Scores on testing indicated average cognitive abilities with average to above average verbal comprehension and perceptual reasoning skills as well as processing speed skills. She displayed a score within the low average range on tasks measuring working memory skills. Scores on academic testing fell within the low average to the lower end of average range on reading, spelling, and math subtests, although Cheyanne was noted to do much better with arithmetic when she was allowed to use the calculator where she obtained a score within the high average range. Cheyanne obtained scores within the average range on testing of visual and verbal memory, auditory comprehension, and oral reception. She was found to have mild-to-moderate impairments in motor skills, sound perception, verbal learning, visual memory, and word naming.

Cheyanne was seen back for a follow-up appointment by Dr D'Agara in April 2008. At that time the results indicated an "improvement in her ability to learn and retain new information, although her auditory attention and information processing, and visual confrontation naming and phonemic verbal fluency, remain impaired." Intellectually, Cheyanne's auditory/verbal and visual/nonverbal intellectual abilities were consistent with her estimated premorbid ability level. Her reading, spelling, and arithmetic results on the screening measure of academic achievement were also lower than expected, and inconsistent with her grades the first and second nine weeks of her sophomore year. From an emotional-behavioral perspective, Cheyanne was not found to be experiencing depression, anxiety, or cutting behavior. She was diagnosed with Cognitive Disorder Not Otherwise Specified secondary to a mild traumatic brain injury, Major Depressive Disorder, single episode, and Anxiety Disorder Not Otherwise Specified which were considered to be in partial to full remission. Recommendations were for sharing the report with the school, continued medical follow-up, continued individual counseling, continued modifications within the classroom, and referral to the Office of Vocational Rehabilitation.

Cheyenne was evaluated through the school district using the Woodcock-Johnson Test of Achievement-III in March 2009. At that time she obtained scores close to age and grade expectancy on phonemic awareness, spatial relations, concept formation, visual matching, incomplete words, and auditory working memory tasks. She displayed relative weaknesses on math calculation, math fluency, and number reasoning tasks. On the Behavior Assessment System of Children, Second Edition, which was completed by Cheyanne's mother, Cheyanne was reported to have significant difficulties (greater than the 95th percentile) on the following scales: Hyperactivity, Depression, Atypicality, and Attention Problems.

DEVELOPMENTAL AND MEDICAL HISTORY

Cheyenne was the 5-pound, 14-ounce product of a full-term pregnancy. There were no difficulties noted during the pregnancy, labor, or delivery. Her mother stated that developmental milestones were attained well within normal limits and there were no concerns about her functioning. Cheyanne did not attend a specific preschool program and did well when she transitioned into a kindergarten program. Cheyanne obtained average to above average grades with no behavioral concerns until after the time of the motor vehicle accident in December 2005. As previously noted in the background information portion of the report, difficulties were not significantly problematic until Cheyanne's 10th grade year when emotional/behavioral issues became more of a significant concern. However, based on the evaluation by Dr D'Agaro in March 2007 when Cheyanne was 14 years of age, Cheyanne was noted to have some deficits with respect to cognitive skills and was diagnosed with a Cognitive Disorder NOS, as well as a major depressive disorder and an anxiety disorder not otherwise specified.

Cheyenne did well medically until the time of the motor vehicle accident. As previously noted, she was hospitalized for three to four days in the ICU and was found to have a small right temporal contusion on a CT scan. She was followed by Dr Clark, a neurologist in the family's local area, who had prescribed Aricept initially and later also prescribed Celexa due to depression. Aricept was subsequently discontinued due to negative side effects. There has been a history of significant headaches. Cheyanne was subsequently referred to Children's Hospital where she was seen by Dr Inna Vaisleib in the Neurology Department in February 2009 who diagnosed migraine headaches. At that time Dr Vaisleib focused on concerns regarding headaches and prescribed Imitrex as needed as well as magnesium supplements. She also recommended that she obtain an MRI and EEG which were found to be normal. However, at the time of the current evaluation Cheyanne had an ambulatory EEG in order to completely rule out any concerns about seizure activity as there had been a history of some staring episodes.

FAMILY HISTORY

Cheyenne presently lives with her mother. Her parents are divorced and Cheyanne does have some, but inconsistent, involvement with her father. Her parents were separated when Cheyanne was approximately 10 years of age. Cheyanne also has a 30-year-old half-sister who lives independently and is married with a family. Cheyanne's mother reported no family history of developmental, learning, or behavioral/emotional difficulties. However, Cheyanne's mother did report that she has obtained counseling services for herself and that that Cheyanne's father has a history of significant anger management difficulties.

ASSESSMENT OF CHEYANNE

The present evaluation included a review of parent and school questionnaires, an interview with Cheyanne and her mother, as well as observation of Cheyanne in a clinical setting. In addition, the following evaluative tests were administered in order to make a diagnosis, address functional concerns, and make recommendations:

1. Wechsler Abbreviated Scale of Intelligence (WASI)
2. Wechsler Memory Scale-Third Edition
3. Wide Range Assessment of Memory and Learning-Second Edition (Design Memory subtest)
4. Delis-Kaplan Executive Function System (selected subtests)
5. Vanderbilt Parent Assessment Scale, Child Behavior Checklist, Behavior Rating Inventory of Executive

- Function, and Conners' Parent Rating Scale-Revised (completed by mother)
6. Youth Self Report (completed by Cheyanne)

OBSERVATIONS AND TEST BEHAVIOR

Cheyenne was accompanied to the appointment by her mother. A psychology intern also participated in the evaluation. Cheyanne presented as an attractive, well-developed adolescent who appeared to be her chronological age. She was connected to an ambulatory EEG during the present appointment. She was able to transition along with her mother and the examiners. During the initial interview, Cheyanne was verbal and displayed age appropriate speech and language skills and was able to make appropriate eye contact. She endorsed having difficulties learning and remembering school material, as well as emotional difficulties and frequent headaches and migraines. She complained of distress and headache due to her wearing the ambulatory EEG and indicated her desire for to be taken off which was to occur after the present appointment. During the initial interview, she complained about mood changes and appeared labile. Her affect did not match what she was saying and she did not appear sad or unhappy. She complained of difficulty remembering information and often looked to her mother or asked her mother to clarify information, stating that she had "no clue" about some of the things that were asked of her. However, at other times, she was able to be relatively detailed and able to volunteer and elaborate on information. She indicated most concerns about whether she was always going to feel the way that she was feeling presently with memory problems and mood swings and she indicated concerns about whether she would be able to function normally in the future.

During the open-ended interview, Cheyanne continued to indicate concerns about her memory and mood changes. She was verbal and she was oriented to person and place. She did talk quickly, was often dramatic, smiled as she spoke, and did not appear in any distress, even when talking about difficult issues. When asked about priorities regarding having things get better, she indicated that she wanted help with note taking in school and stated that she did best with both hands-on instruction as well as written instruction. She reported that she felt that she was doing better in her vo tech program as there was a "hands-on" approach. She reported that the Celexa seemed to help her depression and she did not have suicidal ideation and had not attempted any other self-harm since being prescribed this medication. She related, however, that she did continue to be concerned about mood changes as she often went from one mood to another with at times feeling bored and at other times feeling that she just wanted to die, although she felt that she would not act on these feelings. She indicated becoming angry easily with her screaming and cursing, and particularly calling her father names. She also reported that she felt very keyed-up, like she could jump out of a window. When questioned, she reported having a pretty good relationship with mother, but often becoming angry and having difficulty getting along with her father. As previously noted, she reported that she does smoke approximately 1 1/2 packs of cigarettes during the summer and less during the school year. She did not report significant substance usage, although she had previously used alcohol and marijuana, but did not believe that this was a significant concern. She reported sexual molestation by her friend's brother, but denied any other history of sexual or physical maltreatment. She denied any current suicidal intent.

Cheyenne stated that she was primarily concerned with her difficulty learning and remembering material at school, especially information presented orally because she worries she may not be able to function in a work environment. She also revealed that she is concerned about her emotional difficulties, noting that she experiences mood swings such that she can feel tired one moment and suddenly feel very energetic or extremely angry. Cheyanne did acknowledge depressive symptoms and wanting to kill herself in the past, but that she has not experienced suicidal intents since starting anti-depressants.

Cheyenne was able to separate along with a psychology intern to begin testing. During the evaluation, she was able to be directed to be seated and perform tasks presented. She presented as a pleasant, compliant adolescent during the evaluation, but was dramatic in her presentation and often commented on how she felt about tasks presented. She was able to articulate her learning and emotional difficulties. During formal testing, Cheyanne was generally attentive to tasks presented and persisted even as items became difficult for her. Although Cheyanne endorsed experiencing a headache at the onset of testing and became hungry and irritable as the evaluation progressed,

Cheyenne continued to participate until the testing was terminated. It is felt that the evaluation is a valid representation of her skills.

BEHAVIORAL REPORTS

Cheyenne's mother completed standardized behavioral rating forms which are measures of children's attentional, emotional, and behavioral difficulties. Scores greater than the 95th percentile are considered to be statistically significant. On the Child Behavior Checklist, Cheyanne was rated above the clinically significant range on the Internalizing Problems (98th percentile) and the Total Problems (95th percentile) composite scales. She was rated above the clinically significant range (at or above the 97th percentile) on the Withdrawn/Depressed, Somatic Complaints, and Attention Problems scales. She was rated above the clinically significant range on the Affective Problems, the Somatic Problems, and the Attention Deficit/Hyperactivity Problems scales on the DSM-Oriented scales for Girls. On the Conners' Parent Rating Scale-Revised, Cheyanne was rated within the clinically significant range (95th percentile) on the Conners' ADHD Index. On the Behavior Rating Inventory of Executive Function, Cheyanne was rated as having significant difficulty within the Metacognitive Index with scores above the clinically significant range (96th percentile) on the Initiate and Working Memory scales, indicating difficulty beginning tasks and being able to manipulate and remember information required for multitasking. She was also rated as having significant difficulties (96th percentile) on the Emotional Control scale. She was also rated above the clinically significant range (96th percentile) on the Global Executive Composite which is a summary score that incorporates all scales of this measure, indicating significant difficulty with executive dysfunction. She was also rated above the clinically significant range (96th percentile) on the Emotional Control scale which measures the individual's ability to modulate emotional responses. On the Vanderbilt Parent Assessment Scale, Cheyanne was rated as having significant difficulties on the ADHD Predominantly Inattention scale. She was also endorsed as having significant difficulties in math but no other significant difficulties with respect to school performance or relationships.

Cheyenne completed the Youth Self Report which is a measure of emotional and behavioral difficulties endorsed by the individual. On this measure, Scores fell within the clinically significant range (95th percentile) on the Attention Problems scale and on the Attention Deficit/Hyperactivity Problems DSM-Oriented Scales for Girls. She was rated below the clinically significant range on all other scales, although some symptoms of anxiety and depression were endorsed.

One of Cheyanne's teachers completed the Vanderbilt Teacher Assessment Scale. On this measure Cheyanne was rated as having significant difficulties on the ADHD Predominantly Inattentive scale, including difficulty focusing and sustaining attention, difficulties completing school work and following through on instructions, difficulty with organization, losing things, forgetfulness, and distractibility. She was also rated as having four of nine symptoms of hyperactivity, including difficulties with hyperactivity, fidgetiness, talking excessively, blurting out answers before questions have been completed, and interrupting or intruding on others. She was also endorsed as having some depressive features, including feeling worthless and blaming herself for problems. She was endorsed as having difficulty in math, but performing within the average range in reading and written expression. She was endorsed as having "problematic" difficulties with assignment completion and organizational skills and that following directions and disrupting the class were "somewhat of a problem". On the narrative report, Cheyanne was described as friendly and strong-willed. She, however, was found to have difficulty handling stress, having relationship issues, and having academic issues.

COGNITIVE SKILLS

The Wechsler Abbreviated Scale of Intelligence was administered. This is a brief measure of verbal and nonverbal cognitive skills. An IQ score of 100 and a T score of 50 denote average performance.

There was a significant discrepancy between scores within the Verbal and Performance areas. Cheyanne displayed a relative strength (with a score within the high average range) within the Verbal area where she particularly excelled on a task measuring abstract verbal reasoning when she was required to tell how two words were the same. She obtained a score within the average range on the vocabulary subtest which is a measure of expressive vocabulary where she was required to define words.

Within the Performance area, there was significant variability among subtest scores which ranged between borderline and the upper end of average. Cheyanne displayed a relative strength (with a score at the upper end of the average range) on the Matrix Reasoning subtest which is a measure of nonverbal problem solving where she was required to complete matrix patterns. She displayed a relative weakness (with a score within the borderline range) on the Block Design subtest which is a measure of visual-motor organization.

VERBAL AND VISUAL MEMORY SKILLS

The Wechsler Memory Scale-Third Edition was administered. This is a measure of both verbal and visual memory skills. A scaled score of 10 and an Index score of 100 denote average performance.

Cheyenne obtained scores which ranged between average and high average within the auditory and visual immediate and delayed memory areas. Within the Auditory Immediate area, Cheyanne obtained a score within the average range. She also obtained a score within the average range within the Auditory Delayed area. She obtained a score within the average range on the Auditory Recognition Delayed area. Within the Visual area, Cheyanne obtained scores within the average to the upper average range with a score within the upper end of the average range within the Visual Immediate area and a score within the high average range within the Visual Delayed area. She obtained a General Memory score within the average range.

The Design Memory subtest of the Wide Range Assessment of Memory and Learning-Second Edition was administered in order to further evaluate abstract visual memory skills. On this measure, Cheyanne obtained a scaled score of 6 (9th percentile) on a subtest where she was required to remember abstract visual designs.

EXECUTIVE FUNCTION SKILLS

Selected subtests of the Delis-Kaplan Executive Function System were administered. A scaled score of 10 denotes average performance.

Cheyenne obtained scores within the average to above average range on the Trail Making test where she was required to sequence numbers and letters, perform a visual scanning task, and perform a motor speed task. She was able to alternate and sequence between numbers and letters rapidly without difficulty. On the Color-Word Interference Test, Cheyanne obtained scores which ranged between deficient and average. She obtained a score within the average range when she was required to read words quickly. She obtained a score within the low average range when she was required to name colors quickly. She obtained a score at the lower end of the low average range on the Inhibition subtest which is a measure of the ability to inhibit verbal responses. She displayed a relative weakness (with a score within the deficient range) on the Inhibition/Switching task which is a measure of cognitive flexibility, indicating difficulties with executive function skills.

On the Twenty Questions Test, Cheyanne obtained a score within the average range with respect to her ability to be abstract initially, but obtained a score within the borderline range with respect to total questions. She was not able to sustain her initial abstract responses and she had difficulty utilizing categorical processing and feedback regarding her responses.

SUMMARY AND RECOMMENDATIONS

Cheyenne is an adolescent who sustained a motor vehicle accident in December 2005 which reportedly resulted in a right temporal contusion. She has had a history of learning, memory, and emotional/behavioral difficulties since the time of the accident and she presently has an IEP, attends counseling services, and is prescribed Celexa. She also has developed migraine headaches since the accident. She was referred for the present evaluation by Dr Inna Vaisleib in the Neurology Department for a neuropsychological evaluation and her mother and Cheyanne wished to understand the nature of her deficits and whether these will be permanent. Cheyanne has complained of significant difficulties with memory, learning, and particularly emotional problems. She is in counseling services and has been diagnosed with a depressive disorder and anxiety related to her head injury. She is presently being prescribed Celexa which has been beneficial to reduce depressive symptoms, but she continues to display significant mood fluctuations. In addition, she complains that learning has been more difficult for her and she is very concerned about her ability to be productive and independent in the future. There have also been significant psychosocial stressors and the family is presently in litigation with respect to both pursuing liability for her father who was driving the car at the time of the motor vehicle accident and a history of previous sexual molestation. Cheyanne has had previous neuropsychological evaluation in 2007 and 2008 as a result of her head injury. Results of the evaluation indicated average cognitive abilities with a relative strength with respect to verbal comprehension skills and a relative weakness with respect to perceptual organization and working memory skills. She also displayed mild weaknesses and deficits with respect to visual memory, motor skills, visual confrontation naming, verbal fluency, attention, and emotional factors. She did do better at the time of the second testing as compared to the time of the first testing with improvements with her mood and behavior, but continued deficits with respect to auditory attention and information processing. She was doing better at the time of the second evaluation appointment with respect to her emotional and behavioral issues. She was diagnosed with Cognitive Disorder NOS secondary to a motor vehicle accident resulting in mild traumatic brain injury, Major Depressive Disorder, Single Episode and Anxiety Disorder NOS, in partial to full remission.

During the present evaluation, Cheyanne displayed a score within the average range on an abbreviated cognitive measure which is consistent with her previous testing. She displayed a relative strength within the verbal reasoning area with a score within the high average range and a relative weakness within the performance area with a score at the lower end of the average range. On testing of verbal and visual memory skills, Cheyanne obtained scores within the average to the above average range with respect to both verbal and visual memory skills, particularly when information was presented in story form or with repetition. She also displayed scores within the average to above average range with respect to remembering faces and elements of pictures. She displayed a relative weakness (with a score at the lower end of the low average range) on an abstract visual memory subtest.

Cheyenne displayed most significant difficulties with respect to executive functioning skills. It is felt that executive dysfunction is significantly negatively impacting on her performance at the present time. Recommendations are for continued therapy services. In addition, recommendations are for medication to be further evaluated by a psychiatrist to determine if she is on the right dosage and whether any additional medication to address attention and mood changes would be beneficial for her. It was discussed with Cheyanne and her mother that some of these difficulties that she has experiencing may continue, but she should be able to learn to manage them better with the use of medication as well as continued behavioral counseling. Cheyanne should continue to be supported in her vocational and social and functioning with services provided through individual and family counseling and through the Department of Vocational Rehabilitation. Cheyanne does display a number of strengths and these should continue to be supported. In particular, she is an adolescent with well-developed understanding skills and she has good verbal and visual memory skills with respect to information that is meaningful and repeated. She does display more difficulty with respect to visual and perceptual organization skills. Previous testing through her school recently indicated most difficulties with respect to math with scores suggestive of a specific math disability and she should have continued supports in this area.

It was discussed that difficulties that Cheyanne is experiencing are likely related to her motor vehicle accident;

however, it is felt that there may also be premorbid factors and stresses which have exacerbated difficulties. In particular, there is a history of sexual molestation which occurred prior to the motor vehicle accident and there is a history of significant family conflict. However, based on information received, it is likely that at least some factors are related to the motor vehicle accident and has exacerbated problems that may have been evident prior to the time of the accident.

Based on the evaluation, the following recommendations are being made:

1. School Placement: Recommendations are for continued support services with an IEP within the school program. Modifications should be made to the program. This report should also be shared with the school.
2. Vocational Planning: Recommendations are for services provided through the Office of Vocational Rehabilitation.
3. Behavioral Services: Recommendations are for continued intensive counseling services. Recommendations may also be to include a cognitive behavioral approach as part of the therapy in order to address current and future oriented concerns.
4. Instructional Strategies: Additional attentional and listening strategies may include:
 - a. Provide structure.
 - b. Be sure that Cheyanne is paying attention to the speaker during instructions and is not distracted by other sources.
 - c. Make eye contact when giving directions.
 - d. Break tasks into components.
 - e. Prepare Cheyanne to listen by stating, "Are you ready? I am going to tell you one (two) things now."
 - f. Allow time for Cheyanne to process instructions and complete tasks.
 - g. Verbalizations and directions to Cheyanne should be in small "chunks." Speak slowly and clearly, using short, simple sentences when directing Cheyanne. Likewise, directions should be brief, containing no more than one or two parts at a time.
 - h. Supplement oral directions with visual aids.
 - i. Use behavioral contracts that are specific and can be backed up with reinforcers at school or at home.
 - j. Help Cheyanne with motivation by providing rewards, interesting material, and frequent praise.

Educational Strategies may include:

- a. When working with Cheyanne, informational chunks should be kept small and manageable. The size of the chunks may vary according to Cheyanne's interest and knowledge base of the material.
- b. In order to determine if Cheyanne is understanding information being presented, it will be helpful to utilize on-line comprehension techniques at selected times. This may involve having Cheyanne provide an interpretation of a small unit of information prior to addressing the entire problem-solving task.
- c. It will be important for there to be multiple repetition of material and information, particularly when new material is being introduced as Cheyanne learns better with repetition. Trying to link new information with prior knowledge will also be beneficial in helping Cheyanne to acquire new information. Previewing information prior to the time that it is formally introduced in the classroom may be beneficial. New information should be reviewed regularly and comprehension of these materials should be frequently monitored.
- d. Information provided should be reviewed regularly and comprehension of materials should be frequently monitored.
- e. Cheyanne does better when information is presented more meaningfully and when there are contextual cues. Cheyanne may have more difficulty remembering a series of directions. Cheyanne will do better with repetition of information and when contextual cues are provided to aid with learning.
- f. Cheyanne may be better able to demonstrate knowledge of a topic/subject if provided with response formats that tap recognition memory. These might include matching, short answer and multiple choice test formats.
- g. It will be important to find strategies to support organizational skills. This may include providing charts and checklists which will enable Cheyanne to follow routines and multi-step directions. Providing encouragement and reinforcement for their use may strengthen their effectiveness.
- h. Provide specific and explicit instruction for reading which may include phonemic awareness activities with explicit instruction in segmenting and blending speech sounds, sight word drill and practice, daily writing activities, using a kinesthetic approach to letters which can be manipulated (e.g. magnetic letters for use in segmenting), and word building activities and application.
- i. Cheyanne will need help with math reasoning and calculation skills.

Additional adaptations for problems may include:

- a. Provide opportunities for Cheyanne to check over her work.
- b. Reduce workload and homework load.
- c. Provide a structured study guide.
- d. Have Cheyanne keep an assignment book.
- e. Help Cheyanne prepare a work plan for long range assignments.

Writing modifications may include:

- a. Written formulation should be taught explicitly starting with single sentences and later teaching paragraph writing.
 - b. When possible, lengthy written output should be kept to a minimum as writing is difficult for Cheyanne. If lengthy written assignments are required, they should be staged over time with instructional guidance.
5. Psychiatry Services: Recommendations are for Cheyanne to be evaluated specifically by a psychiatrist who can address medication issues, including concerns about mood lability and attention.
6. Follow-Up Services: Cheyanne should continue to be closely monitored regarding her skills. She should continue to obtain medical follow-up services as needed. At this time there is no specific follow-up appointment in the Child Development Unit; however, Cheyanne and her mother may contact this examiner in the future if

Please also find a relatively simple discovery request concerning a few issues.





MOTION TO COMPEL

NOW COMES the Plaintiff, Lorraine L. Hahn, as mother and natural guardian of Cheyanne M. Hahn, by and through her counsel of record, Theron G. Noble, Esquire, of Ferraraccio & Noble, who avers as follows in support of her MOTION TO COMPEL:

1. On October 24, 2011, Cheyanne Hahn was taken to Pittsburgh for purposes of IMEs to be performed by a neuropsychologist, Dr. James D. Petrick; and a neurologist, Dr. Richard B. Kasdan.
2. During the short examination of Dr. Richard B. Kasdan, he stopped the examination informing Plaintiff and Cheyanne that he had to see if there was anything else he needed to do, then exited the examination.
3. While Plaintiff and Cheyanne were in the examination room, which had a phone connected to Dr. Kasdan's phone system, it was apparent that phone calls were being made as the lights on the phone indicated as such.
4. A little while later, Dr. Kasdan returned to the examination room and informed Plaintiff and Cheyanne that the examination was concluded and further commented to the effect that this case would shortly be over and that Cheyanne needed to move on from it.

5. In December, Plaintiff received a copy of Dr. Kasdan's report.
6. Based upon Dr. Kasdan's report and the facts as averred in averments 1- 4, Plaintiff sent its second discovery request, a true and correct copy of the relevant portion, as well as Defendant's objection to the same is attached hereto as Exhibit "A", essentially raising "work product" privilege to further disclosure.
7. Based upon the facts and circumstances, upon information and belief, Plaintiff believes that Dr. Kasdan and Defendant's attorney had a phone conversation during Dr. Kadan's IME of Cheyanne.
8. The work product privilege does not protect disclosure of whether or not this event occurred as is reasonably believed under such facts and circumstances and Defendant should be compelled to so disclose in response to Interrogatory 1.
9. If in fact such a conversation did occur, then Plaintiff also believes it is entitled to know the substance of such phone conversation while the Court may protect Defense Counsel's "mental impressions" or other similar privileged information while compelling the disclosure of facts which have bearing on Dr. Kasdan's findings, examination and subsequent opinion

WHEREFORE, Plaintiff request this Honorable Court to compel Defendant to answer Plaintiff's Interrogatories.







RESPONSE IN OPPOSITION TO PLAINTIFFS' MOTION TO COMPEL

AND NOW, comes Defendant, Jeffrey K. Hahn, by and through his counsel, McQuaide Blasko, Inc., and files the following Response in Opposition to Plaintiffs' Motion to Compel averring as follows:

1. Admitted. By way of further response, reports from the independent medical examinations have been produced to Plaintiffs.
2. Denied. After reasonable investigation, Defendant is without sufficient knowledge or information to form a belief as to the truth of the allegations of paragraph 2. The same are therefore denied. Defendant further denies Plaintiffs' characterization of the examination undertaken by Dr. Kasdan.
3. Denied. After reasonable investigation, Defendant is without sufficient knowledge or information to form a belief as to the truth of the allegations of paragraph 3. The same are therefore denied.
4. Denied. After reasonable investigation, Defendant is without sufficient knowledge or information to form a belief as to the truth of the allegations of paragraph 4. The

same are therefore denied. Defendant further denies Plaintiffs' characterization of any alleged comments that Plaintiffs claim were made by Dr. Kasdan.

5. It is admitted that Defendant produced a copy of Dr. Kasdan's report to Plaintiffs. The report was forwarded to Plaintiffs on November 16, 2011.

6. Admitted in part and denied in part. It is admitted only that Plaintiffs issued an interrogatory requesting information pertaining to communications with Dr. Kasdan and defense counsel or others acting on behalf of Defendant, and that the interrogatories and Defendant's response are included within Exhibit A. It is denied that the objection was based only upon the work product privilege. To the contrary, please see the objection attached as Exhibit A to Plaintiffs' Motion. Defendant objects on the basis that the interrogatories seek information that is beyond the scope of expert discovery permitted by the rules of procedure, and specifically Rules 4003.3 and 4003.5. The Pennsylvania Superior Court has recently affirmed that discovery requests regarding communications between an opposing party's attorney and expert retained for trial falls outside of the language of 4003.5 and is not discoverable. See Barrick v. Holy Spirit Hosp., 32 A.3d 800 (Pa. Super. 2011). Defendant denies the averment that Plaintiffs' interrogatories were issued "based upon Dr. Kasdan's report and the facts as averred in averments 1-4."

7. Denied. After reasonable investigation, Defendant lacks sufficient knowledge or information to form a belief as to the truth of the allegations regarding what Plaintiff believes to have occurred. By way of further response, Defendant objects to Plaintiffs' request for discovery regarding communications, if any, between counsel and Dr. Kasdan, for the reasons set forth in Defendant's discovery objection and in paragraph 6, above.

8. Denied. The averments of paragraph 8 constitute legal conclusions to which no response is required. By way of further response, as set forth in response to paragraph 6, above, Defendant does not rest his position solely upon the work product doctrine. Defendant incorporates by reference paragraphs 1 through 7, above, and particularly to paragraph 6, herein by reference as though set forth in full.

9. Denied for the reasons set forth above.

WHEREFORE, Defendant respectfully requests that Plaintiffs' Motion to Compel be denied.



REPLY TO MOTION TO COMPEL EXPERT DISCOVERY

AND NOW, comes, Lorraine L. Hahn, Mother and Natural Guardian for Cheyanne M. Hahn, Plaintiff, by and through her counsel of record, Theron G. Noble, Esquire, of Ferraraccio & Noble, avers as follows in response to Defendant's MOTION TO COMPEL EXPERT DISCOVERY:

1. Admitted.
2. Admitted.
3. Admitted.
4. Admitted. By way of further response, Plaintiff has also fully cooperated in this process by signing AUTHORIZATIONS as well as waiving the twenty (20) day period prior to service of the such subpoenas when requested to do so
5. Denied. Plaintiff disagrees that any traumatic brain injury is aptly described as "small" or that one is recovering "well" from such type of injury. In candor, such records could be construed to support what the defendant asserts but he fails to mention that within a few months other symptoms started to appear and be recognized related to the traumatic brain injury.
6. Admitted. By way of further response, Cheyanne continued to treat with other health care professionals directly related to such traumatic brain injury.
7. Denied. It was within a few months that Cheyanne started to have symptoms related to the traumatic brain injury, which at first thought, the headaches were not related, however as other symptoms became apparent such as short term memory loss, executive function deficit,

and some periods of confusion, further medical treatment was sought which then took some months to get scheduled.

8. Admitted in part, denied in part. It is admitted that the defense has different theories to explain some of Cheyanne's symptoms and injuries but this averment is denied in that the most plausible explanation covering all of Cheyanne's ills seems to be the traumatic brain injury.

9. Admitted.

10. Admitted.

11. Admitted. By way of further response, Plaintiff foremost has fully cooperated in the discovery process and has not only given all requested and required information to defense counsel but has also fully cooperated in the defendant's investigation. However, it took the defendant nearly 21 months to complete its IMEs, providing the last of such reports to Plaintiff just two (2) months ago. Plaintiff does not disparage defense counsel for this delay as a large part of such delay, which is all prevalent in Plaintiff's present inability to provide the requested information at this time, is that Dr. Inna Vaisleib¹ took over a year to produce her final report and it seems all health care providers in this field report to be extremely busy.

In any event, since Plaintiff has received the defense IME²s, which do support the defendant's claim of other sources for Cheyanne's problems, along with the traumatic brain injury, Plaintiff's counsel has been in contact with those medical providers, namely Dr. Laura Harvatine, a psychiatrist, and Dr. Hilary Feldman, a pediatric psychologist, and Pauline Stout, her therapist, each of whom have played a significant part in Cheyanne's progress³, to determine their willingness, competency and ability to testify.

Dr. Harvatine saw Cheyanne while Dr. Harvatine practiced in the State College area. She now practices in Virginia but is on maternity leave (and has been for approximately a month). In that Dr. Harvatine is in her early 40s, she told counsel that any such pregnancy is "complicated" and counsel awaits word from her as to her return.

Dr. Feldman⁴, whose report is attached as Defendant's Exhibit "H", is extremely busy and therefore hesitant to get involved. Dr. Feldman indicated on March 5, 2012, that she is not able to so participate given that Cheyanne has now reached majority and she specializes in pediatric issues.

¹ Dr. Vaisleib was not an expert retained by Plaintiff for purposes of litigation but was a treating physician referred to Cheyanne by Dr. Clark.

² It was hoped that they would concur with Plaintiff's medical reports and therefore eliminate the need to do as Plaintiff must now do.

³ Cheyanne has made positive progress given the care of these named medical providers.

⁴ Dr. Feldman's office reports that she is so busy that they are now scheduling incoming appointments for September but has now at least confirmed she will not so participate.

Plaintiff's best interests in this litigation are served by those who set forth a path of treatment which has helped Cheyanne, be the ones who testify as to their opinions, each of which did relate Cheyanne's issues to her traumatic brain injury. If they do not cooperate, then Plaintiff must and will seek experts like the defense obtained. Once there is testimonial support which Plaintiff can rely upon then the only task needed is for a vocational rehab expert to quantify the economic losses suffered by Cheyanne from her injuries. However, this does seem prudent to do until the link between the injuries and damages can be met, again through reliable testimonial evidence.

Plaintiff does not dispute that (i) defense is entitled to what it has requested; or (ii) that Plaintiff has such burden. Plaintiff simply asks for reasonable time to accomplish her requirements within the frame of these concerns as herein presented.

12. Admitted. By way of further response, Plaintiff takes issue with "alleged" as the same is and has been documented.

13. Admitted when you take into account the defense IME reports.

16. Each such averment will be addressed as further herein detailed.

20. Denied. It is believed that Dr. Clark as a physician who treated Cheyanne would base his report on all tools available to him, including his own findings and thoughts.

21. Denied. Although defense counsel might call Dr. D'Agaro's letter of 2009 a "retraction", it is more accurately quantified as an elaboration as he did not "retract" the significance of the traumatic brain injury only acknowledged that other stressors were present as well.

22. Denied. It is strictly denied that Dr. Clark gave "Dr. D'Agaro almost complete deference".

23. Admitted. By way of further response, Dr. Vaisleib saw Cheyanne as Dr. Vaisleib specializes in pediatric migraine headaches, a symptom Cheyanne was experiencing at the time.

24. Admitted. By way of further response, given Dr. Vaisleib's education, training and experience, it would be unusual for her to render the opinion suggested by defense counsel that Dr. Vaisleib did not give.

25. Admitted.

26. Admitted.

27. Admitted.

28. Admitted.

29. Denied. Foremost, Dr. Feldman's diagnosis, "Personality change due to motor vehicle accident (including attentional problems and mood fluctuating" certainly relates injuries to the accident.

30. Denied. For the reasons set forth in 29 above, this is DENIED.

33. Denied. Dr. Harvatine had access to all of Cheyanne's records to the best of Plaintiff's knowledge, information and belief.

34. Denied. Dr. Harvatine given her treatment and care of Cheyanne would be in position to render such an opinion.

38. Admitted. By way of further response, counsel has located Dr. Harvatine and spoken with her as relayed herein.






