
AND NOW COMES, Plaintiff, by and through its counsel, Weltman, Weinberg & Reis, Co., L.P.A., and hereby files this Emergency Motion to Enter Plaintiff's Default Judgment and in support thereof, Plaintiff avers as follows:

1. On or about March 15, 2007, Plaintiff brought this action against Defendant for payment of a credit card debt.
2. On or about March 23, 2007, the Sheriff's Office of Clearfield County personally served Defendant with a copy of the Complaint.
3. On or about May 06, 2007, Plaintiff mailed an important notice to the Defendants.
4. On or about June 8, 2007, Plaintiff prepared a Praeclipe for Default Judgment.
5. On or about June 16, 2007, Plaintiff was informed that the Clearfield County Sheriff's Office has failed to forward a copy of the Sheriff's return evidencing service upon Defendant Paula Rothrock
6. Plaintiff contacted the Clearfield County Sheriff's Office on June 22, 2007 and was informed by Marilynn that although Defendant Paula Rothrock was served on March 23, 2007, she does not expect a copy of the Sheriff's return evidencing service to be forwarded anytime in the near future.
