



**STIPULATION OF THE PARTIES FOR PAYMENT
AND FOR THE ENTRY OF JUDGMENT BY CONSENT**

TO THE PROTHONOTARY:

Kindly enter Judgment in favor of Plaintiff and against the Defendant, JERRIE A FIDA, above-named, in the amount of \$4530.05 pursuant to the Stipulation of the Parties for Payment and for the Entry of Judgment by Consent, as follows:

1. Defendant admits indebtedness to Plaintiff in the amount of \$4030.05 with continuing interest thereon at a rate of 6.00% per annum from APRIL 12, 2007, plus attorneys' fees in the amount of \$500.00 and costs.

2. To secure the repayment of said indebtedness, Defendant agrees that Judgment by Consent will be entered in favor of the Plaintiff and against the Defendant, JERRIE A FIDA, in the amount of \$4030.05 plus continuing interest thereon at the rate of 6.00% per annum from APRIL 12, 2007, plus attorneys' fees in the amount of \$500.00 and costs.







This paper is a "Writ of Execution". It has been issued because there is a judgment against you. It may cause your property to be held or taken to pay the judgment.
