COMPLAINT

AND NOW, comes the Plaintiff, MARGARET J. THOMPSON, through her Attorney, David P. King, and for her cause of action respectfully represents as follows:

1. The Plaintiff is MARGARET J. THOMPSON, and she resides at 1322 Bushley Road, Brockway, PA 15824.
2. The Defendant is JAMES CRISTINI, and he resides at 19 Playground Road, Brockport, PA 15823.
3. On or about April 28, 2005, at approximately 8:43 a.m., the Plaintiff was operating her motor vehicle in a safe and prudent manner on the public ways and highways of the Commonwealth of Pennsylvania, within the Township of Sandy, Clearfield County, PA.
4. More specifically, the Plaintiff was operating her motor vehicle and driving on Route 219 in a southerly direction just a short distance from the City limits of DuBois, PA, but still in Sandy Township, near the Glenn O. Hawbaker Construction Plant which is situated on PA Route 219 at the location known as 627 Rich Highway, DuBois, PA.

5. At said time and place, the Plaintiff operating her vehicle in said safe and prudent manner, came to a stop behind a line of cars that had also stopped for road construction which was taking place at that time and in that location.

6. At that said time and place, the Defendant, JAMES CRISTINI, was operating his automobile in the same direction on PA Route 219 and approached the Plaintiff's vehicle and the other vehicles which were at a stop at that time.

7. However, the Defendant was not attentive, looking down over the hillside, or otherwise not paying attention to traffic and the flow of traffic and also traveling at an excessive or unsafe speed and did there and then violently crash into the rear end of the vehicle which the Plaintiff was operating, but which was at a standstill at such time.

8. Such impact was in such a violent and forceful manner as to cause the Plaintiff's vehicle to travel forward from its standstill and then hit another vehicle which was stopped in the line of traffic directly in front of the Plaintiff.

9. This impact and violent collision was solely a result of the Defendant's negligence which can be summarized as follows:

- (a) Traveling at a high rate of speed approaching and traveling through a construction area which the Defendant was aware of or should have been aware of.
- (b) Traveling at an excessive rate of speed on the

roadway as described, considering the construction area, and the general overall condition and environment of the roadway known or which should have been known to the Defendant at such time.

(c) Failing to use caution and vigilance when approaching and traveling through the construction area, and the vehicle of the Plaintiff and others similarly situated.

(d) Failing to follow the rules of the road, and more specifically, to be prudent and careful, considering all factors and circumstances.

(e) Failing to have his vehicle under control and/or driving at a safe speed.

(f) Failing to have his vehicle under control, and failing to observe the Plaintiff who had been stopped with other cars, waiting for permission to proceed through the construction area.

(g) Failing to be able to stop his vehicle from violently and forceably colliding with the Plaintiff's vehicle.

(h) Failing to exercise due care under the circumstances as outlined herein.

(i) Failure to exercise in general, in this context, reasonable care under all of the circumstances.

10. Because of the negligent operation of his motor vehicle, the Defendant was the proximate cause, and has caused injuries to the Plaintiff and her vehicle as set forth herein.

COUNT I
(Personal Injury)

11. The averments in Plaintiff's Paragraph 1 through 10 above are herein incorporated by reference.

12. As a result of the collision as described above, the Plaintiff, MARGARET J. THOMPSON, was physically injured and did undergo great pain and suffering, at said point and time, and such pain and suffering continued thereafter, in a significant manner, for a significant period of time, and she continues to this day to experience and suffer from the same regarding said collision.

13. Because of the Plaintiff's injuries it is anticipated that she will not fully recover from the personal injuries received and will continue to suffer the same for the remainder of her lifetime in some fashion and degree.

14. Further, the Plaintiff has suffered great trauma, emotional distress, pain, suffering, discomfort and inconvenience, then, thereafter and continuing and expected to continue into the future and indefinitely.

WHEREFORE, the Plaintiff, MARGARET J. THOMPSON, prays your Honorable Court to award her damages in excess of \$25,000.00.

COUNT II
(Loss of Income)

15. The averments in Plaintiff's Paragraph 1 through 14 above are herein incorporated by reference.

16. Because of the injuries that the Plaintiff received, and although to date first party benefits have paid lost wages, because of the continuing effects of her injuries, Plaintiff may continue to have wage loss which is not covered by first party benefits which she should be compensated for.

WHEREFORE, Plaintiff prays your Honorable Court to enter judgment in her favor and against the Defendant for such sums as reasonably calculated, and she will so ever pray.

COUNT III
(Medical Bills)


17. The averments in Plaintiff's Paragraph 1 through 16 above are herein incorporated by reference.

18. Because of her injuries, caused and proximately caused by the Defendant's negligence, the Plaintiff incurred and continues to incur medical bills and costs related thereto.

19. The Plaintiff's first party benefits have paid the maximum required, \$10,000.00, but no more.

20. Beyond such first party benefits which have been exhausted as mentioned above, the Plaintiff has incurred additional medical expenses in excess of \$85,000.00, and will continue to incur medical expenses and costs related thereto on going.

WHEREFORE, the Plaintiff prays your Honorable Court to enter a judgment in her favor and against the Defendant in an amount equal to her medical bills incurred beyond the first party benefits that have been exhausted, and she will so ever pray.





AND NOW, comes the Defendant, James Cristini, by his attorneys, Hanak, Guido and Taladay, and hereby responds to Plaintiff's Complaint as follows:

1. Admitted.

7. Denied as stated. It is denied that James Cristini was traveling at excessive or unsafe speed. It is further denied that the Defendant was not attentive. With regard to the remaining allegations of paragraph 7, this Defendant is, after reasonable investigation, without information sufficient to form a belief as to the truth of the remaining matters set forth in paragraph 7 of Plaintiff's Complaint, and therefore,

these allegations are denied and strict proof thereof is demanded at the time of trial.

8. After reasonable investigation, the Defendant is without information sufficient to form a belief as to the truth of the matters set forth in paragraph 8 of Plaintiff's Complaint, and therefore, these allegations are denied and strict proof thereof is demanded at the time of trial.

9. Defendant denies allegations of negligence pursuant to Pa.R.C.P. Rule 1029(e). By way of further answer, however, Defendant admits liability for the collision.

10. After reasonable investigation, the Defendant is without information sufficient to form a belief as to the truth of the matters set forth in paragraph 10 of Plaintiff's Complaint, and therefore, these allegations are denied and strict proof thereof is demanded at the time of trial.

Count I

Personal Injury

11. Defendant incorporates paragraphs 1 through 10 above as if set forth in full.

12. After reasonable investigation, the Defendant is without information sufficient to form a belief as to the truth of the matters set forth in paragraph 12 of Plaintiff's Complaint, and therefore,

these allegations are denied and strict proof thereof is demanded at the time of trial.

13. After reasonable investigation, the Defendant is without information sufficient to form a belief as to the truth of the matters set forth in paragraph 13 of Plaintiff's Complaint, and therefore, these allegations are denied and strict proof thereof is demanded at the time of trial.

14. After reasonable investigation, the Defendant is without information sufficient to form a belief as to the truth of the matters set forth in paragraph 8 of Plaintiff's Complaint, and therefore, these allegations are denied and strict proof thereof is demanded at the time of trial.

Count III

18. After reasonable investigation, the Defendant is without information sufficient to form a belief as to the truth of the matters set forth in paragraph 18 of Plaintiff's Complaint, and therefore, these allegations are denied and strict proof thereof is demanded at the time of trial.

19. After reasonable investigation, the Defendant is without information sufficient to form a belief as to the truth of the matters set forth in paragraph 19 of Plaintiff's Complaint, and therefore, these allegations are denied and strict proof thereof is demanded at the time of trial.

20. After reasonable investigation, the Defendant is without information sufficient to form a belief as to the truth of the matters set forth in paragraph 20 of Plaintiff's Complaint, and therefore, these allegations are denied and strict proof thereof is demanded at the time of trial.

WHEREFORE, Defendant demands judgment in his favor.

NEW MATTER

21. Plaintiff's claims for medical expenses are barred or limited by application of the Pennsylvania Motor Vehicle Financial Responsibility Law and its cost containment provisions.

22. Plaintiff's claims are barred or limited by application of the Pennsylvania Motor Vehicle Financial Responsibility Law.


