AND NOW, comes Murrays Ford Lincoln Mercury Inc., by and through their attorneys, Hopkins, Heltzel LLP, and files the within petition to obtain title to the motor vehicle described herein and in support thereof says:

1. Petitioner is Murrays Ford Lincoln Mercury Inc., a Pennsylvania corporation with a principal business address at 3007 Blinker Parkway, DuBois, Pennsylvania 15801.

2. This action concerns a 2001 Mercury Sable motor vehicle, VIN No. 1MEFM53U51A626213 with mileage of 113,304 miles and bearing California License Plate No. 4VZZ092.

3. The reputed owner of the vehicle is George Delanoy whose address is 204 El Camino Real, No. 615, Encinitas, California 92024.

4. On or about August 15, 2006 Mr. Delanoy left the motor vehicle for a repair estimate. Mr. Delanoy was notified the vehicle required major engine repairs to correct an overheating and missing problem. Since notifying Mr. Delanoy of the major engine repairs Petitioner has not been able to reach him for a decision concerning the repairs.

5. The motor vehicle's title was held by Mission Financial, P.O. Box 29049, Santa Ana, California 92799.

6. Petitioner contacted Mission Financial and learned that the payments on the motor vehicle were in substantial arrears. To the best knowledge, information, belief of Petitioner Mission Financial attempted to contact Mr. Delanoy but was unable to do so.

7. Plaintiff attempted contact with Mr. Delanoy by letter dated December 19, 2006. A photocopy together with the certified mail return receipt card is attached hereto as Exhibit A.


8. Petitioner paid the lien holder, Mission Financial \$400.00 to obtain the title to the motor vehicle. See canceled check marked as Exhibit B.

9. The title is now in the possession of Petitioner. See Exhibit C.



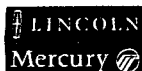

Dear Mr. Delanoy,

On August 15, 2006 you left your 2001 Sable at Murrays Ford in DuBois for a repair estimate. You were notified that your car required major engine repairs to correct the overheating and missing problem.

Since notification, we have not been able to reach you for your decision about the needed repairs. Since 4 months have passed since your car was left at Murrays, and we have had no contact from you, we are considering your vehicle as abandoned at Murrays.

We have contacted Mission Financial in Santa Ana California where your vehicle was financed and they have not been able to make contact with you as your vehicle account is in severe delinquency.
