PETITION FOR REVIEW AND FOR SUPERSEDEAS

AND NOW comes Petitioner, Jeffrey A. Martin, by and through Ronald L. Collins, Esquire,
who Petitions your Honorable Court as follows:

1. That Petitioner is Jeffrey A. Martin of German Road, PO Box 108, Drifting, PA, 16834.
2. That Petitioner was born on September 16, 1963 and has a Drivers License No. 20246332.
3. That Respondent is the Commonwealth of Pennsylvania, Department of Transportation.
4. That by Official Notice dated May 1, 2007, a copy of which is hereinafter attached as Exhibit A, Respondent issued an One Hundred and Twenty Day (120) disqualification of Petitioner's commercial driving privileges as a result of Petitioner's conviction on October 10, 2006 of an offense for Improper Lane Changes occurring on August 2, 2006 in Delaware.
5. That the offense of Improper Lane Changes has been designated as a Serious Offense for commercial drivers.
6. That pursuant to Section 1611 (g) of the Motor Vehicle Code, 75 Pa. C.S.A. §1611 (g), the Department of Transportation is to disqualify a commercial driver for Sixty (60) days if he is convicted of two (2) serious traffic violations committed in a commercial vehicle arising from separate and distinct incident occurring within a three (3) year period, or for one hundred and twenty

(120) days if he is convicted of three (3) serious traffic offenses within that period.

7. That according to a ten (10) year driving record obtained from D.A.C. Services, a copy of which is hereinafter attached as Exhibit "B", Petitioner has only two Serious Traffic Offenses occurring within a three (3) year period, viz., the Improper Lane Change conviction occurring August 2, 2006 and an Exceeding Maximum Speed Limit by more than 15 MPH occurring on July 11, 2005.


8. An official ten (10) year driving record from the Department has been requested by Petitioner but is not available as of the date of the filing of this Petition.

9. In that it appears that Petitioner has only two (2) convictions for Serious Traffic Offenses occurring within a three (3) year period, Petitioner should be subject to only a sixty (60) day disqualification, and the Respondent's action in disqualifying him from driving a commercial vehicle for one hundred and twenty (120) days is erroneous and improper.

10. That Petitioner would assert that there is a reasonable likelihood of the successful prosecution of this appeal and would therefore request that a supersedeas of the Respondent's disqualification of his commercial driving privileges be issued pursuant to Section 1550 (b) (2) of the Motor Vehicle Code, 75 Pa. C.S.A. §1550 (b) (2), pending this appeal.

WHEREFORE, Petitioner respectfully requests your Honorable Court to review the actions of Respondent in disqualifying him from driving a commercial vehicle for one hundred and twenty days (120) and issue a supersedeas of said disqualification pending this appeal.

Dear Motorist:

This is an Official Notice of Disqualification of your commercial driving privilege as authorized by Section 1611G of the Pennsylvania Vehicle Code as a result of your pre-adjudication, conviction, administrative adjudication, or refusal in DELAWARE. Section 1611H of the Pennsylvania Vehicle Code mandates that PennDOT process specific out-of-state pre-adjudications, convictions, administrative adjudications, or refusals as though they occurred in Pennsylvania.

Your driving record reflects one of the above adjudications on 10/02/2006 of M42 of the AAMVA Code Dictionary, IMPROP LANE CHANGES on 08/02/2006. The AAMVA Code Dictionary was developed to support the Commercial Motor Vehicle Act of 1986 and allows states to share conviction information.

Your commercial driving privilege is disqualified for a period of 120 DAY(S) effective 06/05/2007 at 12:01 A.M.

In order to comply with this sanction you are required to return any current driver's license, learner's permit and/or temporary driver's license (camera card) in your possession no later than the effective date listed. If you cannot comply with the requirements stated above, you are required to submit a DL16LC Form or a sworn affidavit stating that you are aware of the sanction against your driving privilege. Failure to comply with this notice shall result in this Bureau referring this matter to the Pennsylvania State Police for prosecution under SECTION 1571(a)(4) of the Vehicle Code.

Although the law mandates that your driving privilege is under disqualification even if you do not surrender your license, Credit will not begin until all current driver's license product(s), the DL16LC Form, or a letter acknowledging your sanction is received in this Bureau.

WHEN THE DEPARTMENT RECEIVES YOUR LICENSE OR ACKNOWLEDGEMENT, WE WILL SEND YOU A RECEIPT. IF YOU DO NOT RECEIVE THIS RECEIPT WITHIN 15 DAYS CONTACT THE DEPARTMENT IMMEDIATELY. OTHERWISE, YOU WILL NOT BE GIVEN CREDIT TOWARD SERVING THIS SANCTION.

While your commercial driving privilege is disqualified, the Vehicle Code permits a driver to obtain a noncommercial Class C or M license, if the driver possesses the motorcycle qualification, to drive noncommercial motor vehicles. If you wish to obtain this license, please complete the enclosed application as instructed and return it to the Department.

Please be aware that if you elect to obtain this noncommercial Class C or M license, you are still prohibited from operating a commercial motor vehicle. If you do so, you are subject to additional penalties, including possible lifetime disqualification of your commercial driving privilege.

You have the right to appeal the Department's action to the Court of Common Pleas (Civil Division) within 30 days of the mail date (MAY 01, 2007) of this notice. You must still send in your license before the effective date of disqualification unless you appear in person before a Judge and receive an order permitting you to continue to drive. PLEASE NOTE that this Civil Appeal is in addition to any appeal you have to file from the criminal conviction.

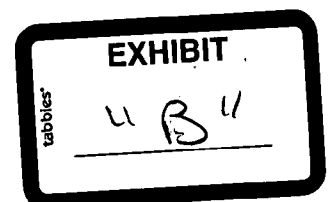




