C O M P L A I N T

NOW COME, the Plaintiffs, RONALD L. TURNER and JUDITH A. TURNER, who by and through their attorney, BARBARA J. HUGNEY-SHOPE, ESQUIRE, file the following Complaint in Quiet Title against the Defendants, and aver as follows:

1. That the Plaintiffs, RONALD L. TURNER and JUDITH A. TURNER, are husband and wife, and reside at 1467 River Road Rear, Olanta, Clearfield County, Pennsylvania 16863.

2. That the Defendants, the heirs of the Estate of D. R. Woolridge, also known as David R. Woolridge, are as follows:

- (a) Raymond H. Woolridge, an adult individual, whose last known address is 1301 Doris Street, Kannapolis, North Carolina 28083-2986;
- (b) Nancy Virginia Woolridge, an adult individual, whose last known address is 100 North East 108th Street, Vancouver, Washington 98685-5262;
- (c) Elizabeth Jane Kauffman, an adult individual, whose last known address is 450 del Moreno Drive, Woodland Hills, California 91364;
- (d) Stephanie Ann Woolridge, an adult individual, whose last known address is 8 Lisa Way, Wayne, Pennsylvania 19087;
- (e) Catherine Suzanne Lansberry, an adult individual, whose last known address is 430 Kathmere Avenue, Havertown, Pennsylvnaia 19803;
- (f) Anna-Vaughn Lee Kepner, an adult individual, whose last known address is Bellwether Farm, 16452 Spielman Road, Williamsport, Maryland 21795;
- (g) Eugenia Mitchell Lee, an adult individual, whose last known address is 10500 Weymouth Street, Apt 301, Bethesda, Maryland 20814;
- (h) Elizabeth Jane Lee, an adult individual, whose last known address is 57 Lake Winds Road, Diamond Point, New York 12824; and

(i) Joseph J. Lee, Jr., an adult individual, whose last known address is 9 North Terrace Drive, Dillsburg, Pennsylvania 17019.

3. That the Plaintiffs became vested in certain land in Lawrence Township, Clearfield County, Pennsylvania, by virtue of the following deeds:

(a) The first parcel was acquired from Donald Bender and Darlene Bender by a Deed dated March 12, 1987, and recorded in Clearfield County Deeds and Records Book Volume 1143, page 582, and is more fully described as follows:

ALL that certain parcel or lot of land situate in Lawrence Township, Clearfield County, Pennsylvania, known as Lot No. 48 and being part of Clearfield County Assessment No. 123-K08-243-35, now No. 123-K08-243-35.2, and also being one of the lots conveyed by the Clearfield County Commissioners to the said Donald Bender and Darlene Bender at a private sale ordered by the Court of Common Pleas of Clearfield County on July 14, 1970, as the property of the D. R. Woolridge Estate. This lot is bounded as follows:

On the North by land of Plaintiffs,
On the East by Bradford Street
On the South by other lots of Donald Bender and Darlene Bender,
And on the West by an unnamed alley.

(b) The second parcel consisting of two (2) lots also acquired from Donald Bender and Darlene Bender by their Deed dated November 2, 1999, and recorded in Clearfield County as Instrument No. 199918262, and more fully described as follows:

ALL those certain parcels or lots of land situate in Lawrence Township, Clearfield County, Pennsylvania, known as Lot Nos 49 and 50 and being identified as Clearfield County Assessment No. 123-K8-243-35 and also being the lots conveyed by the Clearfield County Commissioners to Donald Bender and Darlene Bender at a private sale ordered by the Court of Common Pleas of Clearfield County on July 14,

1970, as the property of the D. R. Woolridge Estate. These lots are bounded as follows:

On the North by land of Plaintiffs,
On the East by Bradford Street,
On the South by Reighard Street, and
On the West by an unnamed alley.

4. The said three (3) lots identified as Lot Nos.48, 49 and 50 formerly assessed in the name of the D. R. Woolridge Estate as set forth in Paragraph 3 above, were conveyed to Donald Bender and Darlene Bender by Deed of the Clearfield County Commissioners dated July 31, 1970, recorded in Clearfield County Deed Book Volume 566, page 539.

5. The same said three (3) lots had been conveyed to the Clearfield County Commissioners by Lillian D. Eshelman, Treasurer of Clearfield County by Deed dated January 10, 1963, as the property of the D. R. Woolridge Estate for nonpayment of taxes for the year 1960.

6. The said D. R. Woolridge, also known as David R. Woolridge, had acquired four (4) pieces of land, one of which contained the lots described in Paragraph 3 above, by Deed of J. E. Wrigley dated June 18, 1904, and recorded in Clearfield County Deed Book 141, page 529.

7. The said D. R. Woolridge, also known as David R. Woolridge, died testate on June 3, 1950, and by his will filed in the Clearfield County Register of Wills' Office

at No. 20823 devised all of his real property to his wife, Dora M. Woolridge, and his sons, John Hayes Woolridge, Sr. and Raymond H. Woolridge.

8. The said Dora M. Woolridge died intestate without an estate being opened but was survived by her sons, John Hayes Woolridge, Sr., and Raymond H. Woolridge, as her sole intestate heirs..

9. The said Raymond H. Woolridge is an adult individual and has been named as a Defendant herein.

10. The said John Hayes Woolridge, Sr. died testate July 4, 1958, and by his will filed in the Clearfield County Register of Wills' Office at No. 23491, devised all of his real property to his widow, Elizabeth M. Woolridge, and his children, John Hayes Woolridge, Jr. and Elizabeth Woolridge Lee.

11. The said Elizabeth M. Woolridge died testate January 6, 1975, and by her will filed in the Clearfield County Register of Wills Office in Will Book 27, Page 159, at Estate No. 75-2, devised all of her real property to her children, John Hayes Woolridge, Jr., and Elizabeth Woolridge Lee.

12. The said John Hayes Woolridge, Jr., died August 4, 1983, survived by his four (4) daughters; namely, Nancy Virginia Woolridge; Elizabeth Jane Kauffman; Stephanie Ann Woolridge and Catherine Suzanne Lansberry, all of whom survived and are named as Defendants herein.

13. The said Elizabeth W. Lee, died on June 16, 2004, survived by her four (4) children; namely, Anna-Vaughn Lee Kepner, Eugenia Mitchell Lee, Elizabeth Jane Lee, and Joseph J. Lee, Jr., all of whom survived and are named as Defendants herein.

14. That this Quiet Title Action is necessary to remove any cloud on Plaintiffs' title to the parcels described in Paragraph 3 (a) and (b) of this Complaint due to any irregularities in the chain of title because of incomplete estate records of deceased persons or lack of estates, possible adverse interests of unknown heirs, and the validity of the private tax sale.

15. That Plaintiffs believe and aver that the tax sale of July 14, 1970, to their predecessors in title, was valid and that all interest or claim of the Defendants was extinguished by that sale.


16. That from 1970 to the present, Plaintiffs and their predecessors in title, have exercised open, notorious and hostile possession and control over the parcels described in Paragraph 3 (a) and (b) to the exclusion of all others.

17. That at no time have any of the herein named Defendants, or anyone purporting to act on their behalf, attempted to secure possession of the said premises, contest the title of the Plaintiffs or their predecessors in title or assist in the maintenance, repair or improvement of the premises hereinbefore described, nor have they asserted any interest adverse to the Plaintiffs by any legal action.

WHEREFORE, Plaintiffs request:

- (a) That the Defendants be forever barred from asserting any right, title, lien or interest in the Plaintiffs' land inconsistent with the ownership of the Plaintiffs, unless the Defendants bring an action of ejectment against the Plaintiffs for the recovery of the land within thirty (30) days after the entry of judgment of the Court;
- (b) That the Plaintiffs be decreed as the sole owners and be entitled to exclusive possession of the premises described in the foregoing Complaint;
- (c) That the Court make such further orders as may be necessary to establish the legal and valid title of the Plaintiffs and to grant them appropriate relief.

9. The said Raymond H. Woolridge is an adult individual and has been named as a Defendant herein.

10. The said John Hayes Woolridge, Sr. died testate July 4, 1958, and by his will filed in the Clearfield County Register of Wills' Office at No. 23491, devised all of his real property to his widow, Elizabeth M. Woolridge, and his children, John Hayes Woolridge, Jr. and Elizabeth Woolridge Lee.

11. The said Elizabeth M. Woolridge died testate January 6, 1975, and by her will filed in the Clearfield County Register of Wills Office in Will Book 27, Page 159, at Estate No. 75-2, devised all of her real property to her children, John Hayes Woolridge, Jr., and Elizabeth Woolridge Lee.

12. The said John Hayes Woolridge, Jr., died August 4, 1983, survived by his four (4) daughters; namely, Nancy Virginia Woolridge; Elizabeth Jane Kauffman; Stephanie Ann Woolridge and Catherine Suzanne Lansberry, all of whom survived and are named as Defendants herein.

13. The said Elizabeth W. Lee, died on June 16, 2004, survived by her four (4) children; namely, Anna-Vaughn Lee Kepner, Eugenia Mitchell Lee, Elizabeth Jane Lee, and Joseph J. Lee, Jr., all of whom survived and are named as Defendants herein.

14. That this Quiet Title Action is necessary to remove any cloud on Plaintiffs' title to the parcels described in Paragraph 3 (a) and (b) of this Complaint due to any irregularities in the chain of title because of incomplete estate records of deceased persons or lack of estates, possible adverse interests of unknown heirs, and the validity of the private tax sale.

15. That Plaintiffs believe and aver that the tax sale of July 14, 1970, to their predecessors in title, was valid and that all interest or claim of the Defendants was extinguished by that sale.


16. That from 1970 to the present, Plaintiffs and their predecessors in title, have exercised open, notorious and hostile possession and control over the parcels described in Paragraph 3 (a) and (b) to the exclusion of all others.

17. - (a) That the Defendants be forever barred from asserting any right, title, lien or interest in the Plaintiffs' land inconsistent with the ownership of the Plaintiffs, unless the Defendants bring an action of ejectment against the Plaintiffs for the recovery of the land within thirty (30) days after the entry of judgment of the Court;
- (b) That the Plaintiffs be decreed as the sole owners and be entitled to exclusive possession of the premises described in the foregoing Complaint;
- (c) That the Court make such further orders as may be necessary to establish the legal and valid title of the Plaintiffs and to grant them appropriate relief.
