## WAIVER OF RIGHT TO FILE LIEN


WHEREAS, Continental Construction, Inc., hereinafter called the CONTRACTOR, has entered into a contract with the Clearfield Borough, hereinafter called the OWNER, to provide materials and perform labor necessary for the Contract 2005-1 Ward 1 East Side & Park Avenue Sanitary Sewer Project, hereinafter called the PROJECT.






