

# COMPLAINT

NOW COMES, the Plaintiff, CLAIR LEE YEAGER, EXECUTOR of the  
ESTATE OF WILMA YEAGER POTTER, Deceased, who by and through his  
attorney, BARBARA J. HUGNEY-SHOPE, ESQUIRE, files this Complaint to  
quiet the title to certain real estate and in support thereof avers as follows:

1. That the Plaintiff, CLAIR LEE YEAGER, who resides at 3017 Vernon Avenue, Pittsburgh, Pennsylvania, was granted Letters Testamentary for the Estate of Wilma Yeager Potter, by the Register of Wills for Clearfield County, Pennsylvania, on March 29, 2005, and as Executor brings this action on behalf of the said estate.

2. That Defendants are the heirs at law of Michael Bannon, who died intestate on November 12, 1941, their heirs, executors, administrators, successors and assigns, known or unknown, with the known heirs who have not quit-claimed or released their interest to the premises subject of this action being as follows:

(a) Heirs of Michael Bannon, as to any unknown heirs who have not quit-claimed and released any claim to the "Subject Premises, whose identity and location are unknown.

(b) Heirs of Jeannette Bannon, surviving spouse of Paul Bannon, whose identity and location are unknown.

3. That the Plaintiff is the representative for the owner of two (2) certain pieces or parcels of land located in the Third Ward of Clearfield Borough, Clearfield County, Pennsylvania, having been acquired by virtue of a deed from the Clearfield County Tax Claim Bureau recorded in Clearfield County Deeds and Records Book 1505, page 01, hereinafter referred to as the "Subject Premises", and bounded and described as follows:

**PARCEL NO. 1:** BEING bounded on the South by Clearfield Street; on the East by the eastern half of Lot No. 134; on the North by an alley; and on the West by an alley. Being fifty (50) feet front and one hundred fifty-five (155) feet in depth and known in the Plan of Clearfield Borough as Lot No. 135.

**BEING** the same premises conveyed to Annie Bannon by deed of William D. Bigler and Annie, his wife, by their deed dated May 21, 1884, and

recorded in Clearfield County Deed Book 32, page 162.

**PARCEL NO. 2:**

BEING bounded on the South by Clearfield Street; on the East by the eastern half of Lot No. 134; on the North by an alley; and on the West by Lot No. 135. Being twenty-five (25) feet front on Clearfield Street and extending in depth one hundred fifty-five (155) feet to an alley and known in the Plan of Clearfield Borough as the western one-half of Lot No. 134.

**BEING** the same premises conveyed to Michael Bannon by deed of William D. Bigler and Alice, his wife, by their deed dated April 13, 1887, and recorded in Clearfield County Deed Book 69, page 157.

4. The "Subject Premises" were conveyed to D. Wallace Potter and Wilma J. Yeager Potter, by the Tax Claim Bureau of Clearfield County, Pennsylvania, by its deed dated December 15, 1992, as the property of SARAH J. BLOOM and the MICHAEL BANNON HEIRS.

5. The said D. Wallace Potter died November 12, 1997, vesting sole title in the "Subject Premises" in his surviving spouse, Wilma Yeager Potter, by operation of law.

6. The said Wilma Yeager Potter having died testate on March 7, 2005, and by her Last Will and Testament appointed her son, Clair Lee Yeager, as Executor who was granted Letters Testamentary on March 29, 2005, and brings this action on behalf of the Estate of Wilma Yeager Potter.

7. Parcel No. 1, known as Lot No. 135 of the "Subject Premises" was acquired by Annie Bannon by deed from William D. Bigler, et ux., dated May 21, 1884, and recorded in Clearfield County Deed Book 32 at page 62.

8. The said Annie Bannon died intestate in 1907 survived by her spouse, Michael Bannon, and seven (7) children; namely, Peter Sheridan Bannon, Michael James Bannon, Francis Patrick Bannon, Thomas Edward Bannon, Paul Bannon, John B. Bannon, and Mary Ellen Bannon.

9. The said Michael Bannon as surviving spouse acquired a life estate in Parcel No. 1 with the remaindermen being Annie Bannon's seven (7) children.

10. The said Francis Patrick Bannon, son of Annie Bannon, died intestate on April 22, 1925, survived by his spouse, Helen Bannon, and three (3) children; namely, Betty Patricia Bannon, Thomas Sheridan Bannon and Francis Patrick Bannon, Jr.

11. The said Helen Bannon, surviving spouse of Francis Patrick Bannon, claimed his one-seventh (1/7) interest in Parcel No. 1 of the "Subject Premises" as part of her widow's exemption which she subsequently conveyed to Mary Ellen Cupples, formerly Mary Ellen Bannon, Peter S. Bannon, also known as Peter Sheridan Bannon, John B. Bannon, and Michael James Bannon by her deed dated September 3, 1937, and recorded in Clearfield County Deed Book 319, page 342.

12. The said Thomas Edward Bannon died intestate on July 16, 1931, without a surviving spouse or any issue, leaving his father, Michael Bannon, as his sole surviving intestate heir for his one-seventh (1/7) interest in Parcel No. 1 of the "Subject Premises."

13. The said Paul Bannon died intestate on November 7, 1935, survived by his spouse but without issue leaving his spouse, Jeannette Bannon, and his father, Michael Bannon, as his sole surviving intestate heirs for his one-seventh (1/7) interest in Parcel No. 1 of the "Subject Premises."

14. Parcel No. 2, known as part of Lot No. 134 of the "Subject Premises" was acquired by Michael Bannon by deed of William D. Bigler, et ux., dated April 13, 1887, and recorded in Clearfield County Deed Book 69 at page 157.

15. Michael Bannon, surviving spouse of Annie Bannon, died testate on June 22, 1936, leaving Parcel No. 2 of the "Subject Premises" to his daughter, Mary Ellen Cupples, and the balance of his estate including his interest in Parcel No. 1 of the "Subject Premises" to his surviving sons, Peter Sheridan Bannon, John B. Bannon and Michael James Bannon.

16. The said Michael James Bannon died intestate on November 12, 1941, without a surviving spouse or any issue, leaving to survive him were his brothers, Peter S. Bannon and John Bannon, his sister, Mary Ellen Cupples, and the issue of

his deceased brother, Francis P. Bannon; specifically, Betty Patricia Bannon Johnston, Thomas Sheridan Bannon and Francis P. Bannon as his sole intestate heirs.

17. The said Mary Ellen Cupples died testate on June 14, 1948, devising her interest in the house and lot known as the Annie Bannon Estate, being Parcel No. 1 of the "Subject Premises" to her brothers, Peter S. Bannon, Michael James Bannon and John B. Bannon and her sister-in-law, Jeanette Bannon, and Parcel No. 2 of the "Subject Premises" to her brother, Peter S. Bannon, by her will dated March 8, 1938, which is filed of record in Clearfield County Will Book X, page 117.

18. The said Michael James Bannon having died November 12, 1941, and Jeanette C. Bannon having died November 2, 1946, both predeceasing Mary Ellen Cupples; therefore, their respective shares of this estate lapsed.

19. The said Peter S. Bannon died testate on August 16, 1952, and by his will he left the residue of his estate to his sister, Mary Ellen Cupples, who predeceased him, then equally to his brothers, John B. Bannon and Michael J. Bannon but since his brother, Michael J. Bannon, had predeceased him this left his brother, John B. Bannon as his sole testate heir.

20. The said John B. Bannon died testate on April 1, 1964, survived by his spouse, Helen McDowell Bannon, leaving his spouse as his sole testate heir as to his interest in Parcels 1 and 2 of the "Subject Premises."

21. Helen McDowell Bannon, widow of John B. Bannon, died testate on October 12, 1987, leaving her estate equally to her granddaughter, Karen McDowell Catalano, and her grandson, Kelly Lynn McDowell.

22. The said Karen McDowell Auman, formerly Karen McDowell Catalano, and Kelly Lynn McDowell by their deed dated April 14, 1994, conveyed their interests in Parcels No. 1 and No. 2 of the "Subject Premises" to D. Wallace Potter and Wilma Yeager Potter, his wife, which is filed in Clearfield County Recorder of Deeds Office in Deed Book 1601, page 22.

23. Thomas Sheridan Bannan, as an heir of Francis P. Bannon, Michael J. Bannon and Peter S. Bannon, released and quit-claimed any interest he had in Parcels 1 and 2 of the "Subject Premises" to Sarah J. Bloom by his deed dated July 29, 1991, and recorded in Clearfield County Deeds and Records Book 1414, page 168.

24. William S. Johnston, brother of Sarah J. Bloom, who are children and sole heirs of Betty Patricia Bannon Johnston; and Francis Patrick Bannan, Jr., and Thomas Sheridan Bannan, as heirs of Francis P. Bannon, Michael J. Bannon and

Peter S. Bannon, released and quit-claimed any interest they had in Parcels 1 and 2 of the “Subject Premises” to Sarah J. Bloom by their deed dated July 12, 1991, and recorded in Clearfield County Deeds and Records Book 1414, page 172.

25. The said Sarah J. Bloom conveyed any interest she may have in the “Subject Premises” to D. Wallace Potter and Wilma Yeager Potter, his wife, by her deed dated July 9, 1993, and recorded in Clearfield County Deeds and Records Book 1601, page 225.

26. That this Quiet Title Action is necessary to remove any cloud on Plaintiff’s title to the “Subject Premises” due to any irregularities in the chain of title because of the tax sale, incomplete estate records of deceased persons showing a complete chain of title or lack of estates, and possible adverse interests of unknown heirs of the said Michael Bannon and Jeannette Bannon.


27. Plaintiff believes and avers that all of the intestate and testate heirs of Michael Bannon and Jeanette Bannon, their heirs, executors and administrators, who have not relinquished any interest that they may have inherited in the “subject premises” have been named as Defendants.

28. Plaintiff believes and avers that the tax sale of the “subject premises” on September 15, 1992, to D. Wallace Potter and Wilma J. Yeager Potter was valid and that no objections were filed.

29. That at no time since the tax sale on September 15, 1992, has any person purporting to be an heir of Michael Bannon or Jeanette Bannon attempted to secure possession of the "subject premises", contest the title of the Plaintiff or assist in the maintenance, repair or improvement of the premises hereinbefore described nor have they asserted any interest adverse to the Plaintiff by any legal action.

WHEREFORE, Plaintiff requests:

- (a) That the Defendants be forever barred from asserting any right, title, lien or interest in the Plaintiff's land identified as the "subject premises" inconsistent with the ownership of the Plaintiff, unless the Defendants bring an action in ejectment against the Plaintiff for the recovery of the land within thirty (30) days after the entry of judgment of the Court;
- (b) That the Plaintiff be decreed as the sole owner and be entitled to exclusive possession of the premises described in the foregoing Complaint; and
- (c) That the Court make such further Orders as may be necessary to establish the legal and valid title of the Plaintiff and to grant him all appropriate relief.



Peter S. Bannon, released and quit-claimed any interest they had in Parcels 1 and 2 of the "Subject Premises" to Sarah J. Bloom by their deed dated July 12, 1991, and recorded in Clearfield County Deeds and Records Book 1414, page 172.

25. The said Sarah J. Bloom conveyed any interest she may have in the "Subject Premises" to D. Wallace Potter and Wilma Yeager Potter, his wife, by her deed dated July 9, 1993, and recorded in Clearfield County Deeds and Records Book 1601, page 225.

26.
