ALL that certain piece or parcel of ground situated in Morris Township, Clearfield County, Pennsylvania, bounded and described as follows:

BEGINNING at an existing iron bolt on the right of way line of State Route 2032 being South forty-five (45) degrees thirty-six (36) minutes zero (00) seconds West eighteen and twelve one-hundredths (18.12) feet from the center line of said State Route 2032 and being the northwest corner of the parcel herein conveyed; thence along right of way line of State Route 2032 South fifty-two (52) degrees thirty (30) minutes zero (00) seconds East one hundred eighty-six and eighty one hundredths (186.80) feet to an existing iron bolt on the right of way line of State Route 2032 being south forty-one (41) degrees twenty-eight (28) minutes zero (00) seconds West seventeen and ninety-five one-hundredths (17.95) feet from the center line of State Route 2032 and forming the northeast corner of the parcel herein conveyed; thence along the lands now or formerly of Lewis and Florence Liptak North thirty-eight (38) degrees eighteen (18) minutes zero (00) seconds West two hundred four and ninety-seven one-hundredths (204.97) feet to an iron pipe forming the southwest corner of the parcel herein conveyed; thence along lands now or formerly of Edward C. Liptak North forty-five (45) degrees thirty-six (36) minutes zero (00) seconds East two hundred forty-six and fifty one-hundredths (246.50) feet to an existing iron bolt and place of beginning. **CONTAINING** 1.1734 acre which is set out on the survey map prepared by Nicholas Shirokey dated January 18, 1992.
