MECHANIC'S LIEN WAIVER

WHEREAS, JAMES L. 
NOW, this 19th day of July, 2007, at the time of or immediately before or subsequent to the execution of the principal contract, and before any authority has been given by the said James L. Baughman, Sr. to Shimmel's Contracting to commence work on the said sand mound, or purchase materials for the same in

consideration of the making of the said contract with Shimmel's Contracting, and the further consideration of the sum of One and 00/100 (\$1.00) Dollar, to them paid by James L. Baughman, Sr., it is agreed that no lien shall be filed against the building or real property by the Contractor, or any other person for any labor, or materials purchased, or extra labor or materials purchased for the sand mound, the right to file such liens being expressly waived.


This Mechanic's Lien Waiver is intended to be filed with the Clearfield County Prothonotary within ten (10) days after date.


