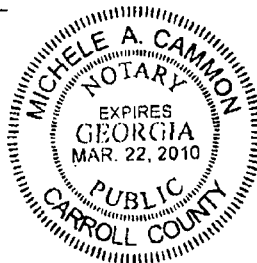

The matter was reported to Sears, again years ago, and they removed the account from my credit report. They did not have my signature for a purchase, because I did not make a purchase, and could not provide any, therefore the account was removed as unverifiable. This was confirmed by Trans Union, the account was unverifiable and therefore removed from my credit file.

Therefore: I dispute the charges being made


In reference to item #3 Defendant (me) did not use this credit card for this purchase and did not authorize anyone else to use my credit card for any purchase.
