For value received and intending to be legally bound hereby, **UNIVERSAL DISPLAY CO., INC.** t/d/b/a **UNIVERSAL DATA INTERCHANGE**, **HARRY J. GABRIEL** and **CATHERINE J. GABRIEL**, husband and wife, and **RICHARD M. SCHRAMM** (individually and collectively "Debtor") promises to pay to the order of **KATZEN INVESTMENT** ("Katzen") the principal sum of \$77,493.85 together with interest at the rate of eighteen (18%) percent per annum on the unpaid principal balance until paid in full.

On June 16, 2007, Debtor shall pay to Katzen \$8,500.00. Beginning on August 20, 2007 and on the 20th day of each month thereafter, Debtor shall pay Katzen \$1,500.00 until the entire debt is paid in full. In the event Debtor makes the \$8,500.00 payment and twenty (20) consecutive monthly payments of \$1,500.00 beginning August 20, 2007 and ending March 20, 2009, Katzen shall cause this Note to be marked paid in full. Payment is due by the 20th of each month at Katzen Investments, 1900 Summit Tower Boulevard, Suite 130, Orlando, FL 32810. If payments are made as set forth above, Katzen shall be entitled to the full amount of the debt.

If Debtor fails to make a payment when due, Debtor shall pay Katzen a late fee of \$200.00. If this Note is placed with an attorney for collection, and whether or not suit is entered hereon or judgment confessed against the undersigned, the undersigned further agrees to pay the holder hereof, in addition to the principal and interest then due, the costs of suit and an attorney's fee of twenty (20%) percent of such principal and interest.

The failure of the holder of this Note to exercise any right hereunder shall not be construed as a waiver of the right to exercise the same or any other right at any subsequent time.


