
**Appeal of Official Notice of Department of Transportation**

2. By letter dated August 29, 2007 Petitioners received an Official Notice of suspension of their registration of vehicles for the following:
  - a. Ford 1997 Station Wagon, License Plate Number GLS 1947, Title 519796, VIN# 1FMDU34E7VUD42148, attached hereto as Exhibit "A".
  - b. Jeep 1999 Station Wagon, License Plate Number DGW1492, Title 56327716, VIN# 1J4FF6iS9XL521965, attached hereto as Exhibit "B".
3. Petitioners as of the date of filing of this Petition have insurance in effect concerning both of these vehicles.


**MOTION TO REQUEST RESCHEDULING OF HEARING**




