


COMPLAINT

1. Plaintiff State Farm Fire and Casualty Company is an insurance company licensed and authorized to conduct business in the Commonwealth of Pennsylvania and having as one of its principal places of business the above captioned address.
2. Mary Southard is an adult individual residing at 112 E. Maple Street in Philipsburg, Pennsylvania.
3. Defendant John Duprez is an adult individual residing at the above captioned address.
4. Defendant John Duprez t/a Duprez Construction is a business entity located at the above captioned address.
5. On or about November 30, 2005 the Defendant contractor was replacing a roof at the Plaintiff's home located at 112 E. Maple Street in Phillipsburg, PA.
6. On or about November 30, 2005, Mary Southland maintained a homeowners policy of insurance with the Plaintiff State Farm Insurance Company under policy # 38-LZ-8955-5.
7. On or about November 30, 2005, The Plaintiff Liberty Mutual Insurance Company insured Plaintiffs with the above referenced homeowners policy,

said policy carrying with same, structure and contents coverages.

8. On or about November 30, 2005, The Defendant was acting individually and or by and through his agents, servants, workmen, sub-agents and/or employees to service, repair, maintain and/or re roof plaintiffs house located at the above captioned address.
9. On or about November 30, 2005 as a result of the negligent and or careless inspection, service, maintenance and or repair of the roof the defendant allowed/caused water to infiltrate the home resulting in extensive water damages to the structure and contents of Plaintiffs property.
10. The negligence of the Defendant consisted of:
 - a. Improper inspection of the roof system;
 - b. Failing to properly prepare and protect the roof during construction,
 - c. Hiring and using unskilled and/or unlicensed contractors,
 - d. Failing to warn plaintiff of the hazards associated with improperly repaired/maintained roof systems;
 - e. Failing to properly tarp the Plaintiffs home;
 - f. Failing to properly secure the roof while performing work at the residence;
 - g. Other such negligence that may be developed through continuing discovery and trial of this matter.
11. The aforesaid water damages resulted solely from the negligent acts and/or omissions on part of Defendant named herein and were due in no manner whatsoever to any act and/or failure to act on part of Plaintiffs.
12. As a result of the aforesaid water infiltration, Plaintiff State Farm Fire and Casualty Company settled the claim of Mary Southard in the amount of \$21,910.39 (said figure includes Plaintiff's first party deductible) representing fair and reasonable reimbursement for the damages sustained.
13. Pursuant to the aforesaid policy of insurance, Plaintiff State Farm Fire and Casualty Company is subrogated to Mary Southard for this loss.

WHEREFORE, Plaintiffs demand judgment against the Defendant in the amount of \$ 21,910.39 plus costs, interest and such other relief this Court finds equitable and just.
