
Paragraph 6. of the Complaint is denied.





NOW, comes the Defendant/Appellee, Bill Craig who hereby avers as follows:


1. The Plaintiff has filed a second Complaint, which includes 'Reply to New Mander'. The only reference Defendant can find for 'mander' is a church pipe organ manufactured in England; therefore, it is not standard legal terminology. The Defendant can only speculate that Plaintiff is addressing 'New Matter'.
2. When the Defendant filed an Answer to the first Complaint, there was no New Matter included. It was a response and clarification of items in the Complaint as is standard practice.
3. If this is the Plaintiff's New Matter, it is not divided into paragraphs, presented properly, or labeled as such.

4. In their attempt to answer New Matter, they contradict themselves in paragraphs 6 and 7. A copy of which is attached hereto and made a part hereof and marked Exhibit A.

5. Also attached is Exhibit B, which is a document from Richard Ballard. Defendant is uncertain as to whether this is a separate complaint or part of the original District Court case filed as 'Waunita Ballard, et.al.'. These two documents contradict in referencing the same District Justice Appeal Case number 2007-1825-CD.

6. The Defendant is unable to respond to the Complaint as submitted in Exhibit A and B in that he is unaware of the Plaintiff's position in this matter. The Defendant needs to know if this is New Matter, an Amended Complaint, or agreeing with Defendant as they contradict themselves within their own documents.
