



This is in response to the notice of intent to sue filed by the above named Plaintiff for the amount of \$2923.22.

In defense of the Civil Action Complaint please review the following:

I had been a long time holder of a Sears account since 1976. This account was always on time and without any problems until 1991 when as a student in LPN school and not employed my spouse decided to abandon me with a mortgage and three school age children. It was at this time my account began to fall behind. I had had my electric and phone shut off during this period, as well as having a pending sheriff's sale on my home as a result of my then spouse failing to comply with a court order to pay the mortgage. I sold my home and did manage to purchase an old home with the help of a co signer, and with the little profit from the sale, I did pay off the Sears at that time.

I did rely on the Sears account and made the minimum payment staying just above water until approximately 1998, when I had a decrease in income as the result of less child support. My bills did not decrease however, and I continued to fall behind.

I did seek a debt counselor at one point going to meet with a firm at the "Y" switches in Hollidaysburg, near Altoona. I do not remember the firm's name. They said I had to little to stretch to far. It was best that I just try to contact my creditors to request they at least stop the accumulation of the interest, which I did by letter to Sears. I did not get a response by mail and I called the 800 number on my monthly statement. I was passed to several extensions and finally was told that was not an option. I explained I would never be able to pay off this balance which at the time was \$1300.00, if they would not work with me. The answer was just simply no. I continued to pay what I could and with the

with me. The answer was just simply no. I continued to pay what I could and with the interest mounting, my usual monthly payment of \$32.00 was not even covering the interest.

I made arrangements then in 2003 with Ameridebt a credit counseling firm, who agreed to work with Sears and some other creditors I had on my behalf. I made monthly payments to Ameridebt for 2 years, with the understanding they had made arrangements with Sears to pay off the balance as per the contract I had with Ameridebt. In late 2005, I stopped receiving monthly statements from Ameridebt and I could not reach them by phone.

In March of 2006 I received a letter listing me as part of a class action suit against Ameridebt. I was advised I would be contacted when the suit was resolved. The only contact number I have for them is 1 800 862 0886 and an address of:
FTC, Consumer Response Ctr., Room 130, 600 Pennsylvania NW, Washington, D.C. 20580.

I include my pay stub and a summary of my monthly bills. I still can't make them all each month and I often find myself paying for water but not sewage, for electric and not oil. Last winter I went without heating oil from mid January until late March. I used ceramic heaters and confined myself to one room in the house.

I do not own my home or my car. I have had my car repossessed and then had to borrow from my 401K to get my car back. I had fallen behind on that payment as a result of having surgery for uterine cancer in July of 2004, and being off work for 10 weeks, due to post operative complications. I was limited to the amount I could borrow from the 401K and the balance was borrowed from a local consumer credit agency that is holding the title on the car. I then had a second surgery in March of 2005 from complications from the first and I was off work again and fell even further behind financially.

In addition having researched the statue of limitations for Pennsylvania at the advice of District Justice M. Rudella, I found it to be 4 years. My not having contact with Sears has been in excess of the four years as shown on enclosed credit report, showing the date of last activity exceeding 81 months.

I request the court please take into consideration all I have declared above and dismiss the suit on the grounds that the statue of limitations has expired.
