

3. A Bank of America credit card was issued to the defendant with account number 4427105000633549 hereinafter referred to as the credit card account.

4. Defendant accepted the credit card by making purchases, balance transfers and/or cash advances.

5. Monthly statements were sent to defendant each month which detailed the charges and credits made to the credit card account for the prior month.

6. The balance due on the credit card account is \$3,735.53.

7. Defendant did not pay the balance due on the credit card account in full upon receipt of the monthly billing statements and also did not make the required minimum monthly payment set forth in the monthly billing statement. As such, defendant is in default on the credit card
