**PETITION FOR TRANSFER OF VEHICLE TITLE**

NOW COMES, Quality Veneer Corporation, Petitioner above named, and by its Attorneys, Belin, Kubista & Ryan, petitions the Honorable Court as follows:

1. Petitioner is Quality Veneer Corporation, a Pennsylvania corporation having its principal place of business at 200 Chester Street, Clearfield, Pennsylvania, 16830.
2. On or about August 6, 2004, a certain Ford 8000 Crane truck having Pennsylvania Title Number 49422895001 and Vehicle Identification Number W80DV836006 was sold by the Clearfield County Sheriff at the suit of Clearfield Bank & Trust Company to No. 03-1037-CD. The said vehicle was sold to Clearfield Bank & Trust Company as evidenced by a true and correct copy of the Bill of Sale attached hereto, marked Exhibit "A" and incorporated herein by reference as if set forth at length.
3. Notice of the Sheriff's sale was made to the prior owner of said vehicle as evidenced by the Sheriff's Return filed to No. 03-1037-C.D. indicating that notice was served upon the prior owner by the Clearfield County Sheriff's Office on August 6, 2004, at 8:50 a.m.
4. Subsequently, the said vehicle was purchased from Clearfield Bank & Trust Company by the Petitioner for the sum of \$9,000.00, as evidenced by the letter from Lori A. Kurtz, Collection Manager of Clearfield Bank & Trust Company dated September 12, 2007, a true and correct copy of which is attached hereto, marked Exhibit "B" and incorporated herein by reference as if set forth at length.

5. The title to the said vehicle was never transferred to Clearfield Bank & Trust Company, and further was never transferred to Petitioner who has been in rightful possession of the said vehicle since the time of the aforesaid sale.

6. In order to accomplish the transfer of the title into the name of Petitioner, the Pennsylvania Department of Transportation requires a certified copy of an Order from this Court directing that the said title be transferred.

WHEREFORE, Petitioner requests that the Honorable Court enter an Order awarding ownership of the said vehicle to Petitioner and extinguishing any right, title and interest of any other person to said vehicle.

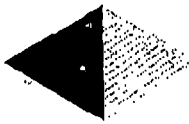




