**ORDER GRANTING PETITION TO ENFORCE FOREIGN TENNESSEE
JUDGMENT IN PENNSYLVANIA**

This matter is before the Court upon the Plaintiff's Petition To Enforce her Foreign (Tennessee) Judgment against the Defendants. After a review of all submissions on file with the Court as of the date of entry of this Order, the Court finds that the Defendants were properly served with process pursuant to the appropriate laws of the State of Pennsylvania. Accordingly, the Clerk of this Court should register and authenticate the foreign judgment previously entered by the General Sessions Court for Davidson County, Tennessee, Civil Division, at Nashville, Case No. 02GC-3041, on February 11, 2002. Said foreign judgment is a money judgment for \$3,080.00 against the Defendants in favor of the Plaintiff.


2. That Plaintiff is entitled to post-judgment interest at the statutory rate. It begins to accrue said interest as of the date of entry of this Order.

PETITION TO ENFORCE FOREIGN JUDGMENT

COMES NOW, the Plaintiff, SANDRA KELLY, by and through her original attorney of record, Laura Tek, and does hereby give formal notice of a filing of a foreign judgment issued by the General Sessions Court for Davidson County, Tennessee, Civil Division, at Nashville, and in support thereof would show this Court the following:

1. The Plaintiff is Sandra Kelly and she is currently a citizen and resident of the State of Tennessee residing at 702 Williamsburg Drive, Hendersonville, Sumner County, Tennessee 37075.

2. The Defendants are Russell E. Perks, Jr. and wife, Sandra L. Perks. They are

currently citizens and residents of Clearfield County living at R.R. 1, Box 189, Luthersburg, Clearfield County, PA 15848-9801.

3. On or about February 11, 2002, the Plaintiff was granted a judgment against the Defendants in an action brought by the Plaintiff in the General Sessions Court for Davidson County, Tennessee, Civil Division, at Nashville, Case No. 02GC-3041. 
5. Plaintiff is entitled to have an appropriate summons issued and have a copy of this Notice and a copy of the foreign judgments served upon the Defendants.


