COMPLAINT TO ESTABLISH PATERNITY
AND FOR GENETIC TESTING

NOW COMES, ROBERT P. MALLON, Plaintiff above named, and by and through his attorneys, Belin, Kubista & Ryan LLP, requests genetic testing and to establish paternity pursuant to 23 Pa. C.S.A. Section 4343 and in support of the request states that:

1. Plaintiff is an adult individual who resides at 47 Goshen Road, Clearfield, Clearfield County, Pennsylvania.
2. Defendant is an adult individual who resides at 309 Turnpike Avenue, Apt. 3 , Clearfield, Clearfield County, Pennsylvania.
3. The parties had engaged in a relationship which allegedly resulted in Defendant becoming pregnant.
4. That Defendant indicated to Plaintiff that he was indeed the father of the child.
5. That Defendant's due date was January 2, 2008.
6. That in the months leading up to said due date, Defendant refused to communicate anything about her pregnancy to Plaintiff and then reversed her story indicating that Plaintiff may not be the father of the child.

7. That Plaintiff believes that the child is his biological child, however, he would like to have paternity testing completed to confirm the same.

8. That it is further believed that Defendant gave birth to the child and Plaintiff has no information and is unable to obtain any information pertaining to the birth of the child or the welfare of the child.

9. That Defendant was not married at the time the child was conceived and born.

10. That Defendant is not now married.

11. It is not believed that there is any custody, support or other action involving the paternity of the child now pending in any jurisdiction.


12. There has not been a determination by any court as to the paternity of the child in any prior support, custody, divorce or other action.

13. That Plaintiff agrees to pay all costs associated with the genetic testing directly to the testing facility in accordance with the procedures established by that facility.

14. That Plaintiff is concerned that Defendant may give the child up for adoption or take such other measures regarding the child and he wishes to determine paternity.

WHEREFORE, Plaintiff requests Your Honorable Court to enter an Order placing a rule upon Defendant to show cause why she should not be directed to submit to genetic testing and to make the child available for genetic testing.






NOW, this 11th day of February, 2008, the parties having agreed to the entry of this Order, it is the ORDERED of this Court as follows:



3. The cost for the testing shall be paid by Plaintiff.
