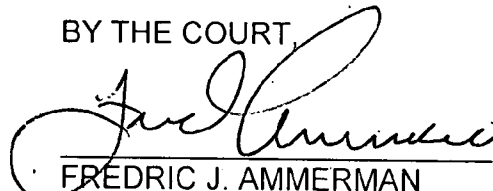

ORDER

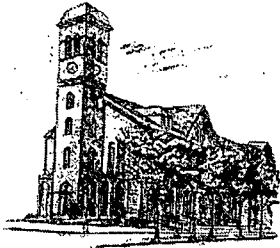
