JOINT PETITION TO COMPROMISE A MINOR'S CLAIM

TO THE HONORABLE JUDGE OF SAID COURT:

RAVI HARLALKA, parent and natural guardian of NANDINI HARLALKA, and
NANDINI HARLALKA, a minor, pro se, and 21ST CENTURY INSURANCE by and through
their undersigned counsel, Marks, O'Neill, O'Brien and Courtney, P.C., Adam G. Anderson,
Esquire, and Grant H. Hackley, Esquire, pursuant to Pennsylvania Rules of Civil Procedure 2039
jointly petition this Honorable Court for leave to compromise the claim of Nandini Harlalka, a
minor, against Defendant, Ravi Harlalka, and assigns therefore the following reasons:

1. Nandini Harlalka is a minor, born July 7, 2006.
2. Nandini Harlalka is in the care of her parent and natural guardian, Ravi Harlalka,
who resides in Canada, 1514-125 Bamburgh Circle, Scarborough, Ontario, MIW3G4.
3. At the time of the incident herein described, Ravi Harlalka had abandoned his
residence in the State of Ohio, and was in transit to a new residence in the State of New Jersey.

4. This action arises out of an automobile accident on September 9, 2007, in which Ravi Harlalka, was driving a motor vehicle in an easterly direction on Interstate 80 in Clearfield County, Pennsylvania.

5. Defendant Ravi Harlalka was traveling at a normal highway rate of speed when the vehicle left the roadway of Interstate 80 and overturned.

6. Minor Nandini Harlalka, date of birth July 7, 2006, was a passenger in the vehicle, and was wearing a restraint device, but suffered a one centimeter laceration to the scalp caused by the accident.

7. Minor Nandini Harlalka was airlifted by helicopter to Altoona General Hospital, where she was treated and found to be in good condition excepting the scalp laceration.

8. Minor Nandini Harlalka incurred numerous medical bills as a result of the accident and the resulting airlift and emergency room visit.

9. These expenses include but are not limited to \$11,032.00 as a result of the airlift, \$38.00 as a result of emergency room x-ray services, and \$6,322.20 for various other emergency room services for a total of \$17,392.20.

10. Defendant Ravi Harlalka is insured by 21st Century Insurance, Policy Number 5815463, with a limit of insurance of \$100,000.

11. Defendant Ravi Harlalka and 21st Century Insurance have agreed to a settlement amount of \$25,000 to resolve this matter, pursuant to claim number 731248.

12. Defendant Ravi Harlalka is unrepresented by counsel, but has provided informed consent to the compromise, in the knowledge that Attorneys Anderson and Hackley are acting on behalf of insurer.

13. Medical expenses remain outstanding, and it is the parties' intent that a portion of the settlement amount of \$25,000 be used to defray these costs.

14. Those expenses to be paid from the settlement amount of \$25,000 are:

(a) \$11,032.00 incurred by the airlift;

(b) \$736.20 remaining of the 6,322.20 incurred as a result of the emergency room visit, which may be further defrayed by the primary medical insurer to leave a potential final outstanding balance of \$149.00; and

(c) \$38.00 incurred as a result of x-rays taken and not otherwise billed.

(d) The settlement funds to be used for outstanding medical expenses shall not exceed the total of the preceding amounts, \$11,806.20.

15. As Nandini Harlalka and her natural guardian, Defendant Ravi Harlalka, are not being represented in this matter by Attorneys Anderson and Hackley, no attorney's fees have accrued against the settlement sum.


16. The parties believe the above is a fair and reasonable settlement of the matter in light of the medical expenses incurred and the nature of the relationship of the parties and the circumstances of the accident.

17. Pursuant to Pennsylvania Rule of Civil Procedure 2039, attached are exhibits including a statement of counsel that this settlement is desirable, a description of the services rendered, and a statement that because fees were not incurred by Defendant, the fees assessed were reasonable (Exhibit A).


18. Also attached as an exhibit is a statement of the doctor, by way of medical reports, who attended to the minor concerning her injuries and prognosis (Exhibit B).




You have been diagnosed with a minor head injury.

A minor head injury means that although you DID have trauma to your head, you did not seem to have had a serious injury to your brain. You DID NOT suffer a concussion. A concussion is a slightly more severe form of head injury in which the victim may have lost consciousness for a period of time and demonstrates some evidence of brain injury.

In the absence of serious trauma and either no loss of consciousness or a very brief loss of consciousness,

X-Rays and CT scans are usually unnecessary.

Treatment includes mild pain medications and observation at home. Narcotic or strong pain medications are

usually not necessary. In most cases, acetaminophen (Tylenol) or ibuprofen (Advil or Motrin) should manage your pain adequately.

After a minor head injury, mild headache may last for days.

Over the next 24 hours:

- Stay with family or friends that can observe your behavior.
- Avoid alcohol or drugs.

YOU SHOULD SEEK MEDICAL ATTENTION IMMEDIATELY, EITHER HERE OR AT THE NEAREST EMERGENCY DEPARTMENT, IF ANY OF THE FOLLOWING OCCURS:

- Worsening severe headache.
- Numbness, tingling, or weakness in your arms or legs.
- Fever, neck pain, change of behavior.
- Vomiting, difficulty walking or changes in vision.
- Difficulty waking from sleep with increased confusion.

SEATBELTS: There is no doubt that seatbelts save lives. Every day in the Emergency Department we see people driving without seatbelts are more severely hurt. We always buckle up. Please do the same!

JOINT PETITION TO AMEND THE ORDER APPROVING THE SETTLEMENT

TO THE HONORABLE JUDGE OF SAID COURT:

Ravi Harlalka, parent and natural guardian of Nandini Harlalka, and Nandini Harlalka, a minor, pro se, and 21ST Century Insurance by and through their undersigned counsel, Marks, O'Neill, O'Brien and Courtney, P.C., Adam G. Anderson, Esquire, and Grant H. Hackley, Esquire, jointly petition this Honorable Court for leave to amend the Order of Court approving the settlement of Nandini Harlalka, a minor, and assigns therefore the following reasons:

1. Nandini Harlalka is a minor, born July 7, 2006.
2. Nandini Harlalka is in the care of her parent and natural guardian, Ravi Harlalka, who resides in Canada, 1514-125 Bamburgh Circle, Scarborough, Ontario, MIW3G4.
3. At the time of the incident herein described, Ravi Harlalka had abandoned his residence in the State of Ohio, and was in transit to a new residence in the State of New Jersey.
4. This action arises out of an auto accident on September 9, 2007, in which Mr. Harlalka was driving a motor vehicle eastbound on I-80 in Clearfield County, Pennsylvania.
5. Defendant Ravi Harlalka was traveling at a normal highway rate of speed when the vehicle left the roadway of Interstate 80 and overturned.

6. Minor Nandini Harlalka, date of birth July 7, 2006, was a passenger in the vehicle, and was wearing a restraint device, but suffered a one centimeter laceration to the scalp.

7. Minor Nandini Harlalka was airlifted by helicopter to Altoona General Hospital, where she was treated and found to be in good condition excepting the scalp laceration.

8. Minor Nandini Harlalka incurred numerous medical bills as a result of the accident and the resulting airlift and emergency room visit.

9. Pursuant to Pennsylvania Rule of Civil Procedure 2039, this Honorable Court, upon hearing, approved a settlement agreement between Defendant's insurer and the minor, Nandini, on July 9, 2008. (See attached Exhibit A).

10. The minor's medical bills have been satisfied. Funds remain in the amount of approximately \$13,194 USD which are required to be deposited into a Federally insured account in the minor's name

11. Defendant is not a United States citizen, and at present is unable to enter the United States.

12. Due to various visa requirements, Homeland Security regulations and his inability to enter the United States, Defendant is unable to establish an account for the minor that is guaranteed by the Federal Deposit Insurance Corporation, as required by the current Order.

13. However, Defendant Ravi Harlalka is able to establish an account that is guaranteed by the Canada Deposit Insurance Corporation, an entity whose purpose is identical to the FDIC.

14. In a CDIC account, the funds would accrue interest at a comparable rate to funds in an account at an FDIC-insured bank in the United States, and the funds are capable of being marked for withdrawal by Nandini only, upon reaching the age of 18.


15. Defendant Ravi Harlalka is unable to otherwise establish an account in which to set the funds deemed to be for Nandini aside.

3. At the time of the incident herein described, Ravi Harlalka had abandoned his residence in the State of Ohio, and was in transit to a new residence in the State of New Jersey.

4. This action arises out of an automobile accident on September 9, 2007, in which Ravi Harlalka, was driving a motor vehicle in an easterly direction on Interstate 80 in Clearfield County, Pennsylvania.

5. Defendant Ravi Harlalka was traveling at a normal highway rate of speed when the vehicle left the roadway of Interstate 80 and overturned.

6. Minor Nandini Harlalka, date of birth July 7, 2006, was a passenger in the vehicle, and was wearing a restraint device, but suffered a one centimeter laceration to the scalp caused by the accident.

7. Minor Nandini Harlalka was airlifted by helicopter to Altoona General Hospital, where she was treated and found to be in good condition excepting the scalp laceration.

8. Minor Nandini Harlalka incurred numerous medical bills as a result of the accident and the resulting airlift and emergency room visit.

9. These expenses include but are not limited to \$11,032.00 as a result of the airlift, \$38.00 as a result of emergency room x-ray services, and \$6,322.20 for various other emergency room services for a total of \$17,392.20.

10. Defendant Ravi Harlalka is insured by 21st Century Insurance, Policy Number 5815463, with a limit of insurance of \$100,000.

11. Defendant Ravi Harlalka and 21st Century Insurance have agreed to a settlement amount of \$25,000 to resolve this matter, pursuant to claim number 731248.

12. Defendant Ravi Harlalka is unrepresented by counsel, but has provided informed consent to the compromise, in the knowledge that Attorneys Anderson and Hackley are acting on behalf of insurer.

13. Medical expenses remain outstanding, and it is the parties' intent that a portion of the settlement amount of \$25,000 be used to defray these costs.

14. Those expenses to be paid from the settlement amount of \$25,000 are:

- (a) \$11,032.00 incurred by the airlift;
- (b) \$736.20 remaining of the 6,322.20 incurred as a result of the emergency room visit, which may be further defrayed by the primary medical insurer to leave a potential final outstanding balance of \$149.00; and
- (c) \$38.00 incurred as a result of x-rays taken and not otherwise billed.
- (d) The settlement funds to be used for outstanding medical expenses shall not exceed the total of the preceding amounts, \$11,806.20.

15. As Nandini Harlalka and her natural guardian, Defendant Ravi Harlalka, are not being represented in this matter by Attorneys Anderson and Hackley, no attorney's fees have accrued against the settlement sum.


MINOR HEAD INJURY

You have been diagnosed with a minor head injury.

A minor head injury means that although you DID have trauma to your head, you did not seem to have had a serious injury to your brain. You DID NOT suffer a concussion. A concussion is a slightly more severe form of head injury in which the victim may have lost consciousness for a period of time and demonstrates some evidence of brain injury.

In the absence of serious trauma and either no loss of consciousness or a very brief loss of consciousness, X-Rays and CT scans are usually unnecessary.

Treatment includes mild pain medications and observation at home. Narcotic or strong pain medications are




