

AND NOW, comes the Plaintiff, by and through its attorneys and the law firm of Wolpoff & Abramson, LLP, and files this Complaint and in support avers as follows:

1. Plaintiff is PALISADES COLLECTION,L.L.C. ASSIGNEE OF NISSAN , 210 Sylvan Avenue Englewood Cliffs, NJ 07632.
2. Defendant, TINA DUNSMORE, is an adult individual with a last known address of 12532 Tyrone Pike Curwensville, Clearfield County, PA 16833.
3. An installment loan was issued to Defendant(s) for the purchase of an automobile.
4. The Defendant(s) agreed to be responsible for payment of interest and all court and collection costs incurred in the event of default.
5. That the Defendant(s) defaulted under the terms of the loan.

6. As of the date of this Complaint, the remaining balance due, owing and unpaid on Defendant's loan balance is the sum of \$12,387.33. A true and correct copy of a Statement of Account identifying the balance due and owing is attached hereto, incorporated herein, and marked as Exhibit "A".
