

### **COMPLAINT**

NOW COMES, the plaintiff by and through its Attorney, Marjorie DeSanto Barlow, Esquire and hereby complains as follows:

1. The Plaintiff is AMERICAN CREDIT COLLECTIONS, LLC, a Pennsylvania Corporation with offices located at P.O. Box 264, Taylor, Lackawanna County, Pennsylvania.
2. The defendant is CONNIE L SROKA competent individual, who is a citizen of the United States and who currently, resides at 416 Knarr Street, Du Bois, in Clearfield County, Pennsylvania.
3. Defendant received a credit card with HOME SHOPPING NETWORK bearing the account number (4417124172371772).
4. Defendant made use of said credit card and has a current balance due of Eighteen Thousand Eight Hundred and Four Dollars and Seventy-Five Cents (\$18,804.75) as of March 10, 2008.
5. Defendant is in default by failing to make monthly payments when due. As such, the entire balance is immediately due and payable to Plaintiff.
6. Plaintiff is entitled to the addition of interest at the rate of 25.740% per annum on the unpaid balance from March 10, 2008. (A copy of Plaintiff's STATEMENT is attached hereto, marked as Exhibit "1" and made a part hereof).
7. Although repeatedly requested to do so by Plaintiff, Defendant has willfully failed and/or refused to pay the balance due to Plaintiff.


Wherefore, the Plaintiff, AMERICAN CREDIT COLLECTIONS, LLC, prays for judgment in its favor and against Defendant, CONNIE L SROKA, individually, in the amount of Eighteen Thousand Eight Hundred and Four Dollars and Seventy-Five Cents (\$18,804.75) with continuing interest thereon at the rate of 25.740% per annum from March 10, 2008 plus costs.
