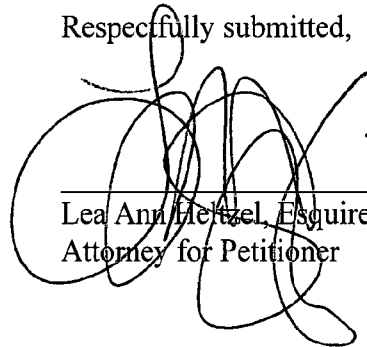
6. There are no judgments or decrees of record or any other matter of character that would be affected by the granting of this Petition.

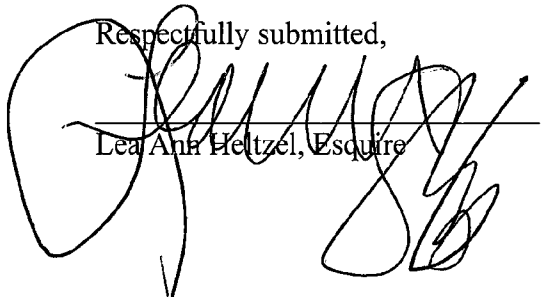
Motion for Telephone Testimony

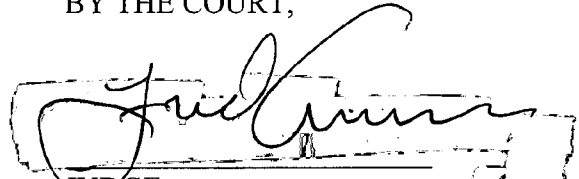

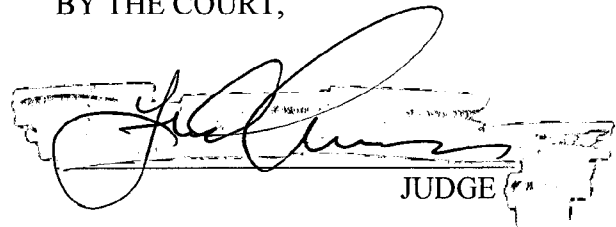

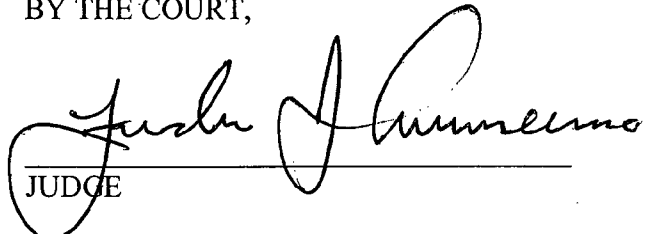
