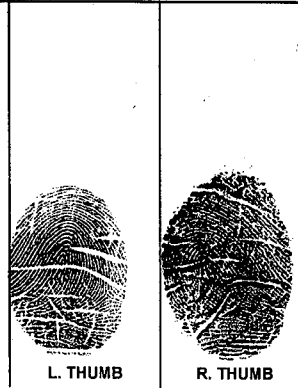

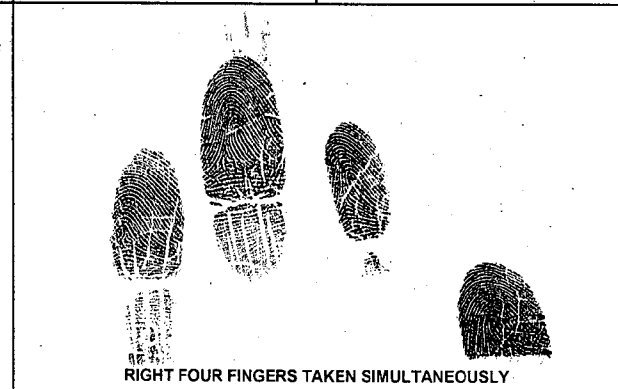


LEFT FOUR FINGERS TAKEN SIMULTANEOUSLY
