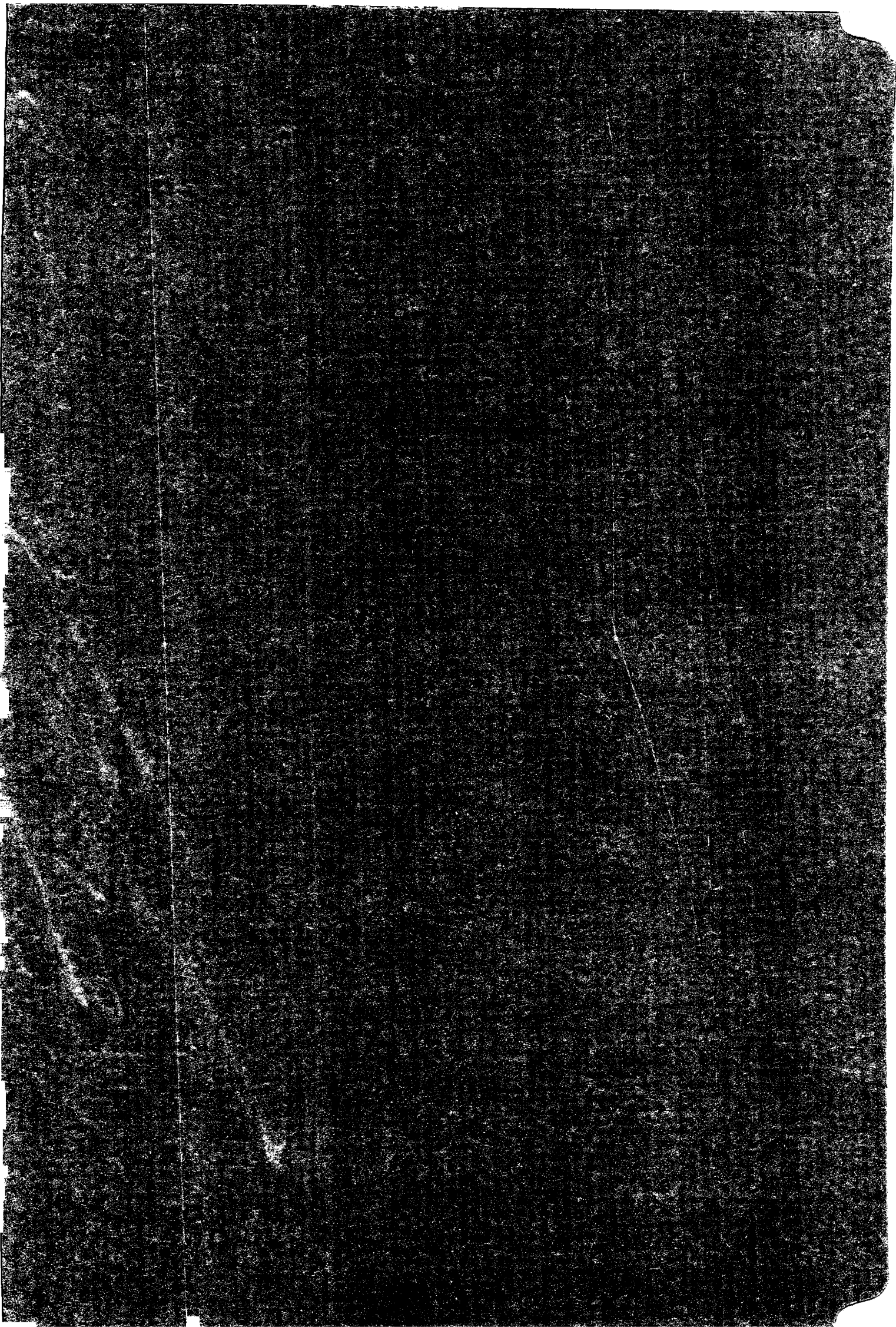


CIVIL ACTION COMPLAINT

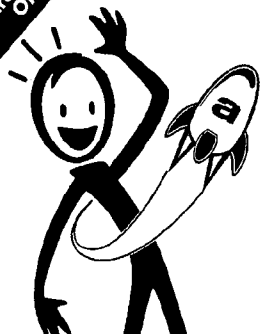
