6. Plaintiff is entitled to the addition of interest at the rate of 29.200% per annum on the unpaid balance from April 25, 2008 . A copy of Plaintiff's STATEMENT is attached hereto, marked as Exhibit "1" and made a part hereof.

7. Although repeatedly requested to do so by Plaintiff, Defendant has willfully failed and/or refused to pay the balance due to Plaintiff.

Wherefore, the Plaintiff prays for judgment in its favor and against Defendant , GARY D CATHCART , INDIVIDUALLY , in the amount of \$1466.98 with continuing interest thereon at the rate of 29.200% per annum from April 25, 2008 plus costs.






