

TO THE HONORABLE FREDRIC J. AMMERMAN, PRESIDENT JUDGE OF SAID
COURT:

AND NOW, come the Petitioners, SEAN M. FLANDERS and STARR M. FLANDERS, by and through their attorneys, GLEASON, CHERRY AND CHERRY, L.L.P., and request that Your Honorable Court order a change of names for the above-named minor children, pursuant to 54 Pa.Cons.Stat.Ann. Section 701, *et seq.*, and in support thereof, assert the following:

1. Your Petitioners, SEAN M. FLANDERS and STARR M. FLANDERS, are husband and wife, who reside at 920 Holborn Road, Streetsboro, Ohio 44241.
2. That your Petitioner, STARR M. FLANDERS, prior to her marriage to your Petitioner, SEAN M. FLANDERS, was married to Richard Clinton Bush and as a result of said marriage, two children were born, namely, SKYE ALEXANDRYA BUSH, a female child born on March 24, 1992, and PEYTON TYLER BUSH, a female child born on July 8, 1993.
3. That your Petitioner, STARR M. FLANDERS, and the said Richard Clinton Bush were divorced and at one time the two minor children resided with Richard Clinton Bush in McKean County, Pennsylvania.

4. That your Petitioner, STARR M. FLANDERS, filed a Complaint for Emergency Custody of both girls on March 15, 2002, and has had primary physical custody of both girls by Order of Your Honorable Court issued that date.
5. That as a result of the incidents leading to the filing of the Emergency Custody Complaint in 2002, neither child has seen her father nor had any contact with him since that time.
6. That Richard Clinton Bush has made no attempt to secure family counseling as ordered by Your Honorable Court nor has he taken measures to protect the minor children from further abuse by his step-son while they are in his custody and; as a result, the girls have never been back to their father's home in McKean County nor has he ever made any effort to come to their home to see them.
7. That the minor children are 16 and 15 years of age, respectively, and desire to assume the same last name as their mother and their mother's husband and to have the same last name as their little sister with whom they reside.
8. That your Petitioners have reached the conclusion individually that a change of name would be in the best interests of the minor children and have brought this Petition as a result of the minor children requesting that their names be changed.
9. That Your Honorable Court is the last court who has exercised jurisdiction over the custody of the minor children and the parties continue to have on-going contacts in Clearfield County, Pennsylvania.
10. There are no judgments or decrees of like character of record against either of the minor children either in the Commonwealth of Pennsylvania or in the State of Ohio.


