6. Defendant has refused to pay Plaintiff for the services performed, and the parts provided to him in the amount of \$1,028.00.



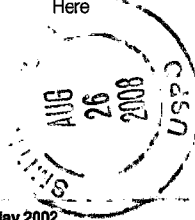
