AND NOW, comes Plaintiff, CAPITAL ONE BANK (USA), N.A., by and through its attorney, Paul J. Klemm and the law offices of Nudelman, Nudelman & Ziering, P.C., and files the following **Complaint in Civil Action** and in support thereof aver as follows:

1. Plaintiff, CAPITAL ONE BANK (USA), N.A., is a corporation licensed to do business in the State of Pennsylvania.
2. Defendant, ROBERTA J MCGARY, is an individual and citizen of the Commonwealth of Pennsylvania, who is believed to currently reside at , 845 STATE ST, CURWENSVILLE PA 16833-1038.
3. Defendant, MCGARY ELECTRICAL & PLUMBING, is an individual and citizen of the Commonwealth of Pennsylvania, who is believed to currently reside at 1293 GRICE RD, OLANTA PA 16863-8012.

4. At the special insistence and request of the Defendants, Defendants were issued a credit card by CAPITAL ONE BANK (USA), N.A., account number 4802137108884919.

5. The Defendants are responsible for an unpaid balance in the amount of \$5,919.03 and interest in the amount of \$1,905.96.

6. Plaintiff has made demand to Defendants for \$7,824.99, but Defendants have willfully failed and/or refused to reimburse Plaintiff for the aforesaid sum due.

Wherefore, Plaintiff demands Judgment in its favor and against the Defendants in the amount of \$7,824.99, plus attorney fees of \$1,302.19 and interest from the date of breach, with continuing interest thereon at the legal rate from the date of Judgment plus anticipated court costs. 
