PETITION FOR CHANGE OF NAME


AND NOW, comes your Petitioner, Scott Peters, by and through his attorneys,
NEISWENDER & KUBISTA and sets forth the following Petition for Change of Name, and in
support thereof would aver as follows:

1. That Petitioner is Scott Peters, an adult individual currently residing at 321 Alton Street,
Apartment 3, Danville, Pennsylvania 17821.
2. That the Petitioner is the natural father of Raegan Nichole Coleman, born April 25, 2002.
3. That the natural mother of Raegan Nichole Coleman is Jessica Coleman currently
residing at 60 Redwood Drive, Penfield, Clearfield County, Pennsylvania 15849.
4. That upon the child's birth, Raegan Nichole Coleman was given the name of her natural
mother.
5. That the Petitioner and Respondent were never married.
6. That there is a Custody Order in effect dated May 12, 2008, wherein Paternal
Grandparents, John and Gale Peters were granted primary physical custody subject to
periods of custody with natural father, Scott Peters and maternal grandmother, Susan J.
Dale. *Attached hereto and marked Exhibit A is a copy of the said Custody Order.*
7. That Respondent, Jessica Coleman does not have contact with the child.

8. That the child is closely bonded with your Petitioner and the members of his family whom have the surname Peters.
9. That the Petitioner is desirous of legally changing the name of Raegan Nichole Coleman to Raegan Nichole Peters in order that the child bear her natural father's name.
10. That the natural father, Petitioner herein took affirmative steps to establish custodial rights to the child.
11. That the best interest of the child would be served by the child having the last name of her biological father and the paternal grandparents who have primary physical custody of the child.
12. That Paternal Grandparents and Respondent are in agreement with the child's name being changed to Raegan Nichole Peters.
13. That there are no judgments or decrees of record or any other matter of like character against Raegan Nichole Coleman.

WHEREFORE, Petitioner, Scott Peters respectfully requests Your Honorable Court pursuant to Act of December 16, 1982, P.L. 1309 No. 295 Section 2 (54) Pa. C.S.A. ORDER

AND NOW, this 12th day of May, 2008, upon the
agreement of the parties, it is ORDERED as follows:

1. John Peters and Gale Peters, (Paternal Grandparents), Susan J. Dale (Maternal Grandmother) and Scott Peters (Father) shall share joint legal custody of the minor child, Raegan Nichole Coleman, born August 25, 2002. Shared legal custody is defined as the legal right to make major decisions affecting the best interests of the child, including, but not be limited to, the right of the parties to obtain, upon request, report cards and other relevant information concerning the progress of the child in school as well as all medical, dental, ocular, psychological and counseling information pertaining to the child. A copy of this Order shall be sufficient to enable any school official and any medical, dental, ocular, psychological or counseling provider to release information or copies thereof to either party. It is understood that this paragraph shall in no way delay the parent having custody to seek emergency medical treatment for the child. In the event that the child should become ill or injured to the extent that she would require medical treatment by a doctor or hospital, the party in possession shall

immediately notify the other party of the situation. In addition, it is understood by both parents, that they shall communicate fully with the other in an effort to assure that all directives pertaining to the minor child from physicians, dentists, and teachers are followed absolutely and all information pertaining to any prescriptions the child is taking is exchanged between the parties.

2. The Paternal Grandparents, John Peters and Gale Peters shall have primary physical custody of the minor child subject to the Maternal Grandmother, Susan J. Dale's periods of partial custody as follows:

- a) Every Tuesday from 3:00 p.m. to 6:30 p.m.;
- b) Every other weekend from Friday at 3:00 p.m. to Sunday at 4:00 p.m.; and
- c) At other times as the parties may agree.

3. The Paternal Grandparents, John Peters and Gale Peters shall have primary physical custody of the minor child subject to the Father, Scott Peter's periods of partial custody as follows:

- a) Every Tuesday from 6:30 p.m. to Friday at 3:00 p.m.; and
- b) At other times as the parties may agree.

4. The Maternal Grandmother and Father shall appropriately supervise the minor child at all times during their periods of partial custody.

5. Unless otherwise agreed upon by the parties, the parties shall share transportation in that the party who is to obtain custody of the child shall provide transportation.

6. The parties shall have reasonable telephone contact with the child while in the custody of the other party.

7. The parties shall keep each other informed of any changes in address or telephone numbers within 48 hours.

8. Neither party shall consume any illegal drugs or alcohol during their periods of custody.

9. The parties nor members of their extended families shall malign or speak in a derogatory manner about the other party in the presence of the child nor will he or she permit anyone else to do so. Each party will exercise his or her best efforts to promote a healthy relationship between the child and the other parent and the other parent's family. The parties are directed to conduct themselves in a reasonable and appropriate manner at all times during their interactions with each other and their family members concerning the custody of the child and issues relating to the child's care and nurturance. Further, neither party shall be permitted to discuss custodial or other adult matters with the child.


10. The parties are to be notified immediately by one another of any medical emergency concerning the child.
