4. Defendant made use of said credit card and currently has a balance due and owing to Plaintiff, as of July 23, 2008 , in the amount of \$8234.14 .


5. Defendant is in default by failing to make payments when due.



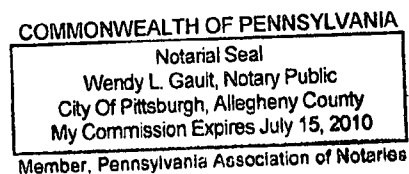


