4. Defendant made use of said credit card and has a current balance due of \$1069.78 , as of July 29, 2008 .

5. Defendant is in default by failing to make monthly payments when due. As such, the entire balance is immediately due and payable to Plaintiff.

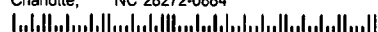

<p><b>1. How to Avoid a Finance Charge.</b></p> <p><b>† a.
