**NOTICE OF LAND USE APPEAL**

AND NOW, Gary L. Berkley, Appellant, by and through his attorneys, Caldwell & Kearns, P.C., files this Notice of Land Use Appeal, appealing from the decision of the Board of Supervisors of Cooper Township, Pennsylvania, granting a subdivision approval on the grounds set forth below.

1. Appellant, Gary L. Berkley, (hereinafter "Berkley") is an adult individual, currently residing at 1395 German Road, Drifting, Cooper Township, Clearfield County, Pennsylvania, 16834.
2. Berkley is the owner of certain real estate located at 1395 German Road, Cooper Township, Clearfield County (hereinafter the "Subject Property").
3. The Appellee is the Board of Supervisors of Cooper Township.
4. On or about September 2, 2008, the Board of Supervisors of Cooper Township (hereinafter the "Board") issued a decision in regard to the Application of Allen and

Roger Larson, approving the subdivision of Mountain View Center, along German Road. A copy of the Board of Supervisor's Meeting Minutes is attached hereto as Exhibit "A". A copy of the subdivision plan has been requested, and will be provided to the Court upon receipt.

5. The proposed Subdivision Plan encompasses an area of land owned by Appellant.
6. Appellant instituted an Action to Quiet Title against the Shive Family on or about April 18, 2005, in the Court of Common Pleas of Clearfield County, Pennsylvania, at Docket No. 2005-582-CD.
7. By approving the subdivision plan, which includes land owned by Appellant and which is the subject of the quiet title action, the Board:
  - a. erred as a matter of law;
  - b. abused its discretion;
  - c. acted arbitrarily and capriciously; and/or
  - d. acted contrary to law and evidence.
8. Appellant reserves the right to supplement this appeal once he has had adequate opportunity to review the approved subdivision plan.

WHEREFORE, it is respectfully requested that this Court reverse the cited action of the Board of Supervisors of Cooper Township, and direct that the subdivision application which is the subject of this appeal be denied, or, in the alternative, that the Board stay the approval of the Subdivision Plan, pending the outcome of litigation between Appellant and the Shive Family, or, in the alternative, remand this matter to the Cooper Township Board of Supervisors for further proceedings.

**Public Input**

Randy Killion addresses the supervisors about a problem with unattended burning in his neighborhood. He said the land owner next to him has been burning all kinds of garbage 24 hours a day. He explained that he has been keeping a record of the burning since June 27. He said they can not open windows or run an air conditioner because of an excessive burning. The burning is also unattended. The burning could be started in the middle of the night and smolder for days. His wife has allergies and is often bothered by having a hard time breathing because of the smoke.

Randy asked if the supervisors would consider a burning ordinance. He has provided a burning ordinance that is in force at Decatur Township.

Mr. Killion also asked about Charles Engelman. Has he responded to any of the letters the supervisors have sent?

There were some comments from the public about Mr. Engelman wanting to have a meeting via telephone. And that he could not attend the meeting due to working but was willing to pay for the call and conduct the meeting over the telephone. But that was not favored by the supervisors. Other comment by the public was made about why he would want to be a supervisor because there is more to being a supervisor than just attending the meetings. Supervisor Josephson and Saggese both do more than just attend the meetings. Both supervisors have other responsibilities but still stay active with the every day business of the township. Supervisor Josephson said the township has sent two certified letters to Mr. Engelman and have gotten no response. Another comment was made that Mr. Engelman needs to come to a meeting and justify himself. Mr. Killion would like to be advised on the situation and if there is something he could do please let him know.

Susan Cowder asked if a member of each organization involved with the township have a representative present at the township meeting and give a report. She said she could not attend all the meeting because of her health but would like to be informed on the activities of each authority or organization. Supervisor Josephson said the Progress always has a report in the newspaper on each meeting. Supervisor Saggese said the township receives meeting minutes from each organization and said we could maybe have copies available for the public at the supervisors meeting.

Ms Cowder also had a second comment about the rats at the Truck shop in Kylertown. She asked if there was an ordinance that would be written about the truckers only being able to be parked at the truck stop for a period of 24 hours. Someone commented that they thought DEP had to regulate that. Supervisor Josephson said he didn't think there was anything the township could do about the problem. Ms. Cowder said her neighbor put out rat poison and had 17 rats in their backyard dead. A suggestion was to contact the Truck shop or DEP concerning the problem.

**Public Input (Cont'd)**

Gary Berkley commented about the recent 4 wheeler accident in the township. He asked if there was something the supervisors could do about the problem with the 4 wheelers running on the main roads in the township. His concern is for the common person driving down the road and possibly having an accident and being charged for the accident and being sued for the accidents. Mr. Berkley wants to know if the township could have an ordinance for controlling the 4 wheelers. A discussion was held on the problems and who would be responsible to control the 4 wheelers. Supervisors said they would have the township police get involved and may need to cite the wheelers for improper usage and suggest the citizens call the state police.

Anita & Lester Mann asked if the supervisors could sign off on the Rod & Helen Eminhizer Subdivision. Ms. Mann said they just came from the Water Authority Meeting and the property needing water and sewerage was approved for the subdivision. The Planning Commission was holding on to the subdivision until approval was given. With the approval given the Supervisors signed the subdivision. Roger Larson, President of Planning Commission was present at this meeting and seen no problem with now having the approval for the water and sewage.

Allen and Roger Larson presented the Board of Supervisors with a Subdivision for Mountain View Center. The owners are just dividing the property. The three lots are non-building wavier lots. Supervisor Saggese made a motion to approve the subdivision. Supervisor Josephson seconded the motion. Motion carried. Gary Berkley stated some concern on the property lines. He stated there is a problem with property line on the Shive property line. Mr. Larson stated that they are using the existing deed and they are not trying to change property lines.

**NOTICE OF LAND USE APPEAL**

AND NOW, Gary L. Berkley, Appellant, by and through his attorneys, Caldwell & Kearns, P.C., files this Notice of Land Use Appeal, appealing from the decision of the Board of Supervisors of Cooper Township, Pennsylvania, granting a subdivision approval on the grounds set forth below.

1. Appellant, Gary L. Berkley, (hereinafter "Berkley") is an adult individual, currently residing at 1395 German Road, Driftin, Cooper Township, Clearfield County, Pennsylvania, 16834.
2. Berkley is the owner of certain real estate located at 1395 German Road, Cooper Township, Clearfield County (hereinafter the "Subject Property").
3. The Appellee is the Board of Supervisors of Cooper Township.
4. On or about September 2, 2008, the Board of Supervisors of Cooper Township (hereinafter the "Board") issued a decision in regard to the Application of Allen and

Roger Larson, approving the subdivision of Mountain View Center, along German Road. A copy of the Board of Supervisor's Meeting Minutes is attached hereto as Exhibit "A". A copy of the subdivision plan has been requested, and will be provided to the Court upon receipt.

5. The proposed Subdivision Plan encompasses an area of land owned by Appellant.
6. Appellant instituted an Action to Quiet Title against the Shive Family on or about April 18, 2005, in the Court of Common Pleas of Clearfield County, Pennsylvania, at Docket No. 2005-582-CD.
7. By approving the subdivision plan, which includes land owned by Appellant and which is the subject of the quiet title action, the Board:
  - .. erred as a matter of law;
  - .. abused its discretion;
  - .. acted arbitrarily and capriciously; and/or
  - .. acted contrary to law and evidence.Appellant reserves the right to supplement this appeal once he has had an adequate opportunity to review the approved subdivision plan.

**Public Input**

Randy Killion addresses the supervisors about a problem with unattended burning in his neighbourhood. He said the land owner next to him has been burning all kinds of garbage 24 hours a day. He explained that he has been keeping a record of the burning since June 27. He said they can not open windows or run an air conditioner because of an excessive burning. The burning is also unattended. The burning could be started in the middle of the night and smolder for days. His wife has allergies and is often bothered by having a hard time breathing because of the smoke.

Randy asked if the supervisors would consider a burning ordinance. He has provided a burning ordinance that is in force at Decatur Township.

Mr. Killion also asked about Charles Engelman. Has he responded to any of the letters the supervisors have sent?

There were some comments from the public about Mr. Engelman wanting to have a meeting via telephone. And that he could not attend the meeting due to working but was willing to pay for the call and conduct the meeting over the telephone. But that was not favored by the supervisors. Other comment by the public was made about why he would want to be a supervisor because there is more to being a supervisor than just attending the meetings. Supervisor Josephson and Saggese both do more than just attend the meetings. Both supervisors have other responsibilities but still stay active with the every day business of the township. Supervisor Josephson said the township has sent two certified letters to Mr. Engelman and have gotten no response. Another comment was made that Mr. Engelman needs to come to a meeting and justify himself. Mr. Killion would like to be advised on the situation and if there is something he could do please let him know.

Lorraine Lawder asked if a member of each organization involved with the township have a representative present at the township meeting and give a report. 





**Public Input**

Randy Killion addresses the supervisors about a problem with unattended burning in his neighborhood. He said the land owner next to him has been burning all kinds of garbage 24 hours a day. He explained that he has been keeping a record of the burning since June 27. He said they can not open windows or run an air conditioner because of an excessive burning. The burning is also unattended. The burning could be started in the middle of the night and smolder for days. His wife has allergies and is often bothered by having a hard time breathing because of the smoke.

Randy asked if the supervisors would consider a burning ordinance. He has provided a burning ordinance that is in force at Decatur Township.

Mr. Killion also asked about Charles Engelman. Has he responded to any of the letters the supervisors have sent?

There were some comments from the public about Mr. Engelman wanting to have a meeting via telephone. And that he could not attend the meeting due to working but was willing to pay for the call and conduct the meeting over the telephone. But that was not favored by the supervisors. Other comment by the public was made about why he would want to be a supervisor because there is more to being a supervisor than just attending the meetings. Supervisor Josephson and Saggese both do more than just attend the meetings. Both supervisors have other responsibilities but still stay active with the every day business of the township. Supervisor Josephson said the township has sent two certified letters to Mr. Engelman and have gotten no response. Another comment was made that Mr. Engelman needs to come to a meeting and justify himself. Mr. Killion would like to be advised on the situation and if there is something he could do please let him know.

Susan Cowder asked if a member of each organization involved with the township have a representative present at the township meeting and give a report. She said she could not attend all the meeting because of her health but would like to be informed on the activities of each authority or organization. Supervisor Josephson said the Progress always has a report in the newspaper on each meeting. Supervisor Saggese said the township receives meeting minutes from each organization and said we could maybe have copies available for the public at the supervisors meeting.

Ms Cowder also had a second comment about the rats at the Truck shop in Kylertown. She asked if there was an ordinance that would be wrote about the truckers only being able to be parked at the truck stop for a period of 24 hours. Someone commented that they thought DEP had to regulate that. Supervisor Josephson said he didn't think there was anything the township could do about the problem. Ms. Cowder said her neighbor put out rat poison and had 17 rats in there backyard dead. A suggestion was to contract the Truck shop or DEP concerning the problem.

Gary Berkley commented about the recent 4 wheeler accident in the township. He asked if there was something the supervisors could do about the problem with the 4 wheelers running on the main roads in the township. His concern is for the common person driving down the road and possibly having an accident and being charged for the accident and being sued for the accidents. Mr. Berkley wants to know if the township could have an ordinance for controlling the 4 wheelers. A discussion was held on the problems and who would be responsible to control the 4 wheelers. Supervisors said they would have the township police get involved and may need to cite the wheelers for improper usage and suggest the citizens call the state police.

Anita & Lester Mann asked if the supervisors could sign off on the Rod & Helen Eminhizer Subdivision. Ms. Mann said they just came from the Water Authority Meeting and the property needing water and sewerage was approved for the subdivision. 




