AND NOW, comes Plaintiff, CAPITAL ONE BANK USA NA, by and through its attorney, Paul J. Klemm and the law offices of Nudelman, Nudelman & Ziering, P.C., and files the following **Complaint in Civil Action** and in support thereof aver as follows:

1. Plaintiff, CAPITAL ONE BANK USA NA, is a corporation licensed to do business in the State of Pennsylvania.
2. Defendant, KRIS HASSAN, is an individual and citizen of the Commonwealth of Pennsylvania, who is believed to currently reside at , 4276 BEE LINE HWY, DU BOIS PA 15801-6512.
3. At the special insistence and request of the Defendant, Defendant was issued a credit card by CAPITAL ONE BANK USA NA, account number 5291492186072969.

4. The Defendant is responsible for an unpaid balance in the amount of \$4,212.00 and interest in the amount of \$879.63.

5. Plaintiff has made demand to Defendant for \$5,091.63, but Defendant has willfully failed and/or refused to reimburse Plaintiff for the aforesaid sum due.

Wherefore, Plaintiff demands Judgment in its favor and against the Defendant in the amount of \$5,091.63, plus attorney fees of \$926.64 and interest from the date of breach, with continuing interest thereon at the legal rate from the date of Judgment plus anticipated court costs.
