



**COMPLAINT**

AND NOW, comes the plaintiff, GARY A. SPRINGER, JR., an individual, by and through his attorney, NICHOLAS GIANVITO, ESQ., of LORENZO & GIANVITO, P.C., and presents the following Complaint, of which the facts set forth hereinafter are a true and concise summary.

1. Plaintiff, GARY A. SPRINGER, JR., is an adult individual who resides at 1306 Washington Avenue, Clearfield, Clearfield County, Pennsylvania, 16830.
2. Defendant, GEORGE W. SANKEY, is an adult individual who resides at 97 Sankey Lane, Osceola Mills, Clearfield County, Pennsylvania, 16666.
3. On November 13, 2006, plaintiff, GARY A. SPRINGER, JR., was working as a subcontractor, installing a roof on a new home that was being constructed. He was on the roof, nailing down roof trusses as the defendant, a crane operator, placed them onto the roof.
4. At the same time and location, defendant, GEORGE W. SANKEY, was operating a crane in the process of lifting roof trusses off of the ground and placing them on the roof that was being constructed. As he lifted one of the trusses, Mr. Sankey allowed the bottom cord of the truss he was lifting to touch the upper cord of one of the previously set trusses. This caused the

truss that was being lifted to dislodge from the hook and fall to the roof where plaintiff was working.

5. Plaintiff, GARY A. SPRINGER, JR., was struck on the head by the dislodged truss, which then pushed him forcefully backward. His feet caught on the roof truss that he had been nailing down, and he was left hanging upside down.

6. As a result of the above described event, plaintiff, GARY A. SPRINGER, JR., sustained the following severe and permanent personal injuries:

- a) Deep vein thrombosis/pulmonary embolism in his left calf;
- b) Left knee pain/torn ACL, MCL and cartilage damage;
- c) Post-traumatic concussive syndrome with migraine headaches;
- d) Nervous shock, anxiety and emotional upset.

7. As a result of the defendant's negligence and carelessness, plaintiff has had his health, safety and vitality impaired, and he has sustained great mental and physical pain, suffering, mental anguish, inconvenience, and embarrassment.

8. As a result of the aforementioned negligence and carelessness of the defendant, plaintiff will, in the future, be forced to endure mental and physical pain, suffering, inconvenience, embarrassment and loss of the quality of his life.

9. Plaintiff has been compelled to expend sums of money for necessary and reasonable medical services in an effort to cure and/or alleviate his aforesaid injuries, amounts of which will be supplied in discovery.

10. As a result of the aforementioned carelessness and negligence of the defendant, plaintiff will, in the future, be required to expend additional sums of money for medical care, treatment and medications necessary for the future care of his above described injuries.

11. At the time of the incident described herein, plaintiff was a self-employed contractor. Due to the injuries he sustained, he has been unable to return to employment, thereby sustaining past wage loss.

12. As a direct result of the incident described above, plaintiff's future earning capacity has been reduced, due to his above-described injuries.

**COUNT ONE**

**Gary A. Springer, Jr., an individual, Plaintiff**

**NEGLIGENCE**

13. Paragraphs one (1) through twelve (12) are incorporated herein by reference as though set forth fully and at length.

14. Defendant, GEORGE W. SANKEY, was negligent and careless in the following respects:

- a) in employing improper use of equipment and/or selection of instruments, i.e., using a home-made hook on the crane;
- b) in failing to pay proper attention to operation of machinery;
- c) in employing improper methods of truss placement;
- d) in allowing the bottom cord of the truss he was lifting to touch the upper cord of another truss, thus causing the lifted truss to dislodge and strike plaintiff.


15. The above-noted acts of negligence and carelessness were the direct and proximate cause of the injuries set forth herein above.

WHEREFORE, plaintiff demands judgment against the defendant, GEORGE W. SANKEY, in a sum in excess of Twenty-Five Thousand and 00/100 (\$25,000.00) Dollars, and/or the maximum jurisdictional amount requiring arbitration.
