PETITION FOR CHANGE OF NAME OF MINOR CHILD

The petitioner, JULIE CHRISTINE TOBIAS f/k/a JULIE CHRISTINE MARTELL (hereinafter "Petitioner"), through her under signed counsel, requests that this Court order a change of name for her minor daughter MOLLY MARIE MARTELL d.o.b. 09-09-1999, pursuant to 54 Pa Cons Stat §701 et seq, and in support thereof represents as follows:

1. Petitioner, JULIE CHRISTINE TOBIAS f/k/a JULIE CHRISTINE MARTELL, is a resident of Pennsylvania and has resided at 100 4th Avenue, Apt. 109, Curwensville, Clearfield County, Pennsylvania 16833 during the 5 years preceding the filing of this petition.

2. Petitioner was formerly married to Richard James Martell, Jr. from whom she was divorced on November 16, 2001 by order filed to Clearfield County Civil Action No. 01-1145-CD.

3. Both Petitioner and Richard James Martell, Jr. are the natural parents of Molly Marie Martell who is presently 9 years of age. A photocopy of the birth certificate for Molly Marie Martell is attached hereto as Exhibit "A" and incorporated herein by reference as if set out in full.

4. On December 3, 2001 a Notice of Election To Resume Prior Name was filed by Petitioner to Clearfield County No. 01-1145-CD pursuant to 23 Pa. C. S. §702 and Pa. C. S. §704. A copy of said notice is attached hereto as Exhibit "B" and incorporated herein by reference as if set out in full.

5. Molly Marie Martell refuses to use the surname Martell and requests of all that she be known by the surname Tobias. Such request has continued for at least a year.


6. There are no judgments or decrees of like character of record against Molly Marie Martell who is a minor person.

7. Richard James Martell, Jr. Has consented to the requested change of name as evidenced by the affidavit of consent attached hereto as Exhibit "C" and incorporated herein by reference as if set out in full.
