



APPEAL OF DETERMINATION TO RECALL DRIVER'S LICENSE

AND now, comes the Appellant, Kenneth A. Hoffman, by and through his counsel of record, Theron G. Noble, Esquire, of Ferraraccio & Noble, who aver as follows in support of APPEAL OF DETERMINATION TO RECALL DRIVER'S LICENSE:

1. That appellant is Kenneth A. Hoffman, also known as "Nick Hoffman", who does, and at all material times, unless otherwise noted, resides at 224 N. 3rd Street, DuBois, Clearfield County, Pennsylvania.
2. That appellee is the Commonwealth of Pennsylvania, Department of Transportation, upon information and belief, with appropriate address for this purpose of Office of Chief Counsel, Third Floor, Riverfront Office Center, Harrisburg, Dauphin County, Pennsylvania, 17104.

Background

3. That Appellant has a driver's license issued by the Commonwealth of Pennsylvania, believed to be number 19701204.
4. That on October 7, 2008, Mr. Hoffman experienced a medical condition in which he

fainted while grocery shopping, hit his head and for which he received medical treatment.

5. That apparently it was reported to Appellee, as is required pursuant to Pennsylvania law, specifically 75 Pa.C.S.A. §1518, that Mr. Hoffman suffers some type of medical condition which might render him incapable of safe driving.

6. That Appellee in response to said information, has issued a recall of Appellant's driver's license pursuant to 75 Pa.C.S.A. §1519(c).

Count I: Appeal of Recall Determination

75 Pa.C.S.A. §1550

7. That the averments of paragraphs 1 - 6, inclusive, are hereby incorporated as if again fully set forth at length.

8. That Mr. Hoffman has undergone and continues to undergo medical treatment, including testing, since the aforementioned incident of October 7th.

9. That upon information and belief, Mr. Hoffman's medical condition is not chronic nor likely to repeat itself such that he is capable of safe driving and should not have his driver's license recalled pursuant to 75 Pa.C.S.A. §1519(c).

10. That the information provided to Appellee by a treating physician, pursuant to 75 Pa.C.S.A. §1518, was so provided prior to a more complete and accurate assessment of Mr. Hoffman's condition, or lack thereof.

11. However, in that Mr. Hoffman's neurologist presently recommends he not drive, Mr. Hoffman does not at this time desire a supersedeas, reserving the right for such motion after further consultation with his neurologist and other physicians (which are scheduled to occur around the time his right to appeal lapses).

WHEREFORE, Appellant respectfully requests that his driver's license not be recalled.




