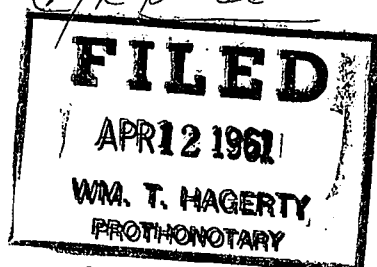

C O M P L A I N T

- (1). The plaintiff herein is a corporation organized and existing under the laws of the State of New York, with an office and place of business at 443 Park Avenue, New York 16, N. Y., where it is engaged in the business of selling Endura-Conquest Watches and Endura-Bayard Clocks.
- (2). The defendant is a corporation organized and existing under the laws of the State of Pennsylvania, with place of business at 203 DuBois Street, DuBois, Clearfield County, Pennsylvania, and is engaged in operating a retail furniture store and also sells other merchandise.
- (3). The plaintiff herein at the special instance and request of the defendant herein sold to the defendant certain goods and merchandise, as outlined on Exhibit "A" hereto attached, and made an integral part hereof, of the value of ~~\$852.80~~ \$852.80. The dates when said sales were made and the prices charged therefor are as set forth on Exhibit "A" hereto attached and made an integral part hereof.
- (4). The prices charged for said merchandise as set forth on Exhibit "A", hereto attached, are just and reasonable and are the prices which the defendant agreed to pay therefor.
- (5). The merchandise sold by the plaintiff to the defendant was duly delivered to the defendant and it has retained the same or has sold or used the same, and after repeated de-

mands for payment, the defendant has paid only \$30.00 on account and plaintiff has accepted the return of merchandise of the value of \$125.45, and while admitting the balance due, the defendant has refused to pay the same.

(6). The plaintiff avers that the defendant is not entitled to any offsets, credits or other deductions from said obligation, and the whole amount remains due and unpaid, with interest on the component parts thereof from the due dates, except as credits are set forth in the preceding paragraph hereof.

(7). The defendant in recognition of its obligation issued a promissory note to the plaintiff, a true and correct copy of which is hereto attached, marked Exhibit "B" and made an integral part hereof. Said note was duly presented for payment, but payment was refused and there is a protest fee of \$3.70 charged on account of said protest, which the plaintiff had to pay.

WHEREFORE, plaintiff brings this action to recover from the defendant the sum of \$701.05, with interest on the component parts thereof from the due dates, with costs of suit.


