

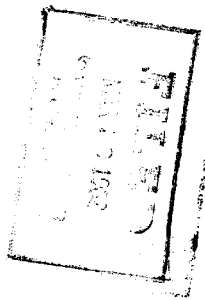


Dear Mr. Hill:
