The undersigned, jointly and severally, promise to pay to the order of THE BUDGET PLAN, INC., at its above office, the amount of loan as above stated together with interest at the following rate: Three (3) per centum per month on that part of the unpaid principal balance not in excess of One Hundred Fifty (\$150.00) Dollars; two (2) per centum per month on that part of the unpaid principal balance in excess of One Hundred Fifty (\$150.00) Dollars but not in excess of Three Hundred (\$300.00) Dollars; and one (1) per centum per month on any remainder of such unpaid principal balance, this rate to continue for a period of twenty-four (24) months from the date of this contract. Interest on any unpaid balance after twenty-four (24) months shall be payable at the rate of six (6%) per centum per annum.

Payment of principal and interest shall be made in consecutive monthly payments as above indicated, covering any unpaid balance, including interest as aforesaid, said installments being due and owing on the due date hereinabove indicated. Of each payment made the accrued interest will be first deducted at the rate specified above and the remainder will be applied to the reduction of the principal balance in accordance with the schedule furnished.

The principal amount of this obligation, or any part thereof, may be paid in advance at any time, with interest as above stated to the date of payment.

If default shall be made in the payment of any of said installments or sums due on this note, then the whole principal sum of this note, or such portion thereof as shall then remain unpaid, with interest thereon as above stated up to that time, shall, at the option of the holder of this note, become immediately due and payable without notice.

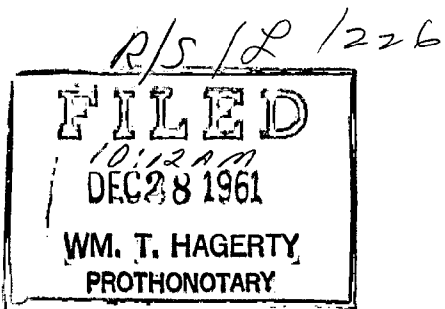
And further, we do authorize and empower any attorney of any Court of Record in Pennsylvania, or elsewhere, or the Prothonotary thereof, to appear for us and with or without declaration filed, to confess judgment against us at any time for the above sum with costs of suit, release of errors and without stay of execution; and for value received we do also waive the right and benefit of any exemption law of this or any other state, and do also waive the right of inquiry upon any Real Estate that may be levied upon to collect said judgment and consent to the condemnation thereof with full liberty to sell the same on fi. fa., with release of errors thereon, waiving all benefit or relief from any or all appraisement, stay or exemption laws of any state now in force or hereinafter to be passed.
