
NOTICE OF VIEW AND HEARING

By Court Order dated December 29, 1961, John Scollins, John D. Haines and Ben Hughes were appointed Viewers by the Court of Common Pleas of Clearfield County, Pennsylvania, for the purpose of estimating and determining the amount of damages, if any, sustained by the owner, in the condemnation by the Board of School Directors of the School District of Lawrence Township, of the following described premises situated in Lawrence Township, Clearfield County, Pennsylvania.

BEGINNING at an iron pin on the Northwest corner of Highview Village plot plan; thence by lands of William J. Hoover Estate North Three (03°) degrees Forty-nine (49') minutes East Two Hundred Eighty (280) feet to an iron pin; thence by lands of Thomas H. and Winifred N. Aughinbaugh North Eighty-three (83°) degrees Fifty (50') minutes West Three Hundred Forty and Eight tenths (340.8) feet to an iron pin; thence by land of Thomas H. Jr., and Winifred N. ORDER

NOW, December 29, 1961, Petition for Condemnation having been presented by the Board of School Directors of the School District of the Township of Lawrence and it appearing from the Petition that they have entered upon and occupied lands described in the said Petition and have set forth facts including a description by metes and bounds and the names of the owners, it is on motion of Donald R. Mikesell, Attorney for the School District of the Township of Lawrence, ORDERED AND DECREED that JOHN SCOLLINS, JOHN D. HAINES, Jr. and BEN HUGHES are hereby appointed a Jury of Viewers from the County Board of Viewers and within thirty (30) days shall fix a time for hearing when they shall view the premises provided, however, that the Petitioner shall give five (5) days' notice of the time and place for the first meeting and that the said notice to Winifred M. Aughinbaugh, Trustee, shall be by Certified Mail, Return Receipt Requested to her last known address.

On completion of the hearing and view, the Jury of Viewers shall make a true report to the Court, taking into consideration the quality and location of the improvements upon the lands taken and occupied for school purposes, and also taking into consideration the damages sustained and the benefits accruing and further shall estimate and determine what amount of damages, if any, have been sustained by the owners of such premises by reason of the taking of the said lands by the School District, and to whom said amount or amounts is payable.

REPORT OF THE JURY OF VIEWERS

To the Honorable John J. Pentz, President Judge of said Court:

The undersigned Jury of Viewers respectfully reports upon the matter deemed pertinent to the above entitled case as follows:

THE FACTS:

1. The School District of the Township of Lawrence discussed the building of an addition to the present Elementary School building at Hyde, to accomodate the children of school age and upon submitting the matter to the Department of Public Instruction at Harrisburg for approval, the Department refused to approve the plans submitted and suggested a New Elementary Six-Room building of modern construction for school purposes.

2. The School Board considered several sites in the vicinity, to wit: The Aughinbaugh tract, the Armory, and the William J. Hoover sites, finally selecting and approving part of a 37-acre tract of land, the record owner of which is Winifred M. Aughinbaugh, Trustee. After determining the quantity of land desired, efforts were made to agree upon a price for the same. Upon failure to agree upon a price, the School District decided to take the land by condemnation proceeding. It appears that the steps antecedent to the appointment of Viewers were properly taken.

3. We find that on August 7, 1961, the Board of School Directors of said district adopted a resolution providing for the acquisition of the land selected by it for school purposes, and that on August 9, 1961, said Board of School Directors did enter upon, take possession of, and occupy the land selected and designated, and marked the boundary lines thereof by erecting permanent corners in accordance with the survey made by the engineer they had employed, who made a map of the land taken, situate, lying and being in said Township of Lawrence, bounded and described as follows, to wit:

BEGINNING at an iron pin on the Northwest corner of Highview Village plot plan; thence by lands of William J. Hoover Estate North Three (3) degrees Forty-nine (49) minutes East Two Hundred Eighty (280) feet to an iron pin; thence by lands of Thomas H. and Winifred N. Aughinbaugh North Eighty-three (83) degrees Fifty (50) minutes West Three Hundred Forty and Eight-tenths (340.8) feet to an iron pin; thence by land of Thomas H. Jr., and Winifred N. Aughinbaugh South Twenty-seven (27) degrees Forty (40) minutes West for a distance of Six Hundred Eighteen (618) feet to an iron pin on the North Right-of-Way line of Township Road No. 517; thence along Right-of-Way of said road South Fifty-seven (57) degrees Nineteen (19) minutes East for a distance of Two Hundred Fifty-four and Three-tenths (254.3) feet to an iron pin; thence along the land formerly of Robert Burns North Seventy-three (73) degrees Thirty (30) minutes East for a distance of Three Hundred Ninety-two and Four tenths (392.4) feet to an iron pin; thence along the west boundary of Highview Village plot North Three (3) degrees Forty-nine (49) minutes East for a distance of Two Hundred Fifty-eight (258) feet to the iron pin the place of beginning. Containing Six and Eight tenths (6.8) acres.

4. After the appropriation a petition was presented to the Court for the appointment of Viewers to assess the damages, whereupon we were appointed. Pursuant to the Order of Court and notice given according to law we made the view and examined the premises January 24, 1962 @ 10:30 o'clock A.M., and thereafter, on January 24, 1962 @ 1:30 o'clock P.M., we held a hearing in the Grand Jury Room of the Court House on the question of damages.

5. We find that the land entered upon and taken is the property described in Paragraph 3 hereof, and that the quantity thereof is 6.8 acres; and is a part of the farm the ownership of which is conceded to be in Winifred M. Aughinbaugh, Trustee, consisting in its entirety of about 37 acres of land; there being no improvements on the premises.

6. As to the quality of the land taken, it has not been under recent cultivation, but is good farming land, fronting on Township Road No. 517, and located on the Northwest corner of built-up Highview Village, (and adjoining the 1.5 acre tract of land owned by Frederick L. Hoover, Sr., and the Heirs of William J. Hoover, i.e., Minnie Hoover, widow, Frederick L. Hoover, son, and Lois H. Read, daughter, and condemned at Condemnation Proceeding entered to No. 361, November Term, 1961 and viewed and heard concurrently herewith]. The part (6.8) acres taken for school purposes would be available for building lot purposes, but the whole tract in its entirety did not appear to have any immediate prospect of being used for such purpose.

7. At the hearing in the Grand Jury Room there appeared Donald R. Mikesell, Esq., Attorney for the School District, with Stanley R. Thompson, Secretary of the Board, and Gilbert R. Cowder and M. Austin Turner, Members of the Board, with Hugh A. Lawhead, a witness in behalf of the School District.

Also, William T. Davis, Esq., attorney for Winifred M. Aughinbaugh, Trustee, together with Donald F. Meckley, a witness in behalf of the Aughinbaugh Estate.

The official plan and survey of the land appropriated by the School District for any and all purposes, as well as the record papers in the proceeding were offered in evidence

by Donald R. Mikesell, Attorney for the Lawrence Township School District.

Clarence R. Kramer, Attorney for the William J. Hoover heirs objects generally to the proceeding in Eminent Domain contending that the matter should be heard In Equity.

The proceeding being in compliance with Section 721 of the Act of 1949, Art. VII, P.L. 30 (24 P.S.7-721) the objection was over-ruled, and exception noted.

Stanley R. Thompson, Secretary; Gilbert L. Cowder and M. Austin Turney, Members of the Board of Directors; Hugh A. Lawhead and Donald F. Meckley, witnesses were sworn, examined and cross-examined by Counsel.

#### DISCUSSION.

In determining the damages to which the owner is entitled for the taking of his property under the right of eminent domain is as to the value of the property in its entirety before and after the taking. The 6.8 acres taken by the School District is the most valuable part of the 37 acre tract; and is so located as to hinder the proper development of the property after, for any practicable use.

The testimony of the witnesses produced by both parties in interest was a matter of opinion, though they both were conversant with values in that vicinity of Lawrence Township in real estate transactions in which their clients and principals were involved. Witness Lawhead estimated the value of the whole tract before the taking @ \$4300.00, and after @\$900.00, or damage to the amount of \$3400.00. Witness Meckley valued the whole tract before the taking @ \$6500.00, and after the taking @ \$1400.00, or damage to the amount of \$5100.00.



There has been considerable improvement in that vicinity of Lawrence Township, such as Susquehanna Terrace, Country Club Hills and Highview Village at the edge of the appropriated land, with improved highways, sewerage, and utilities, except that there is a lull in home building activities at the present time.

CONCLUSION AND AWARD.

Having taken into consideration the quality and location of the of the land taken and occupied for school purposes as aforesaid, and having taken into consideration the damages sustained and the benefits accruing, we estimate and determine that damages have been sustained by the owner of said land, Winifred M. Aughinbaugh, Trustee, to the amount of \$5440.00 by reason of the taking of said land by the said school district, and that said amount is payable to her by said School District.



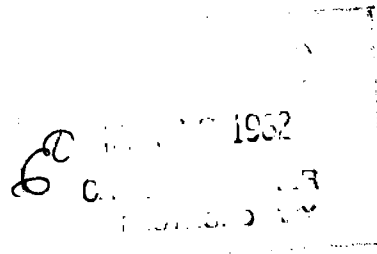
