DO HEREBY AGREE TO PAY TO THE DEPARTMENT OF PUBLIC WELFARE OF THE COMMONWEALTH OF PENNSYLVANIA, ITS
SUCCESSIONS OR ASSIGNS, OR ITS DULY AUTHORIZED AGENT, THE SUM OF Two Thousand and 00/100 Dollars
(\$ 2000.00) FOR ASSISTANCE RECEIVED

By or for me, by or for those persons for whom I am responsible under the Pennsylvania
Support Law.

The judgment to be obtained by the recording of this instrument shall be a lien upon
my real property and be collected as other judgments, except that the real and personal
property comprising my home and furnishings shall not be subject to execution on such
judgment so long as it continues to be occupied as my home or that of my spouse or
dependent children. No interest is to be added.

It is understood that my property at Rt. 322, Clearfield, Pennsylvania, which I am
purchasing from the Philipsburg Thrift Corporation under unrecorded Articles of Agreement
dated 3/21/61, shall be liable under this Agreement for repayment of all
assistance received as above, on and after 4/28/61.

I DO HEREBY AUTHORIZE THE PROTHONOTARY OF, OR ANY ATTORNEY, OF ANY COURT OF RECORD OF PENNSYLVANIA OR
ELSEWHERE, TO APPEAR FOR AND TO ENTER JUDGMENT AGAINST ME FOR THE SAID SUM, WITH OR WITHOUT DECLARATION,
WITH COSTS OF SUIT, RELEASE OF ERRORS, WITHOUT STAY OF EXECUTION. I ALSO WAIVE THE RIGHT OF INQUISITION
ON ANY REAL ESTATE THAT MAY BE LEVIED UPON TO COLLECT THIS SUM, AND HEREBY VOLUNTARILY CONDEMN THE SAME,
AND AUTHORIZE THE PROTHONOTARY TO ENTER UPON THE FIERI FACIAS MY SAID VOLUNTARY CONDEMNATION AND I
FURTHER AGREE THAT THE SAID REAL ESTATE MAY BE SOLD ON A FIERI FACIAS. I HEREBY WAIVE AND RELEASE ALL
RELIEF FROM ANY OR ALL APPRAISEMENT, STAY OR EXEMPTION LAWS OF ANY STATE, NOW IN FORCE OR HEREAFTER TO
BE PASSED.
