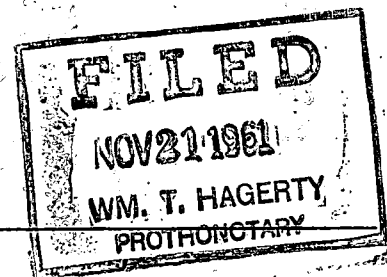

# REPAYMENT AGREEMENT

XX We, John W. Burnosky and Julia Burnosky

DO HEREBY AGREE TO PAY TO THE DEPARTMENT OF PUBLIC WELFARE OF THE COMMONWEALTH OF PENNSYLVANIA, ITS SUCCESSORS OR ASSIGNS, OR ITS DULY AUTHORIZED AGENT, THE SUM OF one hundred, thirty-two and 20/100 (\$ 132.20 ) FOR ASSISTANCE RECEIVED

or to be received by or for us, by or for those persons for whom we are responsible under the Pennsylvania Support Law.

The judgment to be obtained by the recording of this instrument shall be a lien upon our real property and be collected as other judgments, except that the real and personal property comprising our home and furnishings shall not be subject to execution on such judgment so long as it continues to be occupied as our home or that of our spouse or dependent children.

Further, our property shall not be liable for any greater amount than the total assistance received, plus costs.

I DO HEREBY AUTHORIZE THE PROTHONOTARY OF, OR ANY ATTORNEY, OF ANY COURT OF RECORD OF PENNSYLVANIA OR ELSEWHERE, TO APPEAR FOR AND TO ENTER JUDGMENT AGAINST ME FOR THE SAID SUM, WITH OR WITHOUT DECLARATION, WITH COSTS OF SUIT, RELEASE OF ERRORS, WITHOUT STAY OF EXECUTION. I ALSO WAIVE THE RIGHT OF INQUISITION ON ANY REAL ESTATE THAT MAY BE LEVIED UPON TO COLLECT THIS SUM, AND HEREBY VOLUNTARILY CONDEMN THE SAME, AND AUTHORIZE THE PROTHONOTARY TO ENTER UPON THE FIERI FACIAS MY SAID VOLUNTARY CONDEMNATION AND I FURTHER AGREE THAT THE SAID REAL ESTATE MAY BE SOLD ON A FIERI FACIAS. I HEREBY WAIVE AND RELEASE ALL RELIEF FROM ANY OR ALL APPRAISEMENT, STAY OR EXEMPTION LAWS OF ANY STATE, NOW IN FORCE OR HEREAFTER TO BE PASSED.
