





PETITION FOR APPOINTMENT OF VIEWERS

TO: THE HONORABLE JOHN J. PENTZ, PRESIDENT JUDGE:

The petition of Damus Brothers Company, Inc., a business corporation organized under the laws of the Commonwealth of Pennsylvania with its principal place of business in DuBois, Clearfield County, Pennsylvania, respectfully represents:

1. That Damus Brothers Company, Inc., is the owner of premises situate at 229 N. Brady Street, DuBois, Pennsylvania, and were the owners on December 29, 1961 of the aforesaid premises, more particularly described as follows:

BEGINNING at a point on the West curb line of North Brady Street, prolonged from the East side of the Iron Bridge over Sandy Lick Creek, at the Northeast corner of the Pennsylvania Railroad Freight Depot Grounds; thence by the same North 51° 41' West, 150 feet to a stake; thence by the same North 53° 16' West, 100 feet to lands of J. E. DuBois; thence by lands of J. E. DuBois North 36° 44' East 51.5 feet to a post; thence still by lands of J. E. DuBois South 64° 26' East 88.2 feet to a post at corner of land of Susie Mike; thence by land of Susie Mike South 25° 34' West, 29.9 feet to a post; thence South 51° 41' East 150 feet to a post on said West curb line of North Brady Street as above described (58.9 feet from the draft corner of stone abutment of bridge over Sandy Lick Creek); thence along the same, South 27° 9' West 40 feet to place of beginning.

That your petitioner acquired title to said property on July 13, 1940 by deed from Edward F. Andrews, et al., said deed being recorded in the Recorder of Deeds office for Clearfield County in Deed Book 333, Page 52.

2. That the defendant, City of DuBois, is a municipal corporation, being a Third Class city under the laws of the Commonwealth of Pennsylvania, located in Clearfield County, Pennsylvania.

3. That by virtue of the Act of June 23, 1931, P.L. 932, Art. XXVIII, Sec. 2801; June 28, 1951, P.L. 662, Sec. 28, 53 P.S. 37801, the City of DuBois is vested with the power to acquire by eminent domain any real property, including improvements and fixtures for the purpose of laying out and widening streets.

4. By ordinance finally enacted on December 29, 1961, the defendant did take, appropriate and condemn a portion of the above described premises of the petitioner, for the purpose of widening North Brady Street in the City of DuBois.

5. That constructed upon said premises of petitioner, is a large brick, three-story, commercial building, used by your petitioner as a soft drink bottling plant and beverage distribution plant, part of which exists upon the premises taken, appropriated and condemned by the defendant.

6. That the defendant has refused to discuss compensation to be made for the property taken, condemned and appropriated, although requested to do so by your petitioner, and that therefore your petitioner and the defendant have been unable to agree on said compensation.

7. That there are no liens or encumbrances against said premises.


